# Continued increases seen in global air traffic volumes

- The average number of flights daily for the weeks of 4 May and 11 May, 2020 were 37,700 and 39,200 respectively.
  This represents a decline of 62% from the comparable global daily average in April 2019 when over 104,000 flights operated daily.
- The impact on global flight hours was similar, with average daily flight hours for the weeks of 4 May and 11 May, 2020 of 84,500 and 88,700 respectively. That is 60% less than average global daily flight hours the year prior when almost 220,000 flight hours were operated daily.

# Signs that some aircraft are coming back into service

While global traffic levels remain extremely low, we are now in the fourth straight week of increases in average daily flights and flight hours, spurring some cautious optimism. Signs of increasing domestic travel in specific regions are spurring the increase in overall numbers, as international travel remains highly restricted.

Global surveillance data shows that for the week of 11 May an average of 25,700 unique aircraft were operating daily. That number represents a 28% increase on the number of aircraft flying daily four weeks earlier. However it remains approximately 11,300 fewer unique aircraft than were flying on an average day in May 2019, for a year over year reduction of 30%.

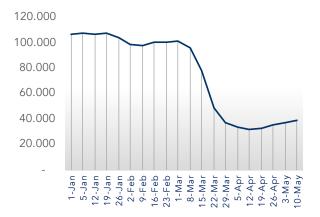
Average daily flights during the week of 11 May were up 24% and average daily flight hours showed an improvement of 21% over four weeks earlier when traffic levels appeared to hit their lowest point.

### Average unique aircraft

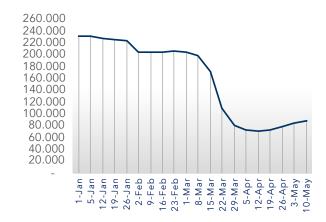

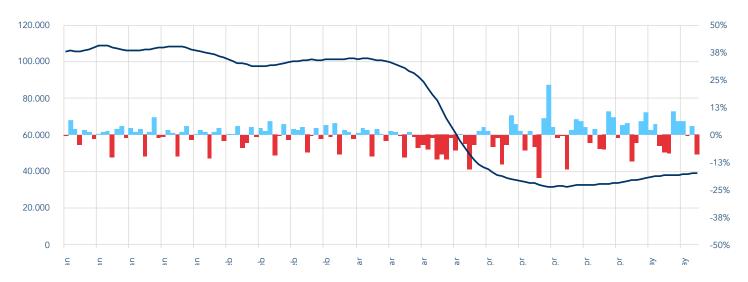


### Average global flight hours

As we enter into the eighth week of severely reduced global traffic levels, the impact on the aviation industry in the form of lost traffic is staggering. Over a half a million flights never occurred, impacting all players in a heavily interconnected industry. Irrespective of the pace of recovery that might follow, that loss will have repercussions.

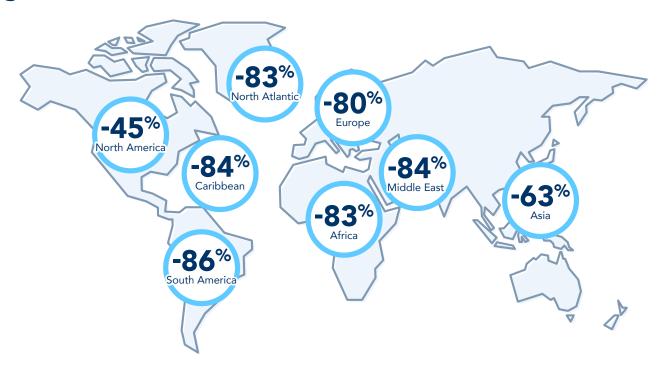
# **Daily flight hours**

# Flight hours since April 2019 with percentage of day-to-day variability



For the ATM industry, global flight hours remains an important metric of activity and workload. Daily flight hours, which normally show some seasonal variation between 210,000 and 250,000 flight hours daily, were 96,900 on 15 May 2020. This represents the highest daily total since they experienced their lowest point of 59,800 global flight hours on 12 April, 2020.

# Regional traffic brief



Most regions experienced improvements in the average number of flights per day over the previous two week period. The number of daily flights in South America, Africa and the North Atlantic remain largely unchanged.

Traffic volumes in Asia saw the largest increase with an additional 2,100 flights per day on average above what the region experienced the week of 19 April, 2020. Europe saw an additional 900 flights per day on average added to their airspace, but remained 80% lower than daily averages in January.
