



Aviation industry leaders to explore the future of the industry in Asia Pacific at seminal hybrid event

Schiphol, The Netherlands, 13 May 2021 - Air traffic management industry organisation, CANSO, is to welcome aviation industry leaders to the first hybrid CANSO Asia Pacific Conference 2021, hosted by NiuSky Pacific Limited (formerly known as PNG Air Services) in Port Moresby, Papua New Guinea, and online, on 19 and 20 May 2021.

The CANSO Asia Pacific Conference 2021 will gather air traffic management's (ATM) key decision-makers and influencers in the region alongside industry stakeholders to discuss the crucial challenges facing aviation as it recovers and rebuilds from the COVID-19 pandemic. The regional event is open to all in the industry, including representatives from ANSPs, suppliers, airlines, airports and other industry stakeholders.
