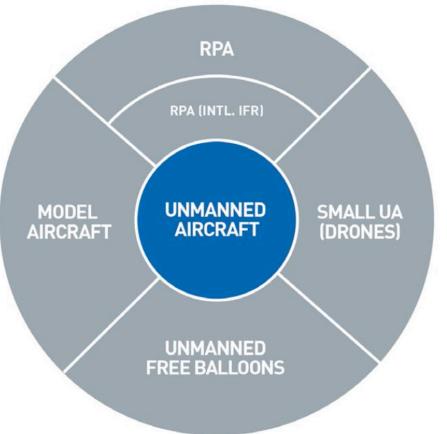

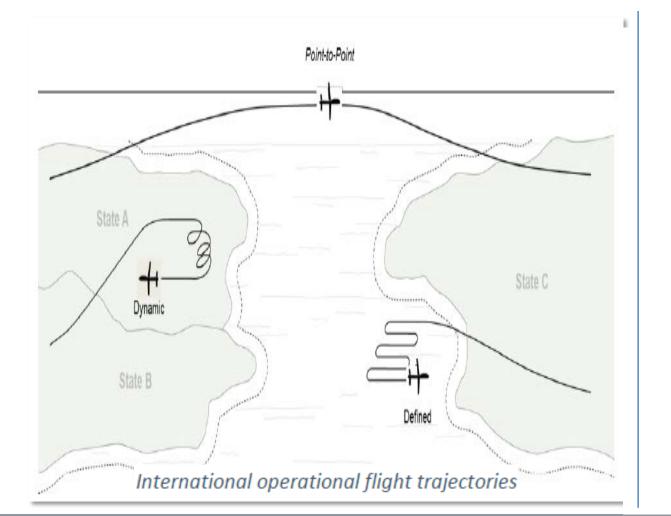


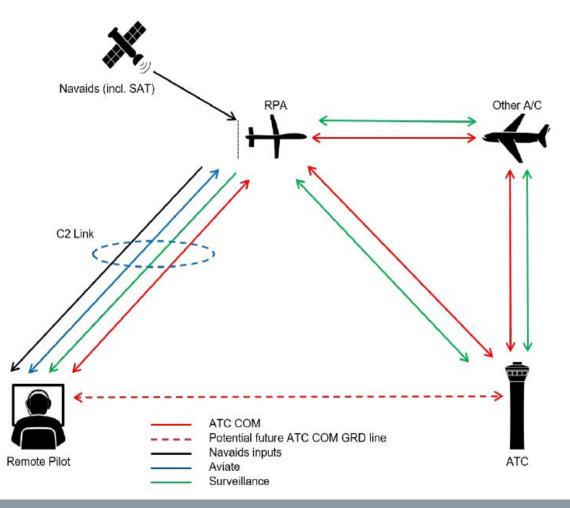
## Key terms

- UA operate as part of an UAS which also includes a RPS, a C2 Link for control and management, and other components.
  - UA includes a broad spectrum of aircraft, from drones, unmanned free balloons and model aircraft, to highly complex, piloted aircraft (RPA) operated by licensed aviation professionals
- RPA are a subset of UA, A further subset of RPA is expected to be accommodated and ultimately integrated into the airspace for international, IFR operations which will require full regulatory certification.









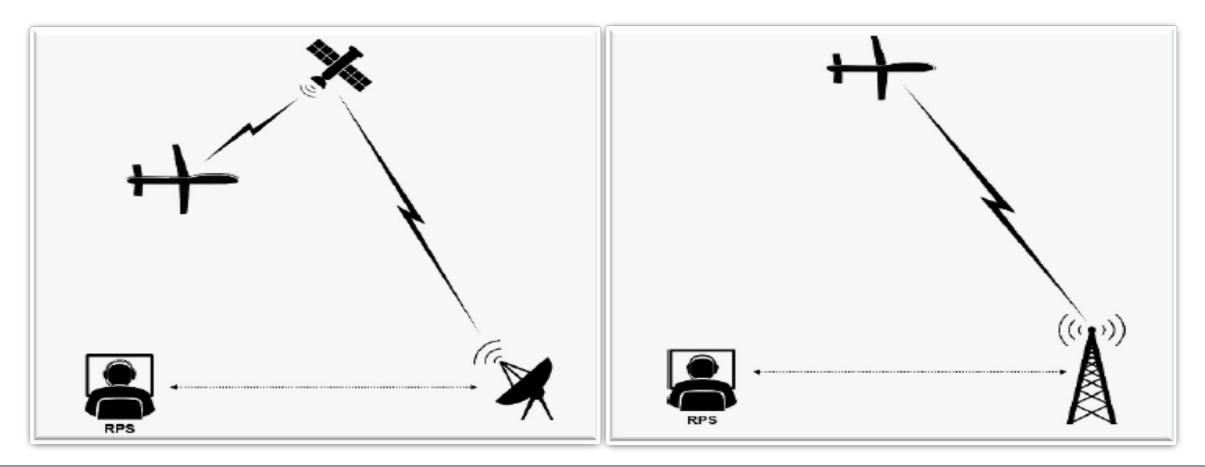

# Rules of the air (Annex 2)

#### **General operating rules**

An RPAS engaged in international air navigation **shall not be operated without appropriate authorization** from the State from which the take-off of the RPA is made.

- An RPA shall not be operated across the territory of another State without special authorization issued by each State in which the flight is to operate.
- An RPAS shall be operated in accordance with conditions specified by the State of Registry, the State of the Operator, if different, and the State(s) in which the flight is to operate.
- RPAS shall meet the performance and equipment carriage requirements for the specific airspace in which the flight is to operate.

### **ICAO GANP/5**

#### **B1-RPAS**

- Initial integration of remotely piloted aircraft (RPA) into non-segregated airspace
- Implementation of basic procedures for operating RPA in non-segregated airspace.

#### **B2-RPAS**

- Remotely piloted aircraft (RPA) integration in traffic
- Implements refined operational procedures that cover lost command and control (C2) link (including a unique squawk code for lost C2 link), as well as enhanced detect and avoid technology.

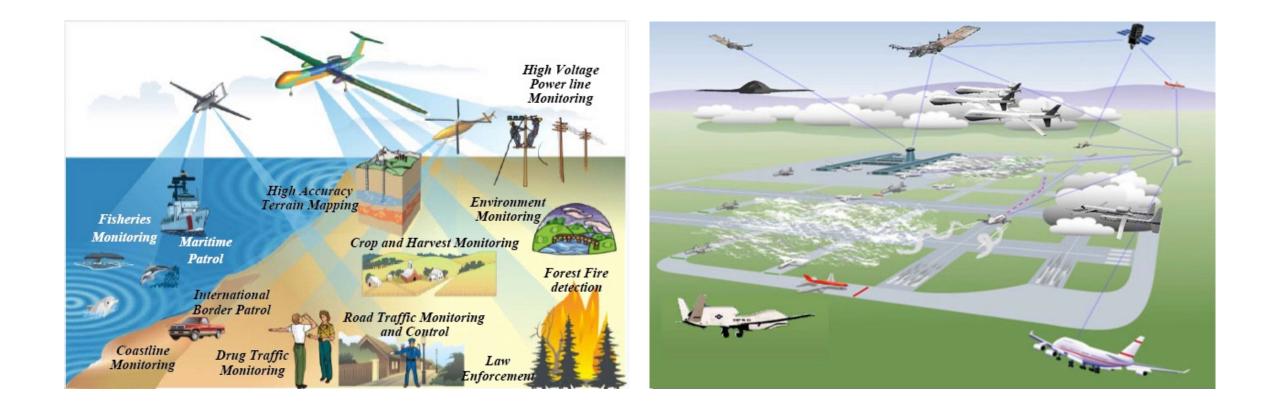
**B3-RPAS** 

- Remotely piloted aircraft (RPA) transparent management
- Continuing to improve the certification process for remotely piloted aircraft (RPA) to operate on the aerodrome surface and in non-segregated airspace just like any other aircraft.

# BACKGROUND



 UAS/ET Working Group identified a need for general UAS training for ANSPs

CANSC

- First version completed in early 2017, updated in early 2020
- RPAS operators, both civil and State, are seeking greater access to airspace and increasingly interact with air traffic management (ATM) systems.
- Accepting RPAS into the ATM system poses many challenges and, from an ANSP point of view, integration of RPAS in non-segregated airspace is of special interest.



# **OBJECTIVE AND SCOPE**

### **Objectives**

- Provide high level introduction to remotely piloted aircraft systems (RPAS).
- Provide training guidance that can be individually tailored by air navigation service providers (ANSPs).
- All material is intended to recommend topics for discussion. ANSPs are encouraged to adapt the material to develop training programmes that meet national/regional needs

#### Scope

- Focus of training RPAS operating instrument flight rules (IFR) in controlled airspace.
- Target audience ANSP management, ANSP training staff and air traffic service staff.

### EXAMPLE OF TRAINING PACKET/INSTRUCTOR GUIDE

#### **RPAS Configuration**

- · An RPAS is comprised of a set of configurable elements including an
  - RPA
  - Associated RPS(s),
  - C2 links
  - Any other system elements as may be required, at any point during flight operation.
- The pilot controls the RPA from an RPS, linked by radio which can either be in
  - Direct radio (frequency) line of sight (RLOS/FLOS), or
  - Beyond (frequency) line of sight (BLOS) using satellite or other relays.
- These links are used both for the C2 of the RPA and for communications with air traffic control (ATC) and are potentially vulnerable to disruption

## Definition

### What is a Remotely-Piloted Aircraft System?

"A set of configurable elements consisting of a remotelypiloted aircraft, its associated remote pilot station(s), the required command and control links and any other system elements as may be required, at any point during flight operation."

## History of Unmanned Aircraft System

The first pilotless vehicles were developed in Britain and the USA during the first world war. Britain's Aerial Target, a small radiocontrolled aircraft, was first tested in March 1917 while the American aerial torpedo known as the Kettering Bug first flew in October 1918.



First pilotless British made aircraft that first flew in 1917.

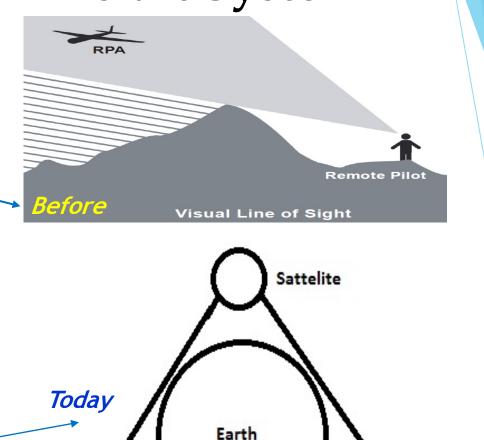


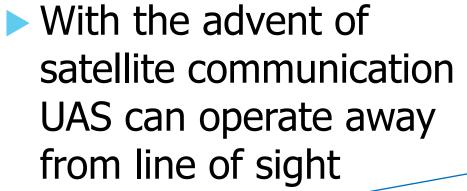

### The Dilemma

- 1. Despite the many near collisions and actual collisions with civil aircraft incidents reported, less than half of the ICAO contracting states have passed the regulations or legislation to manage the operations of UAS within their states.
- 2. Due to their size, the UAS equipment are not easy to detect using the conventional ATC surveillance systems.
- 3. Majority of UAS equipment in individual ownership are not registered.
- 4. The enforcement authorities such as the police don't understand the regulations on the registration, operation and certification of UAS equipment.

# **Categorization of UAS**

Unmanned aircraft systems are categorized according to the risk they pose to the civil aviation, Public and property

### CATEGORY A- (Low risk).

This category of operations poses low or minimal risk to the public, property and manned aviation.

E g- UAS Systems used for filming and photography ICAO Circular 328 of year 2011-AN/190







## **Categorization of UAS**

### Unmanned aircraft systems are categorized according to the risk they pose to the civil aviation industry

**CATEGORY B** (Medium Risk/Regulated Lower Risk).

Operations under this category pose medium risk to the public, property and manned aviation.

E g- UAS used in agricultural activities such as crop spraying ICAO Circular 328 of year 2011-AN/190

### **Categorization of UAS**

## Unmanned aircraft systems are categorized according to the risk they pose to the civil aviation industry CATEGORY C (High Risk)

This Category of operations poses high risk to safety of individuals, property and manned aviation.

E g- UAS such as the ones used for reconnaissance/spying and aerial military attacks.

#### Many industries are choosing to use UAS because of:

- i) Low operating costs
- ii) Ease of Operation/Requires minimum preparation
- iii) Uses cheaper energy e g solar energy and electricity chargeable batteries.
- iv) Low initial cost of purchase
- Convenience of operation- can be operated at any time of the day unless regulations/laws require otherwise.





- Straying of UAS into controlled aircraft flight paths creating a risk of loss of separation and a possibility of collision.
- ii) Deliberate violation of restricted, prohibited and danger areas.
- iii) Loss of communication/link with the command centre posing the risk of collision with aircraft, buildings and installations.
- iv) Inability by the Civil Aviation Authorities/Governments to regulate the UAS operations.

v) Lack of awareness by the citizenship on the existence of regulations to govern ownership, certification, classification and operations of UAS Unregistered UAS operated by unknown persons vi) Violation of people's/organization's privacy vii) Acts of sabotage by criminal & terrorist groups viii) Management of Airworthiness UAS ix) x) Certification and Classification of UAS Piloting/Operating a UAS without the correct license xi) and approvals

- xii) Environmental protection- The operations of UAS including discharges from the UAS and disposal upon decommissioning may pose a risk to the environment.
- xiii) Communication with ATC units via voice or other technologies such as CPDLC is not developed yet.
- xiv) Failure by the Civil Aviation Authorities/Governments to prescribe the minimum equipment list (MEL) to be carried in a UAS.
  xv) Inability by ATM units to detect the operation/presence of UAS in a given area/place.





xvi) Loss of control of UAS that can lead to accidents/incidents during strong winds, storm or cyclones.

#### ROLE OF TRAINING IN INTEGRATING RPAS INTO EXISTING ATM SYSTEMS

- Take lead in training ATM personnel in airspace design to create specific routes/flight paths for RPAS.
- ii) Design programs to train ATM personnel on interpretation of applicable ICAO standards and recommended practices regarding RPAS operations.
- iii) Design programs to train ATM personnel on existing regulations within the state regarding RPAS operations.

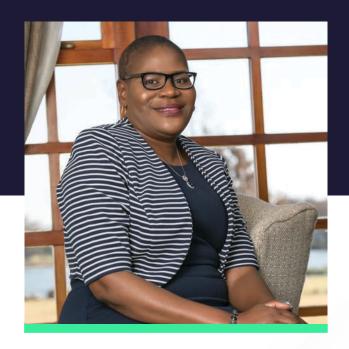

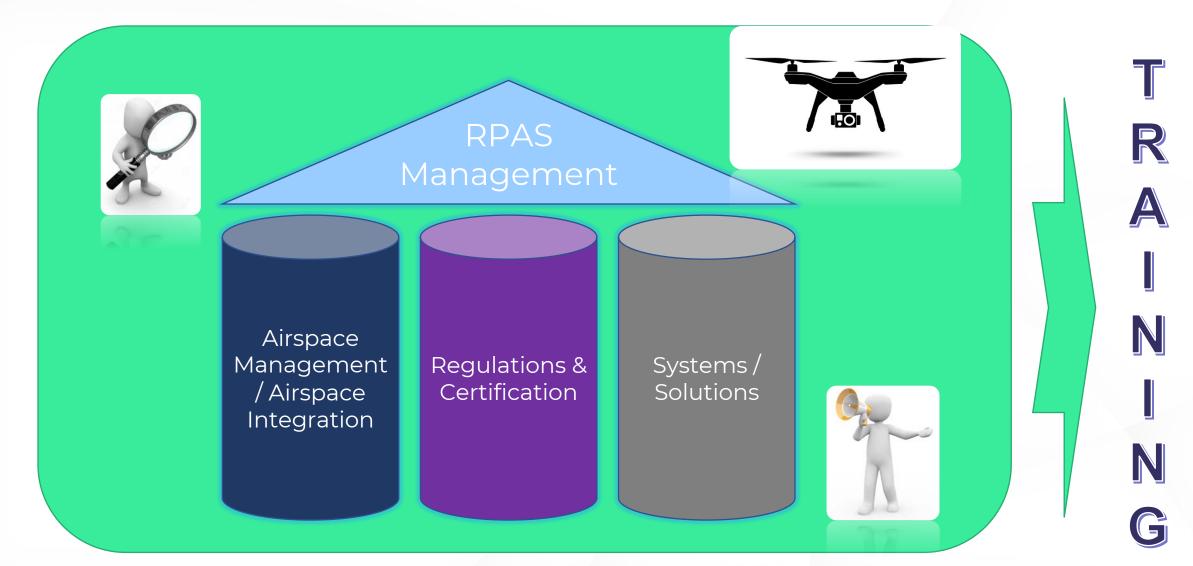
### **UAV SKILLS DEVELOPMENT**

- This has resulted in ATNS ATA pursing the RPAS training product line as part of our product diversification (strategic objective).



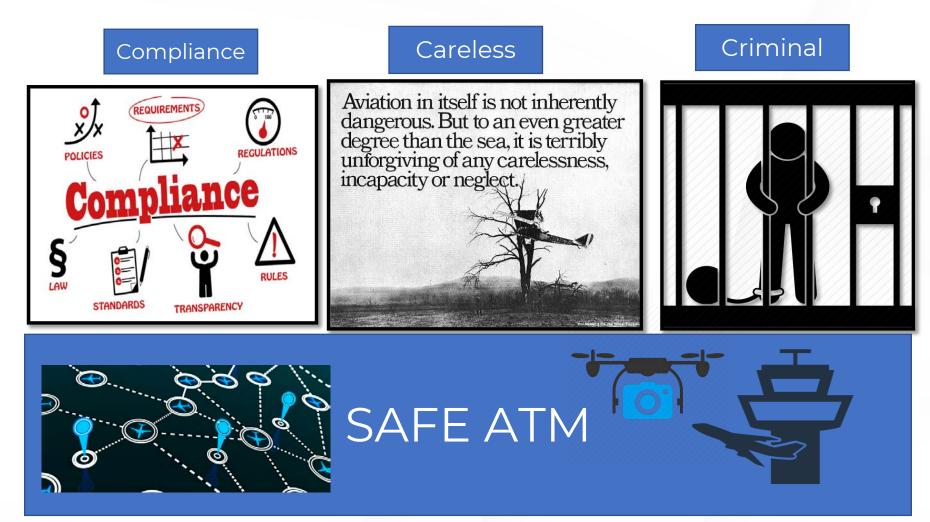

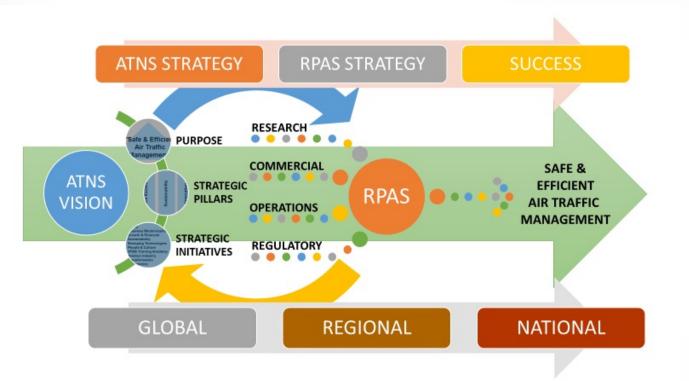

#### **ASPECTS TO CONSIDER**

- Drones **are here with us and will remain** for the foreseeable future.
- **Rapid changes in drone technology** hold enormous promise for the future use of airspace and aviation at large as the digital transformation expands skyward.
- This requires a **step-change** in the way **airspac**e is managed.
- Essentially, there will be a move from several thousand conventional aircraft in the sky every day to potentially hundreds of thousands of **highly connected and automated aerial vehicles**, offering advanced data-driven services and operating everywhere, including in cities.
- **Illegal use of drones** presents a safety concern and a security risk.
- Operating outside of Civil Aviation Authority guidelines or the allocated radio frequencies increases the potential for accidents, including collisions in the airspace, posing a risk to the community.
- Drones' **ability to carry objects** may also lead to potential risks for national security.
- One of the most significant safety risks, as well as risk to the continued growth of the industry, is that posed by recreational/hobby UAS operators.
- This is a **community-wide issue** and not just an issue for the aviation industry. This risk is best addressed through community **education and awareness.**



## CONCLUSION

- Understanding RPAS requirements supported by comprehensive Training/Education is required in all spheres of the Aviation as well as non-aviation industry.
- Specific systems/solutions will be required to be developed for RPAS collision avoidance, surface management and integration with IFR traffic, supported by robust regulations.
- RPAS Management requires Industry involvement of all stakeholders in a Collaborative Decision Making (CDM) Environment.
- A Robust regulatory framework is required to support RPAS operations to ensure safe and efficient operations for all airspace users.
- Irrespective of what you deploy, training will always be required and ATOs remain an integral part of these conversations.
