





Fatigue is defined by ICAO as a physiological state of reduced mental or physical performance capability resulting from sleep loss or extended wakefulness, circadian phase, or workload that can impair an Air Traffic Controller's alertness and ability to adequately perform safety related operational duties.



Fatigue (2)



Key factors fatigue:

• Time of day

effect of circadian rhythms

Period awake and amount of sleep

quantity and quality of pre-duty sleep

• Shift length and intensity


time on position, workload, alternation in tasks and breaks



Fatigue (3)



Key factor 1: Time of day - effect of circadian rhythms



All human beings have a circadian master clock located in a small cluster of cells in the hypothalamus


The circadian body clock programs humans for daytime wakefulness and night-time sleepiness

Light, entering via the retina of the eye, helps the circadian body clock to stay in step with the day/night cycle





Key factor 1: Time of day - effect of circadian rhythms



The circadian body clock controls a daily rhythm that lasts approximately 24 hours


Shift work (circadian disruption) is a mismatch with the human natural rhythms of sleeping, eating and (social) activity



Fatigue (5)



Key factor 1: Time of day - effect on performance



The circadian body clock produces daily highs and lows in performance (the window of circadian low is between 02:00 and 06:00 hours)




Fatigue (6)



Key factor 2: Period awake and amount of sleep

- For sleep to be fully restorative, it must contain unbroken cycles of all the sleep stages
- The circadian body clock affects the timing and quality of sleep
- Reducing the amount or quality of sleep decreases the ability to function and increases sleepiness the next day
- Sleep quality declines as a normal part of aging

Key factor 3: Shift length and intensity - time on position, workload, alternation in tasks and breaks

- The ICAO definition of fatigue describes workload as "mental and/or physical activity" (slide 6) and recognizes that both high and low workload may potentially cause fatigue
- Breaks during a duty period are an important way of reducing the decline in performance with increasing time on task due to the effects of high workload
- Alternation in tasks may be an appropriate countermeasure in case of low workload
- Single Persons Operation may involve risks

Fatigue

- is inevitable in a 24/7 industry
- cannot be eliminated





Fatigue risk management deals with assessing and addressing the safety implications of fatigue.

It is a shared responsibility of:

- State
- Service provider





ICAO distinguishes between different approaches:


- Prescriptive approach
 - Service providers manage fatigue risks using SMS processes within prescribed limits
- Performance based approach (FRMS approach)
 - Service providers meet additional requirements to have flexibility outside of prescriptive limitation regulations *



* A Fatigue Risk Management System (FRMS) is defined by ICAO as a data-driven means of continuously monitoring and managing fatigue-related safety risks, based upon scientific principles and knowledge as well as operational experience that aims to ensure relevant personnel are performing at adequate levels of alertness.

FRMS

Service providers meet additional requirements to have flexibility outside of prescriptive limitation regulations

SMS

Service providers manage fatigue risks using SMS processes within prescribed limits



Develop prescriptive limitations and regulations for



variations

1. States shall establish prescriptive limitation regulations that take into account acute and cumulative fatigue, circadian factors and the type of work being undertaken. These regulations shall identify:

- a) the maximum:
 - *i)* number of hours in any duty period;
 - *ii)* number of consecutive work days;
 - *iii)* number of hours worked in a defined period; and
 - *iv) time-in-position;*
- b) the minimum:
 - *i)* duration of non-duty periods;
 - ii) number of non-duty days required in a defined period; and
 - *iii)* duration of breaks between periods of time-in-position in a duty period.







Monitoring, Identifying and Assessing fatigue risks

ICAO SARPs identify different types of data and information to monitor in order to identify fatigue hazards in daily operations and/or schedules and to assess their risk(s):



- Fatigue assessment (questionnaire, log study during duties, interviews)
- Sleep assessment (sleep diary, actigraphy)
- Roster analysis (biomathematical tooling)
- Workload assessment (survey, site visits, performance data)







Objective:

To get a good understanding of the development of alertness, fatigue and workload during different types of shifts

To identify fatigue risks during the course of various types of shifts

Means:

A booklet with very short questionnaires to be filled in every hour during operational duties (paper-and-pencil log)

- Logs must be completed during active duty
- Paper-and-pencil logs are proven to bring minimal disruption to operational duties





Objective:

To get a good understanding of sleep/wake patterns as well as quality and quantity of sleep post and prior to different duties

To assess if there are any 'sleep risks' (that is low levels of sleep duration and/or low levels of sleep quality) post or prior to specific duties or within specific schedules

Means:

Actigraphy in combination with sleep diaries for a set period of time

<u>Actigraphy:</u> a non-invasive method of monitoring human rest/activity cycles

• Actigraphy can be considered the most appropriate measure available to objectively record general sleep patterns in a non-laboratory setting

Sleep diaries: short online questionnaires upon awakening and at bedtime

• Sleep diary data are typically used to enhance the reliability of the actigraphy data







It is an internationally accepted instrument for measuring current, work-related, fatigue and is often used in aviation

FAID calculates a Fatigue Risk Score, this score is based on four factors:

(1) Time of day of work, (2) duration of work, (3) work history in the

- FAID is an example of a bio-mathematical model :
- Fatigue hazards can be identified by using a bio-mathematical model

Objective:

To examine general roster characteristics, assess robustness of the rosters and identify potential fatigue hazards (planned and actual roster)

Highlighted: Roster Analysis









Where a **fatigue risk** is identified while complying with prescribed limits, a safety action plan identifying appropriate mitigations and controls according to its current safety management practices has to be put in place

The **risk mitigations** need to be regularly reviewed and assessed to ensure their desired outcome continues





States must:

- Assess a service provider's compliance with prescribed limits and associated requirements
- Monitor compliance with approved processes for extending work periods in sudden unforeseen operational circumstances, to ensure that such extensions are used only as appropriate
- Check that SMS processes applied to fatigue-related risks are sufficiently robust to manage the fatigue risk in any situation

Training



Service Providers have to incorporate basic fatigue management topics in their awareness and training programmes

ICAO provides recommended fatigue training topics for

- Individual operational personnel
- Personnel involved in schedule (roster) design and management
- Executive decision-makers and operational risk managers



Examples of topics:

- The basics of fatigue including sleep fundamentals and the effects of disturbing the circadian rhythms.
- The causes of fatigue, including medical conditions that may lead to fatigue.
- How to identify fatigue in oneself and in others.
- How scheduling affects sleep opportunities and can disrupt the circadian biological clock cycle, the fatigue risk that this creates, and how it can be mitigated through scheduling.
- Use and limitations of any scheduling tools and bio-mathematical models or other algorithms that may be used to predict an individual's fatigue across a schedule/roster
- The responsibilities and accountabilities of different stakeholders in fatigue management

Research

Data collection methods include: fatigue assessment (survey, log study), sleep assessment (sleep diary study, actigraphy), roster analysis (biomathematical models), as well as workload assessment (survey, site visits).





Recommendations
