





## UAS / ET WORKING GROUP


- Born as the Collaborative




- With the growth of UAS and other technologies demanding access to airspace, we added emerging technologies to our portfolio.



# Regulatory and Pre-operational Considerations – Commercial Space Transportation

### **FAA Office of Commercial Space Transportation (AST)**

Authorizes the FAA to license commercial launch and reentry activities and the operation of launch and reentry sites as carried out by a citizen of the United States

- **AST Mission:** Oversee and enable the safest commercial space transportation system in the world.
- **AST Vision:** We are committed to propelling commercial space transportation safely into the future.

Over **500** licensed and permitted commercial launches and reentries since 1989 without any public casualties or major property damage

### Who Needs a License or Permit?

### A U.S. citizen or an entity organized under the laws of the United States or any State must obtain a license:

- To <u>launch or reenter</u> a vehicle <u>inside</u> or <u>outside</u> the United States;
- To *operate* a launch or reentry site *inside* or *outside* of the United States;

A Foreign entity that wishes to operate a vehicle or site within United States territory.

#### An entity may obtain an experimental permit:


 To <u>launch</u> a reusable suborbital vehicle from the United States for research and development, or prior to obtaining a launch license, to show compliance with requirements for a license or crew training.

### FAA does <u>not</u> license launches or reentries "the Government carries out for the Government":

NASA and the Department of Defense typically carry out their own launches.

SUMMARY: If the company is U.S incorporated or operated in U.S. territory, it needs authorization.

### **AST Process– Site/Vehicle Operator License**



### **Aircraft Hazard Areas**

- Aircraft hazard areas (AHAs) define the location, extent, and duration of a hazard to other users of the airspace from falling debris generated by a launch or reentry vehicle
- Prior to a mission, the FAA (or a Range) uses physics-based computational tools to model planned hardware jettisons and potential failures of a launch or reentry vehicle at specific points along its trajectory, accounting for uncertainties in vehicle performance, environmental conditions, and other factors
- The tools propagate falling debris to the surface to:
  - Predict the region in which the risk to an aircraft, if present, would exceed acceptable thresholds in part 450
  - Predict the duration of time in which the hazard would exist
- The FAA uses air traffic management tools and techniques to identify these regions for other airspace users and prevent other airspace users from entering them during periods in which the hazard might occur – one such tool is a <u>Temporary Flight</u> Restriction

### **Airspace Requirements**

- Applicant develops an LOA (Letter of Agreement) with FAA Air Traffic Control (ATC) facility where the operation will take place
- Letter of Agreement
  - Establishes procedures for the issuance of a Notice to Air Missions (NOTAM)
  - Defines communication between operator and ATC (before, during and after operation)
  - Outlines response to contingencies

#### NOTAM

- Defines the lateral and vertical (altitude) confines of the airspace with the associated dates/time for a launch/reentry operation
- Must be issued in advance of operations to notify other users of the National Airspace System of the airspace closure






### CONTEXT OF SPACE LAUNCHES IN THE UK

### A New and Growing Sector – but not a "clean sheet" environment

- NATS is in discussion with over a dozen organisations aiming to start providing launch site facilities, or launching rockets, in the UK in the period 2022 2025
- UK is a densely populated country, so launch sites are around the coastline, with space launches aimed out to sea
- UK has many close neighbours, so almost any launch will end up crossing an FIR boundary, or more than one
- Recovery areas will thus usually be in a different FIR from the launch area.
   Some rockets may even cross a boundary before leaving the atmosphere
- Each new FIR/State involved potentially requires additional coordination at Government, Regulator and ANSP level








### AIRSPACE IS A SHARED RESOURCE

### Space Launches have to operate alongside existing Airspace Users

- Major Civil Airports
- Military Danger Areas both routine training and major exercises
- En Route airline traffic (and in a Free Route environment there are fewer lines on maps to show where they may be)
- Specialist operations (e.g. police, medivac, search & rescue, oil platform support)
- Sport & Recreation GA (including unpowered and/or non-radio equipped)
- Time of day / day of the week may make a big difference to the level of interaction.
- For air/sea launches, moving just a few miles may radically change the level of interaction





### FOR MANY OF US, THIS IS NEW

### We don't all have decades of experience

- ANSP staff may not be used to space launches happening locally, nor the fact that they need backup launch days in case of weather or technical issues
- Some Regulators are still setting up their teams and processes but that doesn't mean these can be short-circuited
- Many Launch Sites are new (or haven't yet been completed)
- Many Space Launch companies aren't yet used to dealing with Airspace issues, or are moving into new regions where the rules and procedures are slightly different
- ATM Systems adaptation and Safety work takes time, over and above the rocket/launch approval work – there are very few (if any) shortcuts



## COORDINATE EARLY, COORDINATE CONTINUALLY


### Until this becomes routine we all need to make extra effort

- ANSPs need to make sure contact points are known to those who need them both planning and day-of-operation (noting these may be different teams/individuals). Ensure contact lists are complete and up to date
- The Danger Area design, time and length of activation etc may all need multiple adjustments from the initial proposal as new facts are uncovered. This may need iterative discussions with multiple organisations
- Small changes can have big impacts (e.g. oceanic FIRs may have larger separation requirements than domestic FIRs)
- There may be interaction with other activities (not necessarily even space/airspace) which add constraints
- We collectively need to remain alert until every part of the launch vehicle returned to earth (or has been confirmed to be in orbit)



ATO Space Ops and CANSO ATFM Data Exchange Network (CADENA) have been coordinating via email. New procedures will allow for:

- Reduces workload
- Faster processing

- No longer completing operational coordination via email
- Eliminates manual processing


### Operation Planning Timeline





### LEGACY PROCESS






#### 3 TEST SCENARIOS

- Scenarios tested:
  - Approval
  - Denial
  - Amendment

- Initial request contain primary and five backup dates
- Begin requesting additional backup days no less than 72 hours prior to the last coordinated day
- Request NO DRAFT NOTAM as part of initial request
- Fiji encourages communication via AMHS rather than email

# PREVIOUS PROCESS & DOCUMENTED PROCEDURE

- No coordination (back and forth coordination)
- Notification message received on AFTN from USNOF containing the following:
  - Coordinates of the boundary/location of where the re-entry will take place
  - Estimate times at which the re-entry will occur
- Extract information and plot affected area. Obtain information of affected ATS routes or part thereof
- Coordinate and obtain approval from our CAA for establishment of a temporary restricted Area at the boundary of re-entry
- Issue NOTAM to advise airlines
- On the day, ATC monitors the area and alert aircraft of any potential danger





# IMPROVED COORDINATION PROCESS

- The improvement of the coordination process was initiated by FAA through their Air Traffic Representative in the Asia/ Pacific, Michael Watkins in February 2022
- We, Fiji Airports and our CAA attended the first zoom meeting which was facilitated by Mr. Watkins and also attended by other FAA colleagues on the same month
- Hannah Brown, from ATO Space Operations explained and proposed the best possible coordination process that was intended to implemented
- Fiji Airports requested a test/trial run of the proposed improved coordination process since the process was a significant change to our then documented procedures



# **TEST OF PROPOSED PROCESS**

- The Tabletop Exercise procedures was prepared by ATO Space Operations which included the participation of USNOF, ATO Space Ops, Nadi International NOTAM office (NFOF) and AJV-1
- The test was conducted on the 7th April 2022 and was called off due time difference issue. Test recommenced and was completed on the 8th of April
- The purpose of the Tabletop Exercise was to validate the National Airspace Data Interchange Network (NADIN) system as means to coordinate NOTAMs for international launch and reentry operations, for both the USNOF and NFOF.
- Findings from the exercise were used to develop and refine international NOTAM coordination procedures and also your local procedures





# **CONTENTS OF TEST**

#### Fiji Test Tabletop Exercise

#### Assessment of Need

FAA ATO Space Operations is proposing utilization of the NADIN system to complete the coordination of international NOTAMs in support of launch and reentry operations. The codification of procedures regarding these activities will require the validation of the NADIN system through the FIJITEST exercise. Key stakeholders including the US NOTAM Office (USNOF), Fiji (NFOF), and ATO Space Ops will have the opportunity to simulate coordination for an operation, which will enhance familiarization of procedures for all parties and provide the opportunity for feedback on any shortfalls not previously assessed.

#### Scope

- · USNOF will test coordinating requests with NFOF for FIJITEST Exercise
- · Location: Virtually, and via NADIN
- · Participants: USNOF, ATO Space Ops, NFOF, AJV-I

#### **Purpose Statement**

The purpose of the FIJITEST Tabletop Exercise is to validate the NADIN system as a means to coordinate NOTAMs for international launch and reentry operations, for both the USNOF and NFOF. Findings from this exercise will be used to develop and refine international NOTAM coordination procedures.

#### Objectives

- Validate NADIN as an official means of coordinating international NOTAMs for commercial space launch and reentry activities.
- · Identify shortfalls with the proposed system and procedures.
- · Discuss proposed solutions to develop the most streamlined system for all stakeholders.

#### **Anticipated Outcomes**

- USNOF will become familiar with NOTAM format for space launch and reentry operations
- USNOF will develop best practices for coordination with Fiji and ATO Space Ops
- · Fiji will develop best practices for coordination with USNOF

# **RESULTS OF THE TEST**

- Fiji was able to understand the coordination process
- Able refine and document a new coordination process which in turn established a more convenient intra State coordination with our CAA and other stakeholders
- The NFOF was established as a main point of contact during such activity
- From the test we learnt that we were able to deny a request for re-entry and we have established a procedure that denial of such request shall only arise if area calculated or proposed for re-entry is:
  - •On land or too close to land; or
  - •In a dense air traffic area
- Established a cordial coordination process with FAA
- USNOF became more familiar with our NOTAM format and advance notification requirements



# **EXPECTATIONS FOR SPACE LAUNCH**

- Establish an effective communication mechanism for such activities
- Strategic coordination conducted between the State civil aviation authority prior to the activity and tactical management of the launch/reentry activity
- Advance notification prior to confirmation of launch
- Consideration and continued coordination with the originators of the launch if original re-entry boundary has been declined by the affected State
- Harmonization of coordination between States with originating Space Shuttle launches with affected States

- c) Conflict advisory
- d) Confirm receipt and request response to KATCAJRX



# **USNOF MESSAGE TO FOREIGN ANSP**

# **Upon message from Space Ops, USNOF will:**

 Send AFTN message to specified Air Navigation Service Provider (ANSP) with information from ATO Space Operations message, to include NOTAM request.

\*Note: The same steps will be followed for NOTAM cancellations or reissuance.


#### LETTER OF AGREEMENT

EFFECTIVE: DECEMBER 3, 2020

SUBJECT: CANSO ATFM DATA EXCHANGE NETWORK FOR THE AMERICAS (CADENA) SPACE LAUNCH AND RECOVERY PROTOCOLS

The participating CADENA Air Navigation Service Providers (ANSPs) and the Federal Aviation Administration (FAA) Air Traffic Organization (ATO) Space Operations office (ATO Space Ops) enter into this Letter of Agreement (LOA) to facilitate the safe and efficient movement of space launch and recovery between and through participating ANSP flight information regions (FIRs).

- 1. PURPOSE: The purpose of this LOA is to facilitate the safe and efficient movement of space launch and recovery operations between and through participating ANSP FIRs. This LOA promotes communication, collaboration, and coordination between the participating ANSPs and ATO Space Ops regarding space launch and recovery operations. The information shared among participating CADENA participating ANSPs and stakeholders is for the sole purpose of aviation safety.
- 2. SCOPE: This agreement establishes a common regional, cross-border air traffic management (ATM) communications protocol, a seamless operational atmosphere that incorporates common operating procedures and practices, and a performance reporting and review structure and process. The operations described herein are for use by participating CADENA ANSPs and ATO Space Ops to provide space launch and recovery information. This LOA is a non-binding regional operational agreement and is not intended to replace any local agreements or any other LOAs between participating ANSPs.

CADENA recognizes the importance of innovation in the aviation industry and is committed to continually setting new challenges for the team, adding new entrants, and making positive changes that benefit the LAC region stakeholders.

#### 7.1 Space Launch and Recovery

CADENA acknowledges the importance of the operational integration of commercial space operators into the CADENA regional ANSPs and airline operators. Cape Canaveral Space Force Station located on Florida's central Atlantic coastline is the primary launch site for the United States Eastern Range with multiple, adjacent CADENA FIRs. Space operations are growing rapidly with launches occurring from Vandenburg Air Force Base, CA; Mojave Air and Space port, CA; Pacific Spaceport Complex, AK; Kennedy Space Center, FL; SpaceX, Boca Chica, TX; Wallops Flight Facility, VA. Helping to ensure operational safety throughout the global airspace system during launches and recoveries is of primary importance to CADENA.

To that end, CADENA works in partnership with the FAA's ATO Space Operations at the Air Traffic Control System Command Center (ATCSCC) to help promote operational safety and efficiency during space launches and recoveries through the implementation of the following procedures.




Figure B. Historical Peak Traffic 2019

The Space operations Collaboration Decision Making (CDM) teleconferences reduced the SpaceX polar launch aircraft hazard area (AHA) and active times for Transporter 2. The improvements with relation Transporter 1 mission include a new hazard area 50% smaller, allowing critical airways usage to the east of the hazard area. The active times were also rescheduled to after peak traffic hours of 15-1900 UTC, mitigating impacts to traffic flow.






