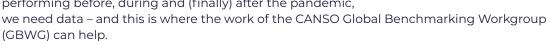

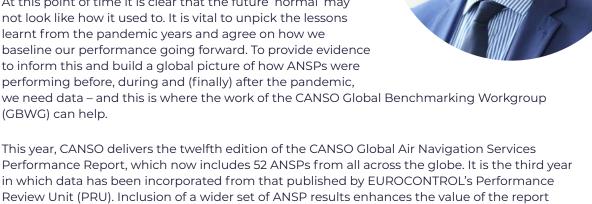

OREWOR

Since early 2020, aviation has been experiencing one of the most difficult periods by any measure or benchmark. The collapse of traffic volumes due to state-imposed travel restrictions aimed at controlling the spread of the COVID-19 pandemic and new virus variants have had devastating effects. The impact has extended far longer than anyone first believed possible at the beginning of the crisis and our attention have begun to shift away from short-term crisis management towards longer-term planning, recovery and building resilience.

At this point of time it is clear that the future 'normal' may not look like how it used to. It is vital to unpick the lessons learnt from the pandemic years and agree on how we baseline our performance going forward. To provide evidence to inform this and build a global picture of how ANSPs were performing before, during and (finally) after the pandemic,





Review Unit (PRU). Inclusion of a wider set of ANSP results enhances the value of the report by presenting an even more global and unique insight into ANS performance. The report is a key output of the work of the GBWG and acts as a tool for ANSPs to compare, contrast and identify good practices and best efforts in ANS performance, particularly in the areas of cost efficiency and ATCO productivity, which were all severely impacted by the decline in traffic.

In this edition, we look back on performance in 2020 at how participating ANSPs were affected by the pandemic and how it reflects in our key performance metrics. In addition, we look at specific feedback from CANSO members on how their businesses have changed and what the pandemic means for resiliency and ANSPs' ability to mitigate the effect of similar challenges in the future.

I would like to thank the CANSO GBWG and all the participating CANSO members. I also thank EUROCONTROL for their support in increasing the scope, scale and utility of our report. In addition, I would like to thank Egis for ten years' of their efforts in data collection and analysis, and their continued dedication in supporting CANSO and the GBWG with this work.

EXECUTIVE SUMMARY

COVERAGE

The CANSO Global Air Navigation Services (ANS) Performance Report is produced annually by CANSO's Global Benchmarking Workgroup (GBWG) with the support of Egis. Through agreement with EUROCONTROL's Performance Review Unit (PRU), data regarding European ANSPs taken from the ATM Cost-Effectiveness (ACE) Benchmarking Report has been included. ACE Report data collected by the PRU since 2002 is available on the ACE dashboard.

This year's report provides data for 52 ANSPs and contains performance indicators for the year 2020, along with trend data between 2016 and 2020.

In line with CANSO's ambitions for the *Global ANS Performance Report* to reflect a broader picture of performance, data provided by the CANSO Safety Intelligence Workgroup (SIWG) has been included. Collaboration between CANSO workgroups aims to enable interdependencies between data to be analysed and ultimately drive better insights into the reasons behind performance trends.

THE PANDEMIC'S IMPACT ON KEY PERFORMANCE INDICATORS

Any assessment of how the ATM system performed during the pandemic is tied to many factors. The highest priority during crisis must be that the ATM system preserves safety and business continuity during times of uncertainty. On those measures, all indicators are that the system did extremely well. Service interruptions were few and of short duration and were often the result of COVID-19 infection amongst ANSP operational staff. There were some small increases in accident rates per million flights¹ but the fatality risk in 2020 remained unchanged from the 5-year average.

There is also evidence that operational performance metrics affected by congestion improved in line with traffic decline, such as those associated with flight efficiency. This provided limited benefits for those aircraft operators still flying, such as reduced holding, more optimised routing and would have been experienced in reduced excess fuel burn.

While on these measures linked to ANSPs essential services role and the quality of service provided it is clear that the system performed well, it is also clear that other metrics show vulnerabilities to traffic shocks that need to be examined for lessons in future resilience. Financial resilience is a key factor that must be considered, particularly for long duration crisis such as the COVID-19 pandemic. An ability to quickly and easily scale operational costs while ensuring appropriate financial support allows for a flexible response to changing demand in either direction.

With a sudden and severe decline in traffic, it is not surprising that unit cost and productivity metrics were severely impacted. Costs per IFR flight hour is a metric that cumulates ANSPs costs and spreads those out over the total number of annual IFR flight hours the ANSP handles in its airspace. In 2020, the median cost per continental and oceanic IFR flight hour amongst participating ANSPs reached USD 895; representing a year over year increase of 104% (the 2019 median was USD 421). Some ANSPs saw even more significant 200-300% changes in this metric, primarily due to high proportions of international traffic or complete local travel bans, while others, particularly those with strong domestic markets, were less affected.

It is important to note that while cost per IFR flight hour increased significantly, that does not mean that aircraft operators experienced those cost increases through pricing changes. The data show that service charges collected by ANSPs in 2020 covered only 65% of ANSP costs. While in many cases the debt incurred will have to be recouped through future traffic, this provided valuable assistance during a crisis that was having significant financial impacts on air operators.

ANSPs did not have had the same opportunity as others in the aviation industry to reduce staffing levels because all airspace needed to remain open and the majority of services needed to continue 24/7. The decline in traffic did result in fewer hours worked with average continental and oceanic ATCO annual working hours dropping by 14% from 1534 to 1319, when comparing the same set of ANSPs.

Not surprisingly, there was also a decline of 28% in continental and oceanic ATCO productivity as measured by IFR flight hours per ATCO in operations. Additionally, average ATCO employment costs did not fall despite a reduction in overtime hours for some ANSPs that accompanied the decrease in traffic.

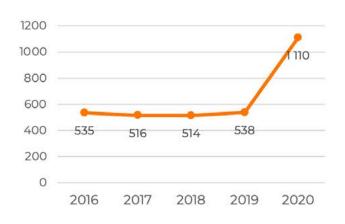

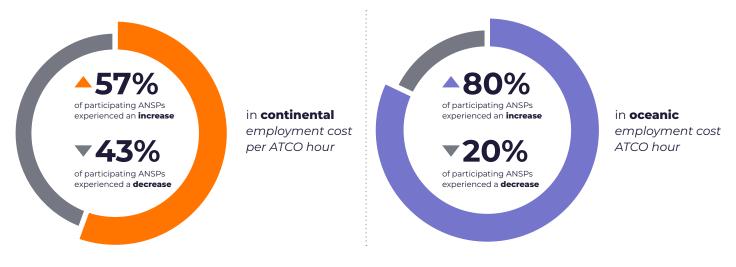

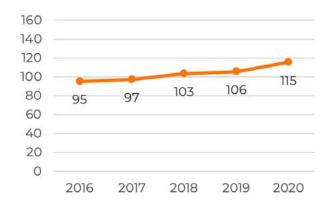

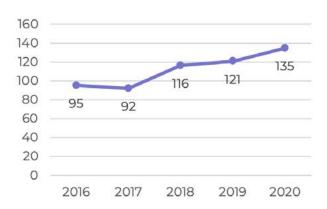

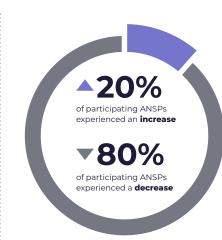

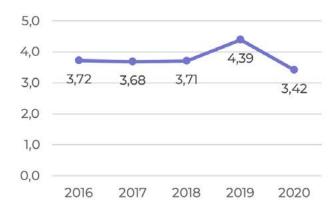

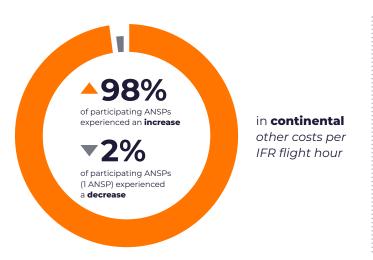

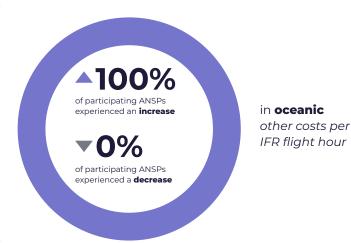

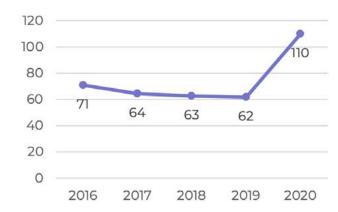

INTRODUCTION

COMPARING ANSP PERFORMANCE

Air navigation service providers (ANSPs) are responsible for managing global air traffic safely, efficiently and cost-effectively. This includes managing and enhancing airspace capacity through improvements to infrastructure and technology, and improving efficiency through a skilled and productive workforce and an innovative approach to airspace management.

The performance of the air navigation system impacts stakeholders throughout the aviation ecosystem. From boosting connectivity and minimising delays, to upholding the highest standard of safety in aviation, efficient, effective air navigation services are a critical component of a high-performance aviation industry. To that end, CANSO has devised benchmarking exercises that aggregate and review global performance accordingly.

Comparing and benchmarking key financial and productivity indicators enables ANSPs to make informed decisions when pursuing increased cost-effectiveness and productivity, without impacting safety – the industry's top priority. The understanding gained from benchmarking helps ANSPs to work together to address both their own performance and that of the ATM industry worldwide. The annual CANSO Global ANS Performance Report has served to highlight global performance trends for over 12 years.

MEASURING COST EFFICIENCY AND PRODUCTIVITY

Cost efficiency and productivity are two key performance indicators of air navigation services that enable this monitoring of performance. They demonstrate how ANSPs are delivering value and serve as indicators of operational efficiency. The CANSO ANS Performance Framework identifies the factors that determine cost-efficiency and productivity, including employment costs, hours worked and other costs, and is used to create a clear, common model for understanding global ANS performance.

GLOBAL AIR NAVIGATION SERVICES PERFORMANCE REPORT

This year's Global Air Navigation Services Performance Report contains performance indicators for identified ANSPs for the year 2020, along with trend data between 2016 and 2020.

ANSPs submitting to CANSO have also provided contextual comments, including any exceptional events during the year or items that may impact the comparability of their data. Additional comments on important events are included within the contextual data, providing insight into the results of the participating ANSPs.

The detailed results for each ANSP can be found in the CANSO Global Benchmarking Workgroup Performance Dashboard, which is available to participating GBWG members.

INCORPORATION OF PRU DATA

A key objective for CANSO and the members of CANSO's Global Benchmarking Workgroup (GBWG) is to continue to increase the global coverage of the data included in the annual *Performance Report*. To support this, for the third year, CANSO, with the agreement of EUROCONTROL, has incorporated public data collected by EUROCONTROL's Performance Review Unit (PRU) to complete the representation of European ANSPs in the dataset.

It should be noted that while the raw data extracted from the ACE Report is directly comparable, the final KPIs expressed in the CANSO report are not directly comparable to those reported in the ACE report.

Primarily, this is because the KPIs use different inputs. In particular, the CANSO report uses IFR flight hours and extracts "total flight hours controlled by the ANSP" as a comparable data point from the ACE dataset, while the ACE Report uses "composite flight hours". These comparable data points were validated as part of a comparison exercise undertaken by Egis, which was presented to the GBWG at GBWG/32 in Tokyo.

Differences in indicators between the two reports, go beyond the use of a different flight hour measurement. Two key examples are highlighted below:

- CANSO's Performance Report converts all cost data into USD instead of EURO
- CANSO's Performance Report primarily uses Organisation for Economic Cooperation and Development (OECD) as a source for exchange rate, inflation rate and PPP information, whereas EUROCONTROL's ACE Report uses a combination of EUROSTAT and IMF data.

European GBWG members have been allowed to request, with justification, to use the GBWG submission instead. For further details please see *Global Air Navigation Services*Performance Report 2016-2020: Participation.

IMPACT OF COVID-19 ON 2020 PERFORMANCE

PANDEMIC IMPACT ON TRAFFIC

This report focuses on 2020 performance data, however, the reporting periods of members' organisations are not aligned in all instances. The performance data of those ANSPs that have reporting periods running from second half of 2019 or into the first part of 2021 may be differently impacted by the drops and waves in traffic caused by the developing COVID-19 pandemic.

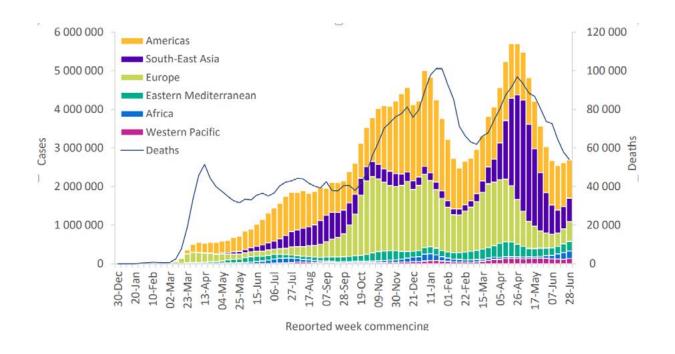


Figure 1 – Number of COVID-19 cases reported weekly by WHO Region, and global deaths, 30 December 2019 to $04 \, \text{July} \, 2021^4$

Figure 1 provides a view on the number of COVID-19 cases recorded across the different regions of the globe from early 2020 until mid-2021. The Western Pacific Region was the first region within which there was a significant spike in recorded COVID-19 infections, beginning in late January 2020, and peaking during the w/c 10 February 2020. The rise of recorded infections then began to spread across the globe, starting with Europe noticing a significant spike in March

2020. Recorded cases then began to increase significantly in the Americas, Eastern Mediterranean and South-East Asia during the month of April and May 2020. Africa followed next, with recorded cases building to a peak during late-May and June.

By the last quarter of 2020, a second, even more significant increase of cases hit the world, mainly impacting Europe and Americas. South-East Asia experienced a slightly delayed but even more shocking rise starting in March and April 2021.

Significant seasonality in traffic volumes requires adjustments in capacity. Figure 6 which shows overflight movements in 2018 and 2019 demonstrates how much difference there is between winter and summer for HungaroControl.

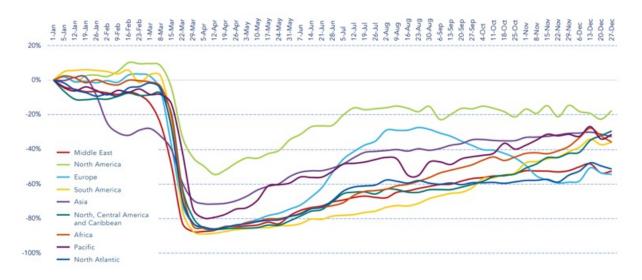


Figure 2 – Percentage change in aircraft movements by region, from Jan 2020 towards Dec 2020. Taken from <u>CANSO ATM Traffic Analysis Report</u> (January 2021)

To some extent, aircraft movements across 2020 (as shown in Figure 2) follow a similar regional staggered pattern to the distribution of cases (shown in Figure 1). Figure 2 highlights the clear reduction in aircraft movements in Asia in February, several weeks ahead of the marked traffic decreases seen in other regions (NB: the CANSO Asia Pacific region used in Figure 2 contains a subset of the countries included in the WHO's Western Pacific region⁵). During this initial stage of the pandemic, Europe and North America only faced minor traffic decreases, as travel bans were limited to certain routes to and from China during the early stages of the pandemic.

During March 2020, the timeframe within which aircraft movements in the remaining regions dropped was, however, far more truncated than that of the increase in number of COVID-19 cases. This reflects the sudden, and wide reaching, travel restrictions imposed by governments to prevent further infections being introduced to their respective countries through their borders at the start of the pandemic. This drop in movements also reflects the drastic shift of passenger opinion towards an avoidance of air travel to reduce the risk of catching COVID-19⁶.

The pattern in North America and Europe then started to raise back in mid-2020 until the next waves of cases hit the regions. The traffic in Europe bounced back to 60% of 2019 levels by the end of 2020.

IMPACT OF COVID-19 AND VARIED REPORTING PERIODS

There is a clear correlation between the rise in coronavirus cases globally and the unprecedented and sustained drop in traffic seen during the first months of 2020. This notably affected those ANSPs in Asia approximately one month earlier than others across the rest of the world.

Similarly to the last year's report, in collaboration with FAA-ATO we have indicated the reporting periods (fiscal years)

of all ANSPs included in our data. As seen in the following figure, performance data of some ANSPs whose reporting period starts in 2019 were less affected by the impact of the COVID-19 pandemic. Others, especially those ANSPs whose reporting periods stretched into 2021 were more impacted. This must be taken into context when interpreting the trends of those affected ANSPs included in the 2020 Performance data section.

Fiscal Years and COVID-19

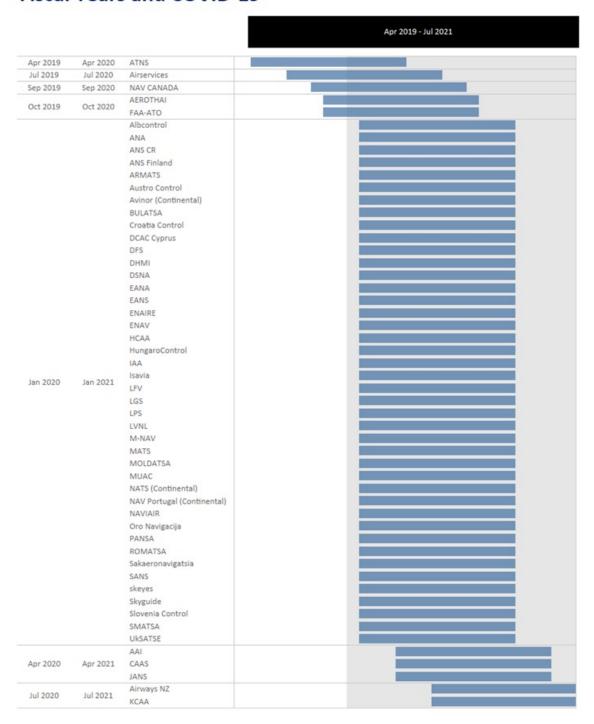


Figure 3 – Reporting periods and COVID-19

In the next figure, the reporting periods are overlaid with information about border closures. It is apparent that every ANSP felt the repercussions of these closures; however, they are not uniformly reflected in the data for many reasons, including (but not limited to) varying fiscal years, the degree to which borders were closed, and domestic airspace size.

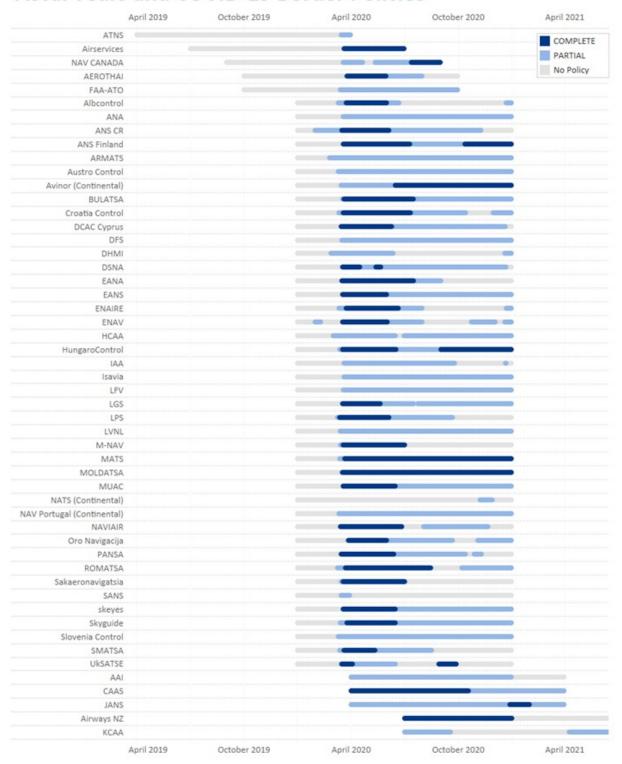


Figure 4 - Reporting periods and COVID-19 border policies

MITIGATING THE FINANCIAL EFFECT OF THE PANDEMIC

As part of the 2020 submission process, a survey on how individual organisations have managed the COVID-19 was included. The overview of responses of ANSPs submitting to CANSO are provided below.

The majority of ANSPs submitting to CANSO took action to adjust their cost base in response to the downturn in traffic and revenue and sought financial support to help fill the revenue gap. Yet it is worth noting that average total costs have only decreased marginally when compared to 2019, despite there being a large variance between ANSPs.

A large majority, 74%, of ANSPs controlled expenditures through the review and postponement of existing CAPEX. While this may serve to reduce planned expenditures quickly in order to ensure continued operation during the pandemic, postponing future projects may delay much-needed capacity enhancements, which may cause difficulties

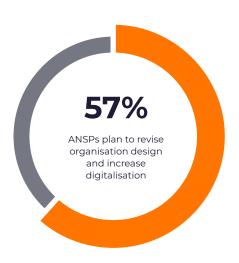
should traffic rebound quickly to prepandemic levels. However, just 4% of ANSPs completely stopped their CAPEX programmes altogether, meaning there is likely awareness of the risks posed by doing so.

While there were operating cost reductions, these were not sufficient to match costs with significantly reduced revenues. Providers have managed to retain ATCOs while deploying them on other, more cost-effective duties, offsetting efficiency losses while keeping operational costs similar. ANSPs highlighted the high level of fixed costs and the challenges around ATCO retention and training (to avoid capacity shortages as traffic recovers) as factors limiting the reduction in operating costs.

Commercial loans were the predominant way for ANSPs submitting to CANSO to receive financial support to close the revenue/cost gap. Several ANSPs noted there was very limited scope for governments to provide capital injections, in part due to the competing financial demands on governments during the pandemic. Some ANSPs were able to access cash reserves or reduce financial pressure by deferring tax payments or other contributions for a period of time.

While increases in service charges have now occurred in many areas, very few occurred during 2020, with only 4% of respondents having adjusted charges. In fact many ANSPs gave service charge deferrals or fee holidays during the pandemic, while others kept charges stable while funding the deficit through commercial loans or state aid.

FUTURE RESILIENCE OF ANSPS



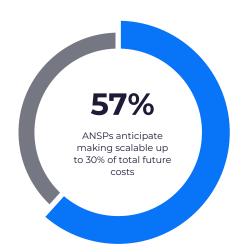


Figure 6 – Future resilience of ANSPs

It is clear that the past two years are causing many in the aviation industry to examine the factors that drive their resilience. A majority of ANSPs have indicated they have active plans to adjust their organisational design, shift priorities and increase digitalisation. An equal majority have indicated that they are seeking to make a portion of their future costs more easily scalable with traffic. Some have indicated their intention to integrate scalability into supplier contracts.

These efforts to examine ways to strengthen the ATM industry's ability to scale with traffic, even if only in part, are worthwhile. Scalability is not symmetrical, and measures that enable ANSPs to scale with traffic growth, will not always provide benefits in the instance of traffic decline.

As ANSPs look to make changes to strengthen future resilience to similar shocks it important to take a balanced view of system performance during this crisis. On certain metrics the system performed well. The impact of measures to enhance scalability on all performance areas should be continually evaluated.

2020 GLOBAL ANS REPORT PARTICIPATION

CANSO GBWG SUBMISSIONS

CANSO data submissions for this year's Global ANS Performance Report were received from 26 ANSPs. Together with the data from PRU, it provides data for 52 ANSPs. All ANSPs who submitted to PRU, CANSO or both are indicated in the table below.

Note that PRU data was used as default in this report for those submitting both CANSO and PRU.

CONTINENTAL COST EFFICIENCY AND PRODUCTIVITY: 2020

Indicator 1: Cost per IFR hour (USD) (Formula: Total costs / IFR flight hours)

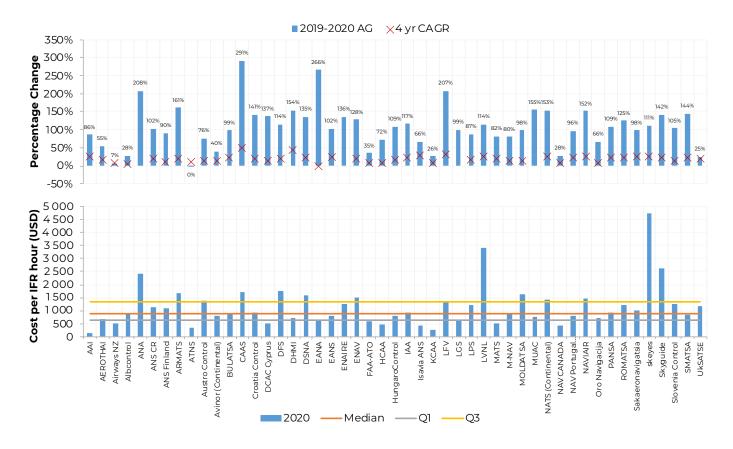


Figure 7 – Cost per IFR flight hour (USD)

The 2020 median cost per IFR flight hour is USD 896, heavily impacted by the loss of traffic due to the COVID-19 pandemic. The 2020 weighted average (taking into account total continental IFR flight hours per ANSP) cost per IFR flight hour is USD 700. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 444 and weighted average was USD 442.

In terms of absolute total costs, 78% of ANSPs saw reduction of total continental costs with median reduction of 10% between 2019 and 2020.

It should be noted that differences between the operational characteristics of ANSPs' airspaces may significantly influence their 'Cost per IFR flight hour'. For example, skeyes and LVNL have delegated control of their upper airspace to MUAC. skeyes and LVNL therefore have a higher 'Cost per IFR flight hour', than if they would also control the upper airspace, because the traffic is generally more complex in lower airspace. MUAC, meanwhile, make use of infrastructure provided by skeyes and LVNL, which reduces its 'Cost per IFR flight hour'. Furthermore, since the upper airspace does not include VFR flights, MUAC's ATCO in OPS productivity is fully reflected in this KPI, while the values for skeyes and LVNL does include VFR workload, which reduces the ATCO in OPS productivity.

UkSATSE (Ukraine)

The following justification is taken from the ACE Report 2020.

In the case of UkSATSE, the main driver of cost reductions were reduced staff costs (-41.8%) due to the implementation of short-time work, natural attrition and job displacements. The second largest contributors were exceptional items (-86.5%) due to the reporting of a very large amount of bad debts in 2019.

Austro Control (Austria)

The following justification is taken from the ACE Report 2020.

For Austro Control, staff costs (-32.0%) were the main driver. It is understood that this results from the combination of a large decrease in pension contributions, public funding of short-time work, decrease in overtime payments and the waiver of termination benefits, leading to a decrease in future termination liabilities.

ENAV (Italy)

The following justification is taken from the ACE Report 2020.

For ENAV, all cost categories decreased in 2020, with the main contributors being ATCO employment costs (-11.0% mainly due to a reduction in the variable component of the remuneration), the cost of capital (-16.8% following the decision to cap the cost of capital charged to airspace users in respect of the year 2020) and non-staff operating costs (-2.7%).

DFS (Germany)

The following justification is taken from the <u>ACE Report 2020.</u>

For DFS, the increase in non-staff operating costs (+19.5%) was outweighed by reductions in staff costs, depreciation costs and the cost of capital. The latter is the most significant reduction (-60.8%). It reflects a decision to apply a 0% return on equity and to charge only the cost of debt for the year 2020.

HCAA (Greece)

The following justification is taken from the <u>ACE Report 2020.</u>

For HCAA, there was decrease in staff costs (-22.6% mainly due to the reduction of the variable component of remuneration which is linked to the level of traffic), non-staff operating costs (-18.8%) and depreciation costs (-54.7%).

LFV (Sweden)

The following justification is taken from the <u>ACE Report 2020.</u>

For LFV, there was an exceptionally high increase in staff costs (+53.9%) due to an actuarial revaluation of pension liabilities following the decrease in the discount rate. Overall, the impact of the increase in staff costs was reduced by the decreases in all other cost categories.

MUAC (-)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of MUAC, staff costs are also the only cost category increasing in 2020 (+13.0%) while small reductions were achieved in other cost categories. The increase in staff costs is mainly due to a combination of two factors: a +5.2% increase in the number of staff, primarily reflecting additional ab-initio trainees and the application of the general condition of employment for ATCOs in OPS which were revised in 2019.

NAVAIR (Denmark)

The following justification is taken from the ACE Report 2020.

For NAVIAIR, there were higher staff costs (+10.2%) reflecting the creation of a provision for voluntary redundancies. The full effect expected from this measure in terms of staff cost reductions will materialise in 2022 since most of staff departures started only in the last quarter of 2021. Increases in depreciation costs (+10.0%) and cost of capital (+22.9%) are also observed mainly due to upgrades to the ATM system and the application of a higher weighted average cost of capital.

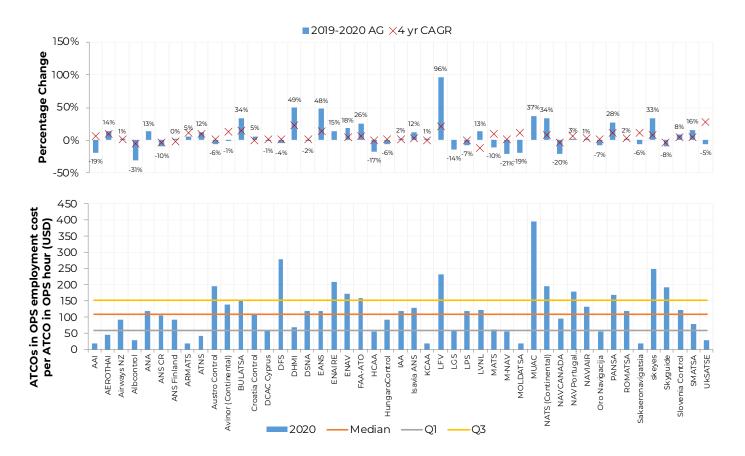


Figure 8 – ATCOs in OPS employment cost per ATCOs in OPS hour (USD)

The 2020 median ATCOs in OPS employment cost per ATCOs in OPS hour is USD 111. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 105.

Specific ANSP comments are outlined below.

LFV (Sweden)

The following justification is taken from the ACE Report 2020.

The exceptionally high increase between 2019 and 2020 in case of LFV is affected by an actuarial revaluation of pension liabilities following the decrease in the discount rate.

MUAC (-)

The following justification is taken from the <u>ACE Report 2020.</u>

The increase in ATCO in OPS employment costs is mainly due to the application of the general condition of employment for ATCOs in OPS which were revised in 2019.

UkSATSE (Ukraine)

The following justification is taken from the ACE Report 2020.

In the case of UkSATSE, the metric is impacted by the decrease of number of ATCOs in OPS, which reflect situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents.

Skyguide (Switzerland)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of Skyguide, the metric is impacted by the decrease of number of ATCOs in OPS, which reflect situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents. It is important to take into account the fact that the 2020 staff costs could be lowered thanks to the application of a short-time work mechanism which enabled Skyguide to be reimbursed for a fraction of employees' salaries by the employment insurance.

Austro Control (Austria)

The following justification is taken from the ACE Report 2020.

For Austro Control, the observed decrease mainly reflects lower pension contributions but also a reduction in gross wages and salaries due to the decrease in overtime payment and the public funding of short-time work.

Avinor (Norway)

The following justification is taken from the <u>ACE Report 2020.</u>

For Avinor, the decrease is mainly due to the furlough scheme implemented, reduction of overtime hours as well as temporary and permanent redundancies. During the temporary redundancy period the employees are compensated by the State.

ENAV (Italy)

The following justification is taken from the <u>ACE Report 2020.</u>

For ENAV, there were reductions in variable salary components (including overtime) and some containment measures on salary increases. There was also an decrease in ATCO in OPS employment costs reflecting lower variable remuneration (less overtime and lower performance bonuses) and the use of backlog holidays. In addition, the lower remuneration resulted in a consequent reduction in social security contributions.

ENAIRE (Spain)

The following justification is taken from the <u>ACE Report 2020.</u>

For ENAIRE, there were reductions in variable salary components (including overtime) and some containment measures on salary increases. There was also an increase in the number of ATCOs in "active reserve", which is an intermediate step between the withdrawal of functions in OPS and the retirement of ATCOs.

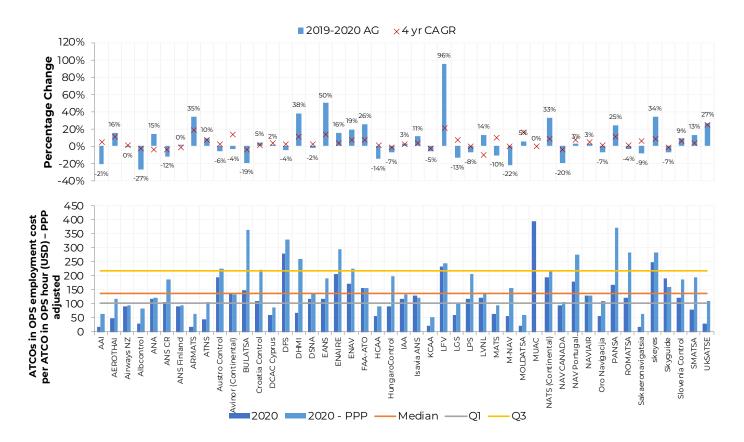


Figure 9 – ATCOs in OPS employment cost per ATCOs in OPS hour, PPP adjusted (USD)

The 2020 median ATCOs in OPS employment cost per ATCOs in OPS hour, after PPP adjustment is USD 139. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 129.

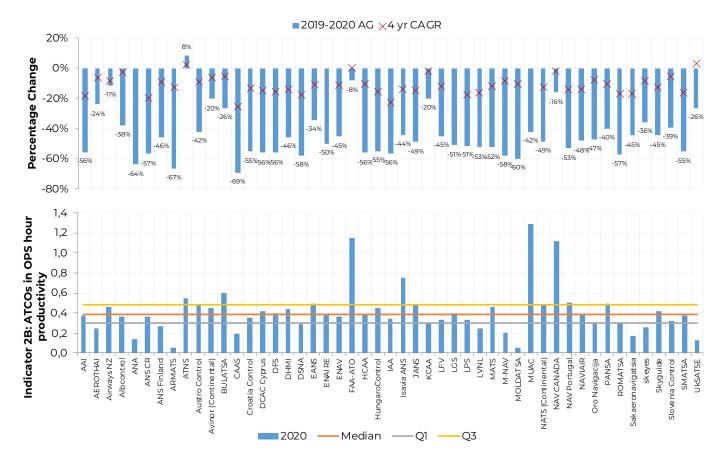


Figure 10 - ATCOs in OPS hour productivity

2020 median ATCOs in OPS hour productivity is 0.38. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was 0.76.

Specific ANSP comments are outlined below.

FAA-ATO (USA)

FAA-ATO Productivity was not as impacted as other ANSPs because FAA-ATO did not have as large of a percent reduction in IFR flight hours. The FAA-ATO controls one of the largest areas of airspace globally and still had cargo traffic even while passenger traffic was down. In addition, ATCO in OPS hours also decreased in 2020 due in part to the staffing measures taken to reduce potential COVID-19 exposure risk and the decrease in overtime hours.

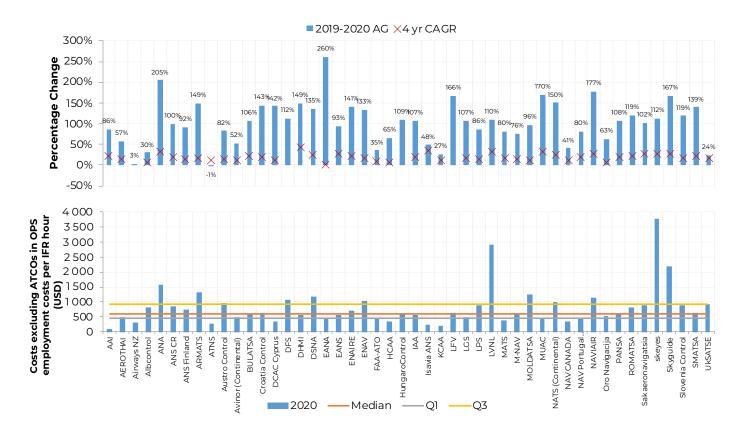


Figure 11 - Cost excluding ATCOs in OPS employment costs per IFR flight hour (USD)

The 2020 median cost excluding ATCOs in operations employment cost per IFR flight hour is USD 609. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 311.

In terms of absolute total costs, 80% of ANSPs saw reduction of continental costs excluding ATCOs in OPS employment costs with median reduction of 8% between 2019 and 2020.

For the same reasons stated in the description of Indicator 1 'Cost per IFR flight hour', it should be noted that differences between the operational characteristics of ANSPs' airspaces may significantly influence their 'Costs excluding ATCOs in OPS employment costs per IFR hour'.

Specific ANSP comments are outlined below.

UkSATSE (Ukraine)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of UkSATSE, there were reductions in staff costs (-40.1% due to the implementation of short-time work) and exceptional costs (-86.5% due to very high provisions for bad debt in 2019).

HCAA (Greece)

The following justification is taken from the <u>ACE Report 2020.</u>

For HCAA, the metric is impacted by the fall in support staff costs (-26.9% mainly due to the reduction of the variable component of remuneration which is linked to the level of traffic), non-staff operating costs (-18.8%) and depreciation costs (-54.7%).

NAV Portugal (Portugal)

The following justification is taken from the ACE Report 2020.

For NAV Portugal, metric is impacted by the lower support staff costs (-37.5%), which results from the combination of exceptional actuarial gains on staff pensions and a reduction in wages and overtime hours for the support staff.

LPS (Slovakia)

The following justification is taken from the ACE Report 2020.

LPS reduced support staff costs (-43.3% mainly due to reductions in salaries and benefits) and non-staff operating costs (-24.5% by limiting the non-essential expenditures).

Albcontrol (Albania)

The following justification is taken from the <u>ACE Report 2020.</u>

For Albcontrol, support staff costs fell by -44.0% due to salary reductions and application of a furlough scheme. Nonstaff operating costs decreased by -44.9%. The drop in depreciation costs (-38.0%) and cost of capital (-12.4%) resulted from the revaluation of Albcontrol's assets and the extension of the asset-life for some of them.

Indicator 2D: Proportion of total costs made up of ATCO in OPS employment costs (USD) (Formula: ATCO in OPS employment costs/Total Costs)

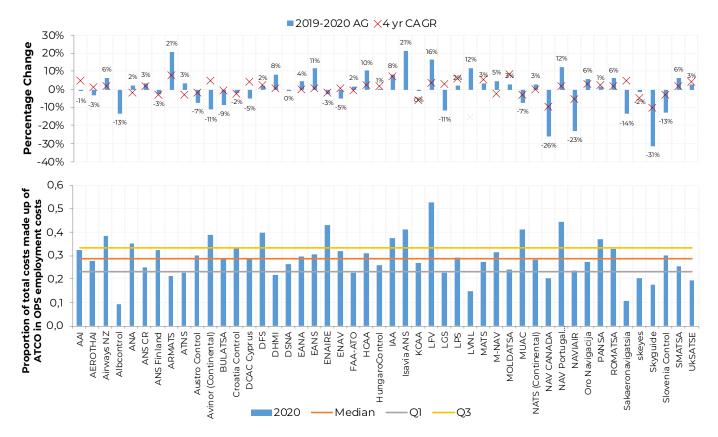


Figure 12 – Proportion of total costs made up of ATCO in OPS employment costs

In 2020, on median 29% of total ANS costs were spent on employing ATCO in OPS. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was 28%.

Indicator 3A: Annual employment cost per ATCO in OPS (USD) (Formula: ATCOs in OPS employment costs / No. ATCOs in OPS)

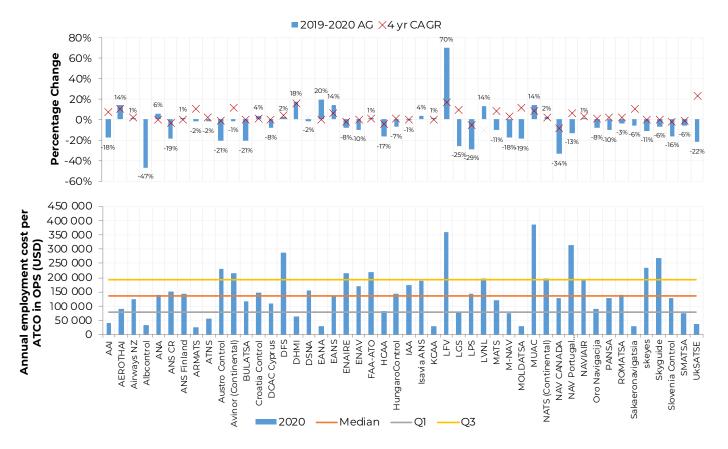


Figure 13 – Annual ATCO in OPS employment cost (USD)

The 2020 median unit ATCO in OPS employment cost is USD 137,282. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 143,457.

Specific ANSP comments are outlined below.

AEROTHAI (Thailand)

AEROTHAI calculated FTE using total actual working hours divided by full-time equivalent working hours which is 160 hours per month for ATCO. This method of calculation is different from what we used to do and report to CANSO, therefore the KPI in this report is incomparable to KPI presented in the previous reports. Moreover, AEROTHAI will be adjusting FTE calculation for the next submission for 2022 report, according to the new definition of FTE.

LFV (Sweden)

The following justification is taken from the <u>ACE Report 2020.</u>

The exceptionally high increase between 2019 and 2020 in the case of LFV is affected by an actuarial revaluation of pension liabilities following the decrease in the discount rate.

MUAC (-)

The following justification is taken from the <u>ACE Report 2020.</u>

The increase in ATCO in OPS employment costs is mainly due to the application of the general condition of employment for ATCOs in OPS which were revised in 2019.

UkSATSE (Ukraine)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of UkSATSE, there was the decrease of number of ATCOs in OPS, which reflect situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents.

Skyguide (Switzerland)

The following justification is taken from the ACE Report 2020.

In the case of Skyguide, there was decrease in the number of ATCOs in OPS, which reflects situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents.

It is important to take into account the fact that the 2020 staff costs could be lowered thanks to the application of a short-time work mechanism which enabled Skyguide to be reimbursed for a fraction of employees' salaries by the employment insurance.

Austro Control (Austria)

The following justification is taken from the <u>ACE Report 2020.</u>

For Austro Control, the observed decrease mainly reflects lower pension contributions but also a reduction in gross wages and salaries due to the decrease in overtime payment and the public funding of short-time work.

Avinor (Norway)

The following justification is taken from the <u>ACE Report 2020.</u>

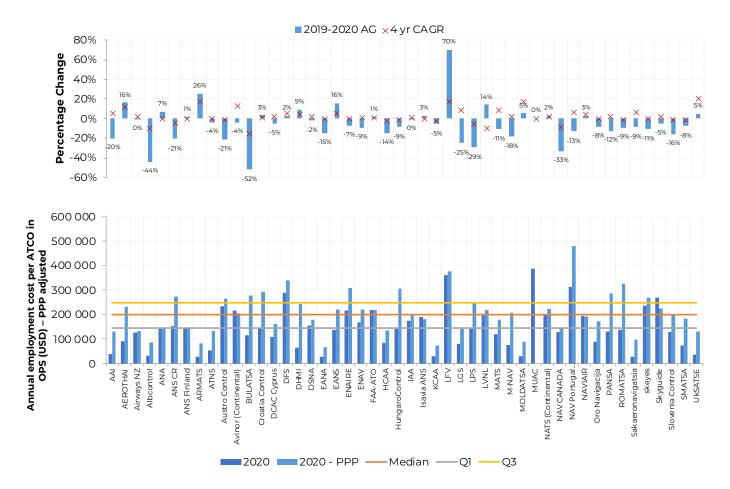


Figure 14 - Annual ATCO in OPS employment cost (USD) - PPP adjusted

The 2020 median unit ATCO in OPS employment cost, after PPP adjustment, is USD 198,517. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was USD 198,592.

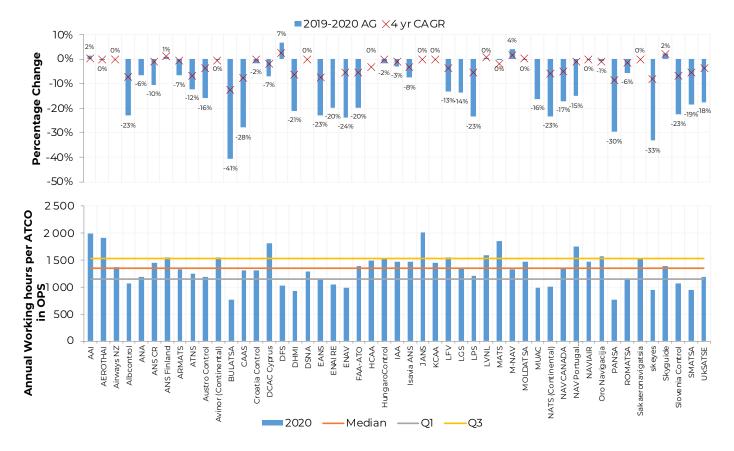


Figure 15 – Annual Working hours per ATCO in OPS

The 2020 median annual working hours per ATCO in OPS is 1,341 hours. Differences in this metric are influenced by the number of staff working full time. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was 1,459 hours.

Specific ANSP comments are outlined below.

AEROTHAI (Thailand)

AEROTHAI calculated FTE using total actual working hours divided by full-time equivalent working hours which is 160 hours per month for ATCO. This method of calculation is different from what we used to do and report to CANSO, therefore the KPI in this report is incomparable to KPI presented in the previous reports. Moreover, AEROTHAI will be adjusting FTE calculation for the next submission for 2022 report, according to the new definition of FTE.

Generic

The following justification is taken from the <u>ACE Report 2020.</u>

Reductions in average hours on duty per ATCO in OPS were a widespread practice across ANSPs. In most cases these reductions result from less overtime and adaptation to the extremely lower traffic levels (e.g. short time work).

UkSATSE (Ukraine)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of UkSATSE, the metric is impacted by the decrease of number of ATCOs in OPS, which reflect situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents.

Skyguide (Switzerland)

The following justification is taken from the <u>ACE Report 2020.</u>

In the case of Skyguide, the metric is impacted by the decrease in the number of ATCOs in OPS, which reflects situations where the application of short-time work resulted in a downward adjustment of the number of ATCOs when expressed in full time equivalents.

Avinor (Norway)

The following justification is taken from the <u>ACE Report 2020.</u>

For Avinor, the metric is impacted by the decrease in the number of ATCOs in OPS resulted mainly from temporary and permanent redundancies.

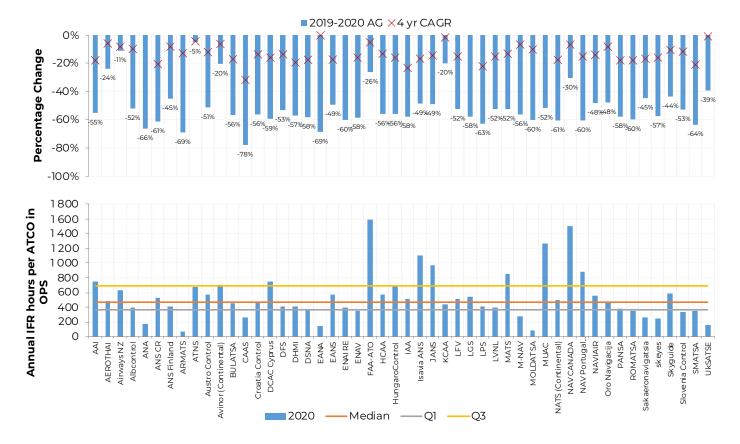


Figure 16 - IFR hours per ATCO in OPS

The 2020 median annual IFR hours per ATCO in OPS was 473 hours. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was 1,014.

Specific ANSP comments are outlined below.

AEROTHAI (Thailand)

AEROTHAI calculated FTE using total actual working hours divided by full-time equivalent working hours which is 160 hours per month for ATCO. This method of calculation is different from what we used to do and report to CANSO, therefore the KPI in this report is incomparable to KPI presented in the previous reports. Moreover, AEROTHAI will be adjusting FTE calculation for the next submission for 2022 report, according to the new definition of FTE.

FAA-ATO (USA)

FAA-ATO Productivity was not as impacted as other ANSPs because FAA-ATO did not have as large of a percent reduction in IFR flight hours. The FAA-ATO controls one of the largest airspace globally and still had cargo traffic even while passenger traffic was down.

Indicator 3D: Ratio of Frontline Service Staff to ATCO in OPS

(Formula: No. Frontline Service Support Staff / No. ATCOs in OPS)

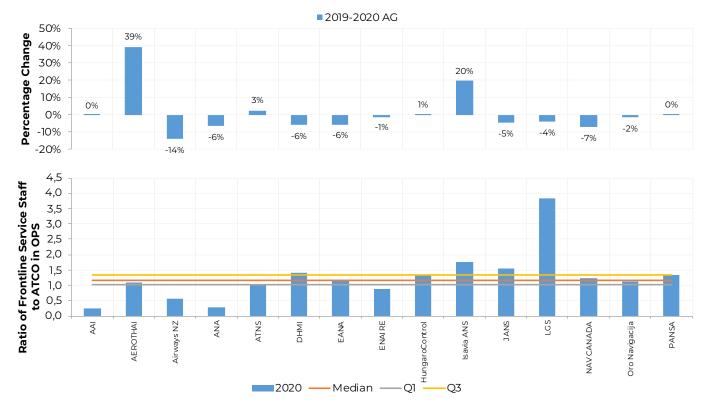


Figure 17 – Ratio of frontline service staff to ATCO in OPS

The 2020 median ratio of frontline service staff to ATCO in OPS is 1.16. All ANSPs submitting continental data for 2020 did so for 2019; the 2019 median was 1.23.

Please note there is no four year CAGR data points for this KPI because ANSPs have only submitted frontline service staff data since 2018.

Specific ANSP comments are outlined below.

AEROTHAI (Thailand)

AEROTHAI calculated FTE using total actual working hours divided by full-time equivalent working hours which is 160 hours per month for ATCO. This method of calculation is different from what we used to do and report to CANSO, therefore the KPI in this report is incomparable to KPI presented in the previous reports. Moreover, AEROTHAI will be adjusting FTE calculation for the next submission for 2022 report, according to the new definition of FTE.

OCEANIC COST EFFICIENCY AND PRODUCTIVITY: 2020

Indicator 1: Cost per IFR flight hour (USD) (Formula: Total costs / IFR flight hours)

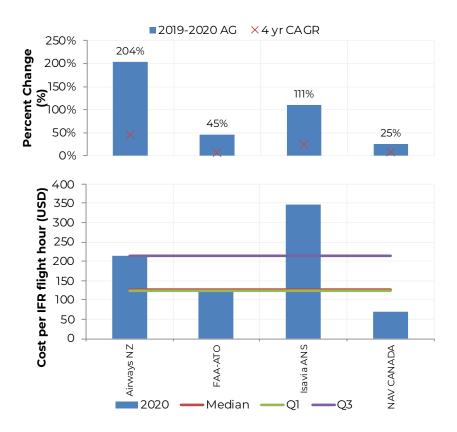


Figure 18 – Cost per IFR flight hour (USD)

The 2020 median cost per IFR flight hour is USD 126 (for comparison, this figure for continental flights is USD 896). The 2020 weighted average (taking into account total oceanic IFR flight hours per ANSP) cost per IFR flight hour is USD 127. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median for these ANSPs was 87 USD and weighted average was USD 88.

In terms of absolute total costs, all ANSPs saw reduction of total oceanic costs with a median reduction of 7% between 2019 and 2020.

Specific ANSP comments are outlined below.

Isavia ANS (Iceland)

Oceanic IFR hours dropped by almost 60% in 2020. This resulted in a significant increase in cost per IFR flight hour.

Indicator 2A: ATCOs in OPS employment cost per ATCO in OPS hour (USD)

(Formula: ATCOs in OPS employment costs / ATCOs in OPS Hours)

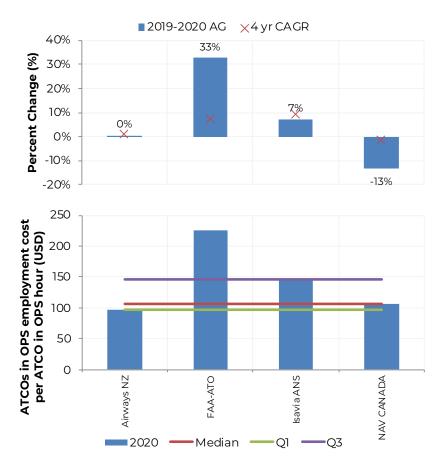


Figure 19 – ATCOs in OPS employment cost per ATCOs in OPS hour (USD)

The 2020 oceanic median employment cost per ATCO in OPS hour is USD 107. For comparison, the 2020 figure for continental airspace is USD 111. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was USD 124.

Specific ANSP comments are outlined below.

FAA-ATO (USA)

FAA-ATO ATCO in OPS employment cost per ATCO in OPS hour is higher for oceanic than continental; an effect of the higher cost of living in the areas that cover oceanic traffic. In addition, ATCO in OPS hours went down in FY2020 as compared to FY2019.

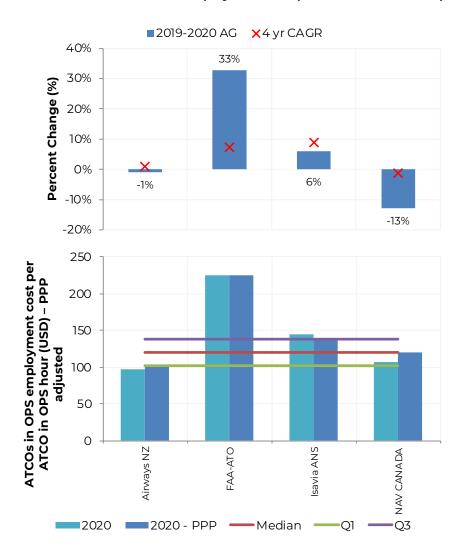


Figure 20 – ATCOs in OPS employment cost per ATCOs in OPS hour, PPP adjusted (USD)

The 2020 oceanic median employment cost per ATCO (PPP Adjusted) in OPS hour is USD 121, the median figure for continental airspace is USD 139. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was USD 130.

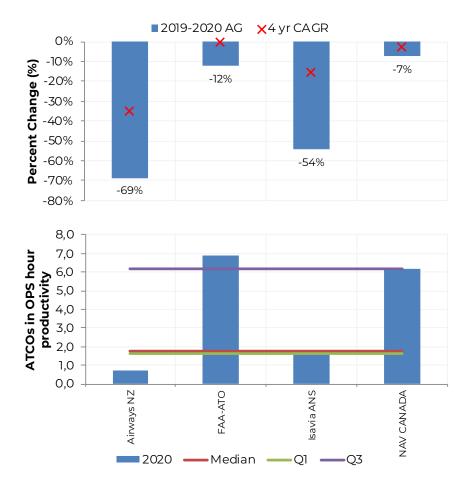


Figure 21 – ATCOs in OPS hour productivity

The 2020 median ATCOs in OPS hour productivity is 1.74 IFR flight hours per ATCO in OPS hours, significantly higher than the continental figure of 0.38. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median is 3.80.

Specific ANSP comments are outlined below.

Isavia ANS (Iceland)

Due to the significant reduction in traffic in 2020 there was a sizeable effect on ATCO productivity.

(Formula: Costs excluding ATCOs in OPS employment costs / IFR flight hours)

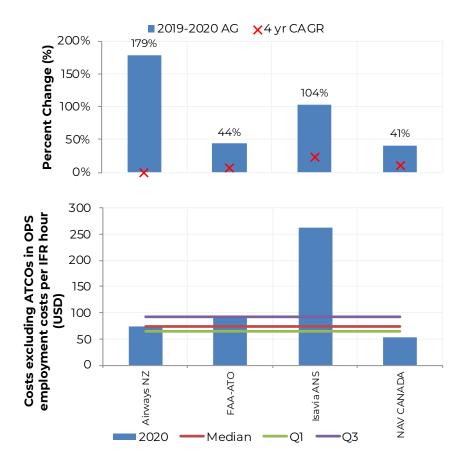


Figure 22 - Cost excluding ATCOs in OPS employment costs per IFR flight hour (USD)

The 2020 median cost excluding ATCOs in operations employment cost per IFR flight hour is USD 75. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was 50.

In terms of absolute total costs, all ANSPs saw reduction of oceanic costs excluding ATCOs in OPS employment costs with median reduction of 4% between 2019 and 2020.

Specific ANSP comments are outlined below.

Isavia ANS (Iceland)

Any data using IFR hours for 2020 was greatly affected by the sharp reduction in traffic due to the COVID-19 pandemic.

(Formula: ATCO in OPS employment costs/Total Costs)

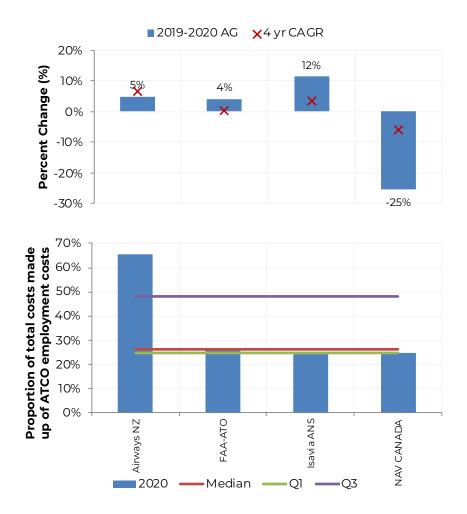


Figure 23 – Proportion of total costs made up of ATCO in OPS employment costs (USD)

The 2020 median for the proportion of total costs made up of ATCO in OPS employment costs is 26%. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was 33%.

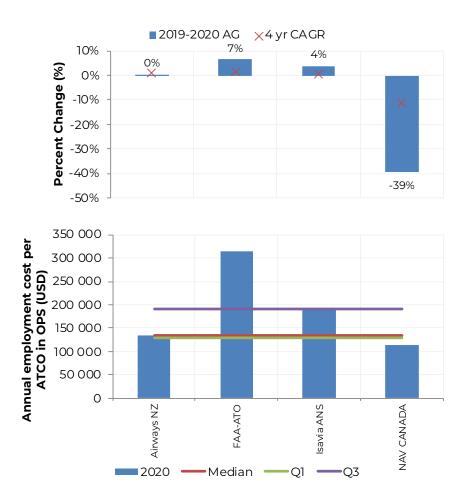


Figure 24 – Annual ATCO in OPS employment cost (USD)

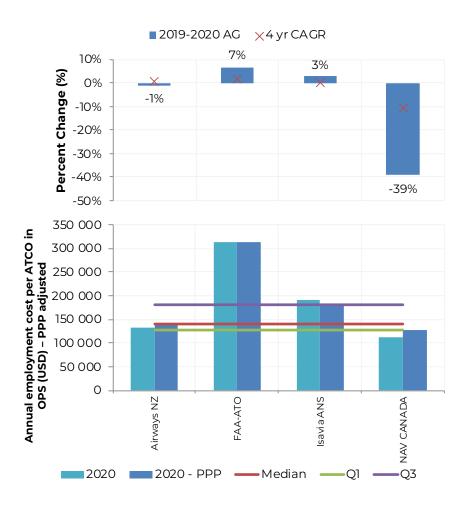


Figure 25 – Annual ATCO in OPS employment cost (USD) – PPP adjusted

The 2020 median unit ATCO in OPS employment cost, after PPP adjustment, is USD 140,528. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was USD 175,871.

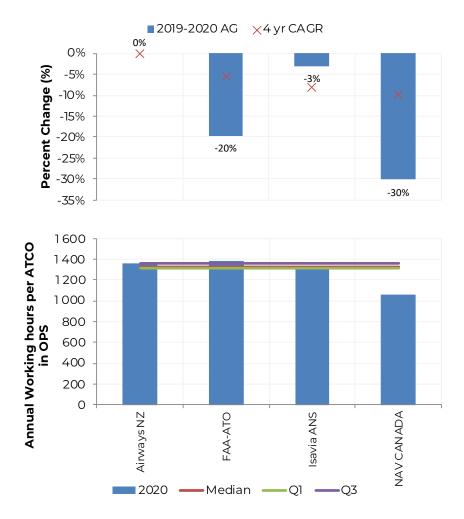


Figure 26 – Annual Working hours per ATCO in OPS

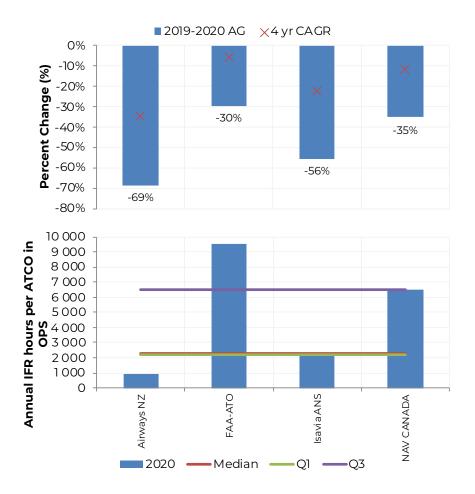


Figure 27 – IFR hours per ATCO in OPS

The 2020 median annual IFR hours per ATCO in OPS was 2,276 hours. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was 5,144.

Specific ANSP comments are outlined below.

Isavia ANS (Iceland)

Any data using IFR hours for 2020 was greatly affected by the sharp reduction in traffic due to the COVID-19 pandemic.

Indicator 3D: Ratio of Frontline Service Staff to ATCO in OPS

(Formula: No. Frontline Service Support Staff / No. ATCOs in OPS)

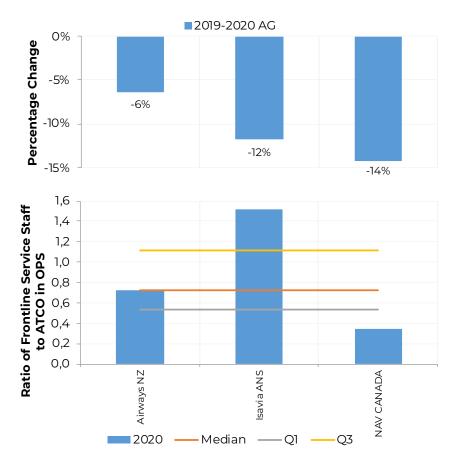


Figure 28 – Ratio of frontline service staff to ATCO in OPS

The 2020 median ratio of frontline service staff to ATCO in OPS is 0.72. All ANSPs submitting oceanic data for 2020 did so for 2019; the 2019 median was 0.77.

There is no four year CAGR data points for this KPI because ANSPs have only submitted frontline service staff data since 2018.

Specific ANSP comments are outlined below.

Isavia ANS (Iceland)

Isavia ANS would like to point out that roughly 90% of our operations are Oceanic, therefore, the ratio of frontline support staff is relatively higher than other larger ANSP's whose continental operations represent a larger proportion of their total service.

JOINT CONTINENTAL AND OCEANIC COST EFFICIENCY: 2020

Indicator CO1: Cost per IFR hour (USD) (Formula: Total costs /IFR flight hours)

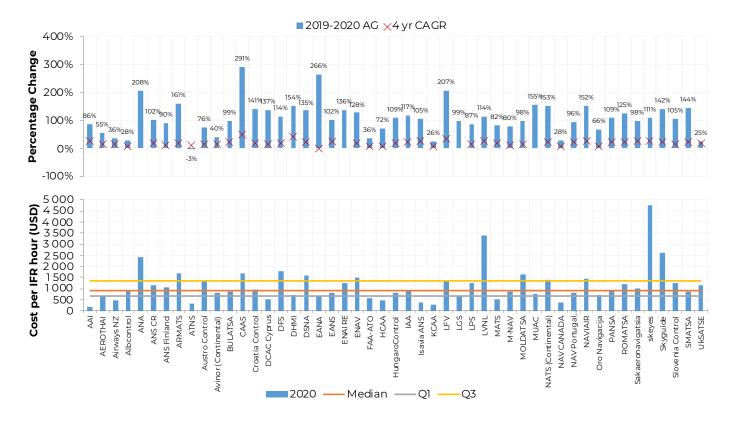


Figure 29 – Cost per IFR flight hour (USD)

The 2020 median cost per IFR flight hour is USD 895. The 2020 weighted average (taking into account total continental and oceanic IFR flight hours per ANSP) cost per IFR flight hour is USD 664. All ANSPs that submitted in 2020 did so in 2019; the 2019 median was USD 439 and weighted average was USD 421.

Indicator CO2D: Employment cost of ATCOs in OPS as a percentage of total costs

(Formula: ATCOs in OPS employment costs / Total costs)

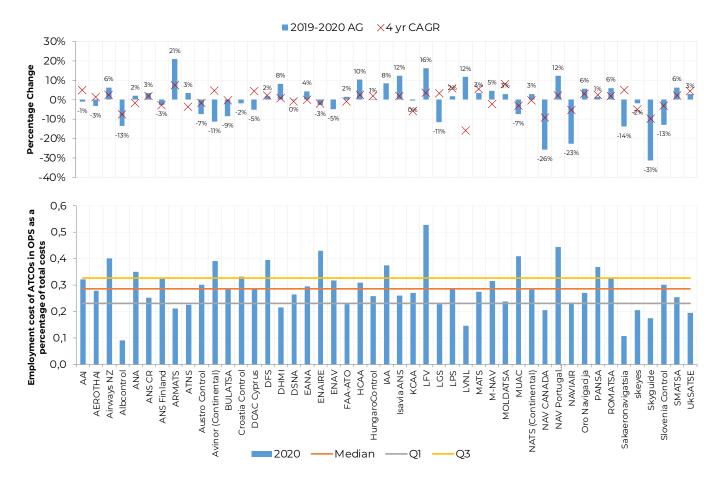


Figure 30 – Employment cost of ATCOs in OPS as a percentage of total cost

The 2020 median employment cost of ATCOs in OPS as a percentage of total costs is 29%. All ANSPs that submitted data in 2020 did so in 2019; the 2019 median was 28%.

SUMMARY OF PERFORMANCE TRENDS

KEY FINDINGS

- Cost efficiency and ATCO productivity were severely impacted with a sudden and unprecedented loss of traffic due to pandemic related travel restrictions;
- Accelerated increases in ATCO employment costs per ATCO hour compared to those recorded in the previous years and despite a reduction in overtime hours;
- Similarly to the total costs, costs excluding ATCO in OPS employment costs per IFR flight hour impacted with the drop of traffic.

As anticipated in last year's report, the COVID-19 pandemic significantly impacted ANSP performance and the 2020 data. A dramatic drop in IFR flight hours naturally worsened all the main indicators, with costs and ATCO hours not falling at a proportional rate, as ANSPs have been required to keep their airspace open during the pandemic, but with severely depleted traffic.

Analysis presented in the *Impact of COVID-19* on 2020 performance shows that ANSPs use different fiscal and reporting years. As a result, their data has been differently affected by the reduced traffic, local border policies and the timing of waves of the pandemic.

COST EFFICIENCY

In the case of total cost efficiency, almost all of the 52 ANSPs experienced an increase in cost per IFR flight hour, compared to 60% in 2019 and only 43% in 2018, when comparing the same set of ANSPs. The rate of traffic growth was completely lost in 2020, with combined IFR flight hours going from growth of 1.6% (2018-2019) to loss of 38.5% (2019-2020), when comparing the same set of ANSPs.

PRODUCTIVITY

98% of ANSPs saw a decrease in their ATCO productivity, compared to 60% experiencing an increase in productivity in 2019. When comparing the same set of ANSPs, the total number of continental and oceanic ATCO in OPS hours decreased by 15.3% (2019-2020), while total number of ATCO in OPS decreased by 1.5% (2019-2020).

FUTURE PERFORMANCE

In an industry that is today still experiencing the impacts of the COVID-19 pandemic, the challenge will be to recover ATCO productivity and cost efficiency in a sustainable manner by incorporating solutions that ensure ANSPs improve their resilience to future changes in traffic demand.

The year 2019 will be regularly referred to as a reference year for normal traffic levels. However, it must be kept in mind that, as shown in the last year's report, slowing traffic growth in 2019 resulted in a number of the key trends from previous years being reversed.

RELATED CANSO BENCHMARKING ACTIVITIES

CANSO conducts a variety of benchmarking exercises to examine developments in the industry. Combining these allow for a greater understanding of the current initiatives and trends occurring across the aviation industry, contextualising the ANS performance analysis within this report. The following input has kindly been provided by the CANSO Safety Intelligence Work Group (SIWG).

CANSO SAFETY INTELLIGENCE WORK GROUP

The CANSO SIWG champions safety measurement and continuous improvement of safety performance. Consisting of representatives from ANSPs across the globe, this group works to analyse, advise, and advance safety performance measurement, and reports to the global¹¹ CANSO Safety Forum.

SAFETY PERFORMANCE

Safety is critical for the trust and confidence of the flying public. As a result, CANSO measures key safety performance indicators to contribute to improvements in safety and efficiency of air traffic control. When productivity and cost efficiency are measured, it becomes crucial to measure safety benchmarks, which rely on the interdependencies these three facets represent. Improvements in productivity and cost efficiency should never come at the cost of reduced safety.

Safety and safety performance are measured in several ways, both through proactive indicators of the CANSO Standard of Excellence (SoE) in Safety Management Systems (SMS) and event-based indicators of loss of separation and runway incursions.

This ensures that globally, ATM stakeholders understand how today safety performance drives tomorrow's improvements – inspiring CANSO members to be future-focussed.

After a hiatus due to the COVID-19 pandemic, data submission was re-established in 2021 for the data captured in calendar year 2020.

Note: Results from the CANSO Standard of Excellence in Safety Management Systems have been omitted from this report. In the spirit of collaboration, the SMS Maturity results should not be used to showcase performance in an external setting. The assessment is meant to drive internal efforts to improve areas of an ANSP's SMS that are found to be lacking, as well as to encourage the adoption of worldleading practices. Any comparison with other ANSPs should be made for this purpose only. Unfortunately, a small number of ANSPs have extended the use of the results outside of this intended scope. Through productive discussions we are hopeful these challenges will be corrected, and results can be provided in the next edition.

ATM GROUND IFR-IFR LOSSES OF SEPARATION¹²

A loss of separation is a key performance indicator for assuring compliance with applicable separation standards. This measure focuses on IFR-IFR losses (both aircraft flying under instrument flight rules).

There are multiple measures for safety performance, CANSO has prioritised this measure over others as a benchmark based on the risk profiling around potential loss of life.

For 2020, 19 ANSPs submitted data on the loss of separation rates. The annual rate for these ANSPs was 59.61 IFR-IFR losses of separation per 1 million IFR flight hours and 2.50 per 100,000 IFR flights.

¹¹ In the context of this report, "global" means the "participating ANSPs".

¹² ATM Ground IFR-IFR Losses of Separation is a specific term that implies a loss of separation where the ANSP (its systems, personnel actions, processes, etc.) had a level of contribution, either direct or indirect, to the sequence of events leading up to, or recovering from, the occurrence.

There were no reported losses considered as high severity in the Risk Analysis Took (RAT) classification scheme¹³ (which differs from the ICAO runway incursion severity classification). The RAT severity classification describes the level of consequences of hazards on the safety of flight operations. It combines the level of loss of separation and the degree of ability to recover from a hazardous situation. The overall severity of one occurrence is composed of risk of collision/proximity (separation and rate of closure) and the degree of controllability over the incident.

From the diagram below, 67% of the IFR-IFR losses of separation had the lowest RAT severity (E). 49% of losses occurred in Terminal environment and 35% in en-Route. The remaining 17% were not provided for analysis.

Count of ATM Ground IFR-IFR LOS by RAT Severity Classification

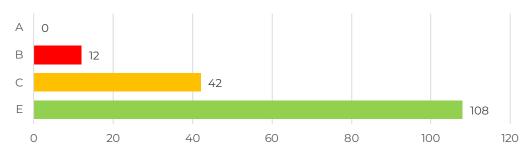


Figure 31 - ATM Ground IFR-IFR LOS by RAT Severity Classification in 2020

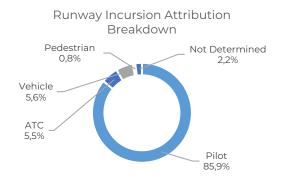
RUNWAY INCURSIONS

A high proportion of safety events take place around the vicinity of an airport's runway(s). Again, there are multiple measurements for safety around an aerodrome. Here, CANSO has selected to measure runway incursions due to the increased likelihood that an ANSP may have contributed to the event.

In 2020, the rate of runway incursions for the ANSPs who submitted data was 5.37 RIs per 100,000 runway movements (one runway incursion for approx. every 19,000 take offs and landings). The rate of ATC-Attributed runway incursions was 0.90.

Below are graphs summarising the attribution (the primary causal element) and severity (based on ICAO classification scheme) for these events. It is worth noting that most runway incursions were attributed to pilot deviation. No explanatory details are available for analysis which opens opportunities for further collaboration across industry partners.

Events assessed at ICAO runway incursion severities A and B contribute about 3% of all runway incursions regardless of attribution.



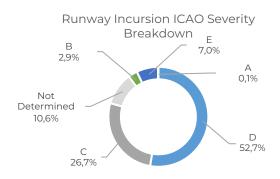


Figure 32 – Runway Incursion Attribution and ICAO Severity Breakdown

In terms of weather and lighting conditions, 61% occurred in visual meteorological conditions, and 62% in day-light conditions respectively.

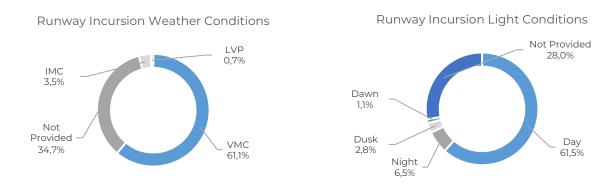


Figure 33 – Runway Incursion Weather and Light Conditions

The details of the ICAO Severity Classification Scheme are below.

Severity classification	Description*
Α	A serious incident in which a collision is narrowly avoided.
В	An incident in which separation decreases and there is significant potential for collision, which may result in a time-critical corrective/evasive response to avoid a collision.
С	An incident characterized by ample time and/or distance to avoid a collision.
D	An incident that meets the definition of runway incursion such as the incorrect presence of a single vehicle, person or aircraft on the protected area of a surface designated for the landing and take-off of aircraft but with no immediate safety consequences.
E	Insufficient information or inconclusive or conflicting evidence precludes a severity assessment.

ANNEX 1: METHODOLOGY

MEASURING PERFORMANCE

Cost efficiency and productivity are two key indicators of measuring the performance of air navigation service provision. They demonstrate how ANSPs are delivering value and serve as indicators of operational efficiency.

These KPIs are all part of the CANSO ANS Performance Framework.

COST EFFICIENCY

Cost efficiency provides an indication of the balance between operational effectiveness (i.e. ATCO productivity) and the cost of providing the service.

The simplest indicator of cost efficiency is the cost of providing **ANS services per IFR flight hour**. A lower cost per flight hour, however, is not necessarily indicative of greater overall performance.

Economic differences outside of the control of ANSPs can drive differences in costs. This includes labour contracts, salary scales and working conditions (such as hours), as well as government regulations on pension management and mandatory financial controls. Furthermore, ANSPs do not control the volume of traffic, which is a function of economic activity and other air passenger demands. Where a minimum level of service is required, there is a limit to how activities can be scaled down in response to lower demand. This was particularly evident in 2020, the year considered in this report.

Cost indicators do not reflect external factors, other performance areas or the quality of service. Moreover, there are costs associated with providing a safer and more punctual, predictable, and efficient service, which can deliver savings to air operators flying in the airspace that offset higher ANSP costs. Costs are broken down into ATCOs in OPS employment and other costs. Other costs include operating costs (excluding ATCO in OPS employment costs), depreciation/amortisation and costs of capital related to providing ATC/ATFM services. They do not include MET costs.

PRODUCTIVITY

The key indicator of ANS productivity is IFR flight hours per ATCO in OPS hour, often described as 'ATCO in OPS productivity'. Although generally reflective of ANSPs' performance, factors beyond the control of the ANSP can cause low levels of productivity – for example a geopolitical event that alters traffic demand.

ATCO in OPS productivity is driven by traffic levels and an ANSP's ability to utilise its ATCOs in operations (OPS) resources. Although they cannot affect traffic demand, ANSPs may improve productivity by utilising flexible rostering and adapting airspace configuration to open and close sectors according to evolving traffic patterns.

Furthermore, advances in technology are now focusing more than ever on reducing the workload of ATCOs in OPS to enable them to safely manage higher levels of traffic in a given volume of airspace. Training associated with the introduction of technology, however, can lead to short-term reductions in productivity.

Airspace complexity also affects ATCO in OPS productivity. Lower airspace will typically have lower levels of ATCO in OPS productivity than upper airspace where aircraft are flying at more consistent altitudes and on noncrossing routes. Therefore, an ANSP operating a high proportion of sectors in lower airspace, or with numerous busy airports with complex approach sectors, is likely to have lower ATCO in OPS productivity than an ANSP with more overflights at higher altitude.

DATA PROCESSING

Data collection:

ANSPs who are members of the CANSO GBWG provided data for this analysis. ANSPs either submit the minimum dataset required for participation in the report (the basic data), or additional data to inform the analysis of advanced KPIs (the advanced data). ANSPs can also revise data submitted in previous years. The data submission workbook includes validation calculations that ANSPs are encouraged to consult in the data collection phase.

The entire dataset is available to all participating ANSPs to enable closer analysis and evaluation of performance trends.

The advanced KPI dataset is only available to ANSPs submitting advanced data.

2020 performance data for European ANSPs has been kindly provided by EUROCONTROL, alongside data for the years 2016 – 2019 to facilitate historical trends analysis, which are completed with the extended set of ANSPs to ensure validity of any trend analysis. European ANSP members of the CANSO GBWG, who also submit data to EUROCONTROL have their ACE data used in this analysis, unless otherwise agreed.

It should be noted that Indicator 2B 'ATCO productivity' is not directly comparable to the ATCO productivity KPI used in the ACE report. This is because the CANSO ANS Performance Framework uses IFR flight hours to calculate this KPI, rather than composite flight hours as used in the ACE report ATCO productivity KPI.

Finally, as part of the data sharing agreement with EUROCONTROL, CANSO data is only available to the core EUROCONTROL analysts and is not shared with the wider ACE report ANSP community.

Data Dashboard:

As part of the CANSO 2016-2020 data collection cycle, a PowerBI dashboard was produced in November 2021, which allowed CANSO members a first look at trends in their data. This dashboard, and accompanying underlying data document provided members the opportunity to thoroughly review and validate their data submission, and notify Egis of any amendments if necessary.

Data processing:

Data has been processed by Egis subject to a data processing agreement with CANSO and in accordance with European data privacy laws. It was subject to a one-step quality check for significant changes, potential errors or omissions and is subject to continued revision by participating ANSPs.

Separation of continental and oceanic data:

Information is provided both for continental and oceanic air navigation services, where applicable. Each of these environments has different challenges associated with providing ANS. For example, it is more straightforward to provide ground infrastructure for communications and surveillance services in continental airspace than it is over oceans.

Exchange rate conversion:

ANSPs submit data in their chosen currency. For KPI comparison, data is presented in USD. 2020 KPI data is converted using exchange rates provided by each ANSP or using data available from the Organisation for Economic Co-operation and Development (OECD) website. Exchange rates for some countries are unavailable using OECD; International Monetary Fund (IMF) exchange rates have been used in such situations.

For ANSPs that operate in a currency other than the USD, the assumption of lower cost may be caused in part by the strengthening USD. Between 2015 and 2016, the USD appreciated against most other world currencies, meaning each USD buys more foreign currency. Despite a dip in 2017, the USD once again strengthened in 2018. This change in the relative value of the dollar effectively lowers the price that ANSPs incur in USD.

Growth rates:

Data is presented from 2020 and then for the one-year and four-year trends. The trend over four years is calculated as the compound annual growth rate (4 yr. CAGR). This shows the overall trend between 2016 and 2020, but masks the fluctuations that may have taken place over the intervening years. In addition, if 2016 was an outlier, this trend may not be representative of the trend over this timeframe. Individual ANSP results for 4 yr. CAGR should therefore be interpreted alongside contextual information.

The trend analysis is presented above the 2020 KPI data and is based on the data submitted in the ANSP's chosen currency.

Inflation:

The growth rates are not adjusted for inflation, and local inflation rates should therefore be considered when interpreting AGR trends. PPP correction: Salaries and the cost of living vary extensively around the world. One way to correct for this is by using purchasing power parity (PPP). Employment costs for ATCOs in OPS are corrected using IMF data. There are, of course, limitations to this approach, as the cost of living can vary widely within a country and may be higher or lower in the region where ANS offices are located.

Median:

The median is the middle number of the data set.

Q1 and Q3:

The first quartile (Q1) is defined as the middle number between the smallest number and the median of the data set. The third quartile (Q3) is the middle value between the median and the highest value of the data set.

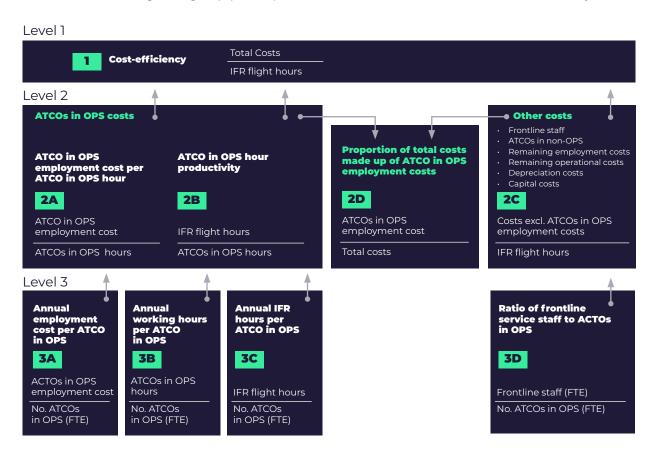


Figure 35 – CANSO ANS performance framework

The detailed metrics for determining the cost efficiency and productivity of continental and oceanic air navigation services are set out in Figure 35. These performance indicators are derived from the CANSO ANS Performance Framework.

DETERMINING PERFORMANCE METRICS

The CANSO ANS Performance Framework was established to create common performance indicators for global ANS data. Based on a tiered structure, the framework was developed in 2014 by the CANSO Global Benchmarking Workgroup (GBWG). It aims to demonstrate the drivers of cost efficiency.

Over the years, the GBWG has worked to identify alternative KPIs to investigate the drivers of the KPIs in the framework, in particular KPI 2C. In 2020, KPI 3D was added to framework to better understand the proportion of 'frontline service support staff' to ATCO in OPS in an ANSP.

It is important to note the dependence of the higher tier metrics on the lower tier. This can be established as follows:
