CANSO was founded in 1996 as more of the world's air navigation service providers separated from their regulatory authorities.



# Through Advocacy

CANSO is an official Observer to the ICAO Council and to the Air Navigation Commission (ANC). Participation in ICAO panels enables CANSO to influence regulatory matters that affect our members. We represent the views of the industry in critical discussions on global standardisation and bring specialist knowledge and expertise to ICAO work programmes.

In turn, CANSO provides ICAO and the aviation industry with specialist knowledge and expertise and the constant level of cooperation required to harmonise global ATM.

CANSO is also a member of the NATO Aviation Committee, the senior civil-military NATO body, which advises the North Atlantic Council. NATO's principal political decision-making body, on aviation matters.

### **INDUSTRY PARTNERS**

To provide a strong aviation industry voice, both within ICAO and beyond, CANSO actively collaborates across the industry. Through regular liaison we provide an ATM view on common positions for industry issues and are able to represent that consensus with a strong united industry voice.

### SAFETY STANDING COMMITTEE (SSC) PROGRAMME

## OPERATIONS STANDING COMMITTEE (OSC) PROGRAMME

### ASBU IMPLEMENTATION TRAINING

The comprehensive training programme Methodology and Best Practices for ASBU Implementation has been designed to provide members of the global aviation community with a common understanding of the ICAO Aviation System Block Upgrades methodology. The course is indispensable for those involved in ATM systems planning and modernisation programmes, and provides insight into key implementation issues such as how to identify gaps between current ATM and ASBU capabilities; and how to develop a business case to support investment decisions.

# AIRPORT SYSTEM CAPACITY ENHANCEMENT PROGRAMME (ASCE)

The ASCE is a new collaboration between CANSO and ACI World designed to support ANSPs and Airports in meeting the capacity challenge of airports as traffic levels increase, ensuring that capital investment plans are structured to support the accelerated delivery of improvements.

Under the programme, CANSO and ACI will bring together experts from both ANSPs and Airports to conduct a review of a specific airport ecosystem to identify any opportunities to enhance and optimise the usage of the available ground and airspace capacity.

After the peer review, CANSO and ACI will connect the ANSP or airport operator to experts to help implement any recommended changes.

### **MICRO-TRAINING COURSES**

CANSO and INFINA are partnering to offer micro-learning courses to the aviation community worldwide.

The micro-learning courses are based on ICAO standards, and industry instructutional design standards and best practices. The micro-learning courses have been successfully used by ATC managers, supervisors and controllers, and by technical operations personnel across the USA who engineer, install, and maintain communications, navigation, and surveillance (CNS) technology for the aviation sector.

The courseware is designed to be delivered on multiple platforms and is suitable for online - live-streaming, video, PowerPoint, gaming technology - and in-person classroom style delivery.
