Brussels, 23 February 2023 – Today CANSO Europe's EC3 (CEO Committee) met for the first time with the new Director-General of EUROCONTROL, Raúl Medina, at the CANSO Europe office in Brussels. The meeting provided the opportunity to discuss key issues facing the air traffic management (ATM) industry at an important time as traffic levels recover towards pre-COVID levels.
