#### Introduction

CANSO – the Civil Air Navigation Services Organisation – is the global trade association for the companies/organisations that provide air traffic control and associated services and suppliers to the industry. CANSO Members support almost 90% of world air traffic. Members share information and develop new policies, with the ultimate aim of improving air navigation services (ANS) on the ground and in the air. CANSO represents its Members' views to a wide range of aviation stakeholders, including the International Civil Aviation Organization (ICAO), where it has official Observer status. CANSO has an extensive network of Associate Members drawn from across the aviation industry.

#### **Purpose of Job**

The Senior Manager CNS/ATM Technical Affairs is responsible for representing CANSO at the Air Navigation Commission and other CNS/ATM technical/operations activities at the International Civil Aviation Organization (ICAO) and for liaison on these matters with other industry stakeholders. The Senior Manager CNS/ATM Technical Affairs will work to advance the goals and objectives of CANSO and the global ATM community.

## **Reporting Relationship and Logistics**

The position reports to the Permanent Representative to ICAO and Head of Montreal Office in the execution of the role.

The position is based in Montreal, Canada, and the successful candidate must be legally able to work in Canada. Some international travel to conferences/ events/ meetings will be required for this role. The position is full time (40 hrs / week) with some flexibility for hybrid/remote work. CANSO's working language is English.



### **Key Duties & Responsibilities**

- Serve as the CANSO official observer to the ICAO Air Navigation Commission (ANC) and provide expert technical advice and guidance on all matters related to air navigation.
- Contribute to the development and implementation of international standards and recommended practices for air navigation (SARPs), in accordance with the organisation's vision of future skies and identified advocacy priorities.
- Work closely with CANSO's Members, workgroups, and industry partners to ensure comprehensive representation across all matters. Ensure that our members' positions and interests are fully considered in advancing key workplan items and developing SARPs. Maintain a strong focus on innovation, acting as a champion for its application in ATM/CNS and its appropriate consideration at ICAO and across CANSO's workgroups.
- As directed by the CANSO Permanent Representative to ICAO, coordinate CANSO representation in assigned ICAO panels and workgroups representing the ATM industry.
  - Draft working papers for Assemblies and High-Level meetings as needed.
- In coordination with CANSO Permanent Representative to ICAO, formulate CANSO positions on issues relating to technical rulemaking and policy guidance.
- Coordinate with other CANSO working groups and aviation industry stakeholders on the development and refinement of positions and coordination of advocacy activities.
- Contribute to excellent relations with ICAO Secretariat staff, resident State delegations, and observers of international organisations with the aim of securing alignment with CANSO positions.
- Support CANSO's global programmes by actively participating in and contributing to workgroups meetings, conferences, and support Programme Managers and Regional Directors.
- Build and maintain relationships with CANSO Members through appropriate means of communications and support their requests that are in line with the objectives and resources available.

- Fluency in English, with knowledge of other languages being an asset.
