Foreword

With many regions of the world today well along the path to full traffic recovery from the COVID-19 pandemic, this report reflects on a time when we were in the midst of those challenges.

In 2022, countries steadily lifted travel constraints, while the global economy continued to confront significant hurdles. The resurgence of COVID-19 in specific regions triggered successive lockdowns. Additionally, the war in Ukraine disrupted global financial markets and increased debt levels. Throughout 2022, there was a notable upswing in global air passenger traffic as travel restrictions were lifted. Industry-wide, the demand for passenger seats was met by available seat capacity, with available seat kilometres (ASKs) recovering to 71.9 per cent of the 2019 levels.

While grappling with capacity challenges driven by growth, lessons from COVID-19 emphasise the need for insights into ANSP performance. To provide evidence and build a comprehensive picture of how Air Navigation Service Providers (ANSPs) were performing before, during, and after the pandemic, data is essential. This is where the work of the CANSO Global Benchmarking Workgroup (GBWG) proves invaluable.

This year, CANSO delivers the fourteenth edition of the *Global Air Navigation Services Performance Report*, which now includes 47 ANSPs from all across the globe. The report is a key output of the work of the GBWG and acts as a tool for ANSPs to compare, contrast and identify good practices and best efforts in ANS performance, particularly in the areas of cost efficiency and productivity, which were severely impacted by the decline in traffic.

In this edition, we look back on the performance in 2022, how participating ANSPs were being affected by global events, and how it reflects in our key performance metrics.

I would like to thank the CANSO GBWG and all the participating CANSO members. I also thank EUROCONTROL for their support in increasing the scope, scale, and utility of our report. In addition, I would like to thank Egis for twelve years' of effort in data collection and analysis, and their continued dedication in supporting CANSO and the GBWG with this work.

Executive Summary

Coverage

The CANSO Global Air Navigation Services (ANS)
Performance Report is produced annually by
CANSO's Global Benchmarking Workgroup (GBWG)
with the support of Egis. Through agreement with
EUROCONTROL's Performance Review Unit (PRU), data
regarding European Air Navigation Service Providers
(ANSPs) taken from the ATM Cost-Effectiveness (ACE)
Benchmarking Report has been included. ACE Report
data collected by the PRU since 2002 is available in the
ACE dashboard.

This year's report provides data for 47 ANSPs and contains performance indicators for the year 2022, along with trend data between 2018 and 2022. For a credible comparison of performance, the ANSPs that shared their data with CANSO were divided into three comparator groups based on the number of IFR hours managed, ensuring that the analysis takes into account the varying scales and complexities of their operations.

In line with CANSO's ambitions for the Global ANS
Performance Report to reflect a broader picture of
performance, data provided by the CANSO Safety
Intelligence Workgroup (SIWG) examining key safety
metrics in 2022 has been included. Collaboration between
CANSO workgroups aim to enable interdependencies
between data to be analysed and ultimately drive better
insights into the reasons behind performance trends.

Pandemic Recovery, and Their Impact on Key Performance Indicators

Analysis of how the ATM system performed during its recovery is complex, however, maintaining service and preserving safety remains a top priority for ANSPs. Following the removal of travel restrictions in 2022, demand surged across many markets.

As the COVID-19 pandemic influenced numerous short-term policy decisions over the past three years, the global economy faces several other challenges.

Ongoing issues such as the war in Ukraine and a potential economic slowdown in major economies pose risks that could hinder the pandemic recovery. A key manifestation of these risks is the notable rise in inflation across many economies. The interaction between geopolitical conflicts and increasing prices is a significant economic threat. Aviation is closely tied to such macroeconomic factors; like other goods and services, air transport demand is influenced by price levels and disposable income. Therefore, uncertainty about a swift recovery for the aviation industry remains prevalent, particularly in the near term.

The year 2022 witnessed a partial recovery in the ATM system, with air traffic volumes rebounding as travel restrictions were lifted. Continental IFR hours increased by nearly 19 per cent, and oceanic IFR hours surged by over 40 per cent. This significant growth in traffic reflects a notable resurgence in demand for air travel, indicating progress towards pre-crisis operational levels, though a full recovery has not yet been achieved.

Despite the increase in traffic, ANSPs faced rising operational costs driven by inflation and the need to adapt to post-pandemic conditions. Such cost increases were largely influenced by factors such as higher fuel prices, increased labour costs, and the implementation of enhanced health and safety measures, all essential for managing the renewed traffic volumes and maintaining safety standards.

The increase in IFR hours has helped reduce the overall cost per IFR hour, particularly in oceanic airspace. The average decrease in cost per IFR hour is about 23 per cent for continental airspace and about 41 per cent for oceanic airspace. However, an upward trend in the total cost per IFR hour was observed for six ANSPs providing continental navigation services. A similar situation was noted for the costs excluding ATCO costs in OPS per IFR hour.

The operational efficiency of air traffic controllers also showed significant improvement. Hourly productivity for ATCOs in continental airspace increased by an average of 32 per cent, while ANSPs in oceanic airspace saw annual productivity gains of up to 64 per cent. Compared to the 30 per cent decrease in 2020-2021, this represents the largest year-over-year percentage change across all KPIs. Despite overall improvements, some ANSPs in both airspace segments experienced declines in ATCO productivity.

Amid the ongoing challenges of recovering from the COVID-19 pandemic, ANSPs have demonstrated a notable ability to quickly adapt to post-pandemic conditions while striving to return to pre-pandemic trends in operational efficiency.

It is important to note that the reporting periods for ANSPs submitting data to CANSO vary. Some include data within the 2021 calendar year, some for the 2022 calendar year and others include some of 2023. The PRU data for European ANSPs aligns with the 2022 calendar year. The impact of the reporting period is still notable in this year's report due to the pandemic restrictions and their lifting. To highlight this, the graphs representing the KPIs are ordered and colour-coded by the reporting period. The reporting periods span from April 2021 to June 2023.

Key findings of the report¹

Cost Efficiency (Indicator 1)

Continental and oceanic cost efficiency improves amidst a growth in traffic



With an overall increase in IFR traffic the KPI1 total cost per IFR flight hour in continental airspace decreased by 23 per cent compared to 2021. Compared to the year 2020, at the peak of the pandemic, the total cost per IFR hour in 2022 was 37 per cent lower.

The decrease in the global average of KPI 1 in oceanic airspace was driven by an increase in oceanic IFR flight hours, with the most significant growth coming from Isavia ANS and Airways NZ. Notably, Airways NZ reported an increase in oceanic flight hours exceeding 100 per cent.

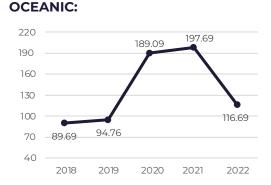
When examining the fiscal years, most ANSPs with oceanic airspace (although there are few) do not align with the calendar year 2022. Instead, their reporting periods primarily cover the last third of 2021. The end of 2021 and the beginning of 2022 were significant due to the easing of international restrictions, which likely contributed to increased air traffic, particularly intercontinental flights. This shift probably had a substantial impact on the data for ANSPs in oceanic airspace compared to those in the continental airspace. Additionally, a gradual increase in IFR hours was observed over the course of the reporting periods.

The air transport sector is still recovering from the pandemic crisis, causing a fluctuation in operational and financial performance, especially in the oceanic airspace due to slower bounce-back in intercontinental traffic levels due to prolonged border shut-down and associated health and safety measures.

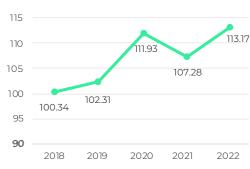

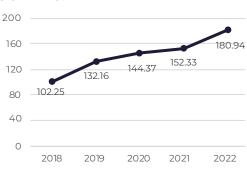

Average KPI values - Employment cost per ATCO hour (USD) (2018-2022):



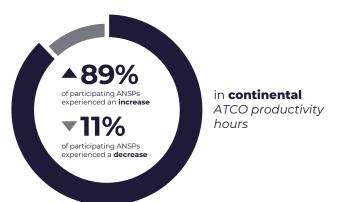


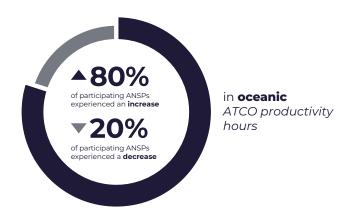

Productivity soared for both continental and oceanic ANSPs, with oceanic ANSPs rebounding significantly after last year's setback





The increase in global average KPI 2B ATCO productivity in both oceanic and continental airspace was primarily driven by a rise in IFR flight hours, which increased across the majority of participating ANSPs during the reporting period. Since KPI 2B is directly derived from IFR flight hours, this led to a significant boost in ATCO productivity, in oceanic airspace surpassing the levels observed prior to the pandemic.

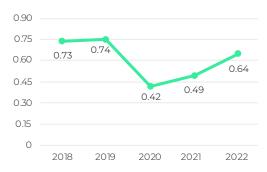

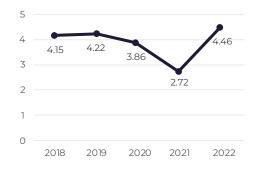

Other costs per IFR flight hour (Indicator 2C) Continental & oceanic costs show signs of returning to pre-pandemic levels



Most ANSPs in continental airspace saw a decrease in KPI 2C (other costs per IFR flight hour), largely due to an increase in IFR hours. However, six ANSPs reported an increase in this KPI, mainly attributed to a significant rise in other costs. Notably, DHMI and KCAA experienced increases in these costs exceeding 100 per cent.

Other costs per IFR flight hour in oceanic airspace decreased for all the ANSPs, driven by an increase in IFR hours.

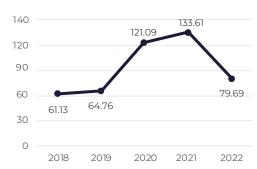

Introduction

Comparing ANSP Performance

Air navigation service providers (ANSPs) are responsible for managing global air traffic safely, efficiently, and cost-effectively. This includes managing and enhancing airspace capacity through improvements to infrastructure and technology, improving efficiency through a skilled and productive workforce, and an innovative approach to airspace management.

The performance of the air navigation system impacts stakeholders throughout the aviation ecosystem. From boosting connectivity and minimising delays to upholding the highest standards of safety in aviation, efficient and effective air navigation services are a critical component of a high-performance aviation industry. To that end, CANSO has devised benchmarking exercises that aggregate and review global performance accordingly.

Comparing and benchmarking key financial and productivity indicators enables ANSPs to make informed decisions when pursuing increased cost-effectiveness and productivity, without impacting safety – the industry's top priority. The understanding gained from benchmarking helps ANSPs to work together to address both their own performance and that of the Air Traffic Management (ATM) industry worldwide. The annual CANSO *Global ANS Performance Report* has served to highlight global performance trends for over 13 years.

Measuring Cost Efficiency and Productivity

Cost-efficiency and productivity are two key performance indicators of air navigation services that enable this monitoring of performance. They demonstrate how ANSPs are delivering value and serve as indicators of operational efficiency. The CANSO ANS Performance Framework identifies the factors that determine cost efficiency and productivity, including employment costs, hours worked and other costs, and is used to create a clear, common model for understanding global ANS performance.

Global Air Navigation Services Performance Report

This year's *Global Air Navigation Services Performance Report* contains performance indicators for identified ANSPs for the year 2022, along with trend data between 2018 and 2022.

ANSPs submitting to CANSO have also provided contextual comments, including any exceptional events during the year or items that may impact the comparability of their data. Additional comments on important events are included within the contextual data, providing insight into the results of the participating ANSPs.

The detailed results for each ANSP can be found in the CANSO Global Benchmarking Workgroup Performance Dashboard, which is available to participating GBWG members.

Incorporation of PRU data

A key objective for CANSO and the members of CANSO's GBWG is to continue to increase the global coverage of the data included in the annual Performance Report. To support this, started in 2013, CANSO, with the agreement of EUROCONTROL, has incorporated public data collected by EUROCONTROL's Performance Review Unit (PRU) to complete the representation of European ANSPs in the dataset.

It should be noted that while the raw data extracted from the ACE Report is directly comparable, the final KPIs expressed in the CANSO report are not directly comparable to those reported in the ACE report.

Primarily, this is because the KPIs use different inputs. In particular, the CANSO report uses Instrument Flight Rules (IFR) flight hours and extracts "total flight hours controlled by the ANSP" as a comparable data point from the ACE dataset, while the ACE Report uses "composite flight hours". These comparable data points were validated as part of a comparison exercise undertaken by Egis, which was presented in 2020.

Differences in indicators between the two reports go beyond the use of a different flight hour measurement. Two key examples are highlighted below:

- CANSO's Performance Report converts all cost data into USD instead of EUR.
- CANSO's Performance Report primarily uses
 the World Bank as a source for exchange rate,
 inflation rate and purchasing power parity (PPP)
 information, whereas EUROCONTROL's ACE Report
 uses a combination of EUROSTAT and (International
 Monetary Fund) IMF data.

European GBWG members have been allowed to request, with justification, to use the GBWG submission for this benchmarking exercise. For further details please see *Global Air Navigation Services Performance Report 2018-2022: Participation*.

Post-Pandemic Recovery

The traffic increases but ANSPs carry the financial debt over

The aviation industry has demonstrated a rapid recovery, with global air transport capacity, seat availability, and passenger numbers now reaching 80 per cent of pre-pandemic levels, according to ICAO analysis. In 2022, the total number of passengers worldwide surpassed 6.6 billion, accounting for 72.5 per cent of pre-pandemic figures. Additionally, global aircraft movements have recovered to 82.4 per cent of pre-pandemic levels³.

This report primarily focuses on performance data from 2022. However, the reporting periods of member organisations vary, with some ANSPs covering the second half of 2021 or extending into the first quarter of 2023. As a result, certain data sets include parts of 2021, others encompass 2022, and some even extend into 2023. ANSPs reporting data from 2022 and 2023 have shown significant recovery, while those incorporating data from 2021 and early 2022 have exhibited less improvement. Consequently, the impact of the COVID-19 pandemic has not been uniformly reflected across all ANSPs due to these differing reporting periods.

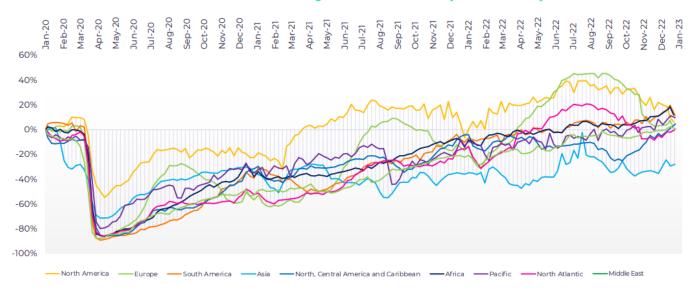


Figure 1 - Percentage change in aircraft movements by region, from Jan 2020 towards Jan 2023. Taken from CANSO ATM Traffic Analysis Report (December 2022)

Figure 1 illustrates that aircraft movements during 2022 generally remained above those of 2021, with traffic more than doubling compared to the first half of 2021, which was still affected by COVID-19 restrictions. Throughout 2022, many nations relaxed travel restrictions. Consequently, the number of air passengers continued to rise globally, nearing levels seen before the pandemic. Globally, full year 2022 traffic was at 68.5 per cent of pre-pandemic (2019) levels. Aircraft movements increased by 14.8 per cent in 2022. The post pandemic high remains July 2022, when 244,000 flight hours were operated globally.

The 2022 summer season brought about a period of increased travel demand for North America and Europe as a result of relaxed restrictions. The gradual reopening of global travel markets was aided by vaccine distribution and findings indicating the limited effectiveness of travel restrictions in managing COVID-19. In 2022, the relaxation of travel policies notably enhanced international passenger

traffic, especially in the Asia-Pacific region, which experienced the slowest recovery in traffic growth in both 2021 and 2022⁵.

Several regions experienced a reduction in air traffic in January, with Europe and the North Atlantic witnessing the most significant declines. In Europe, daily flights dropped by over 4,000 in late January compared to late December, while the North Atlantic saw a decrease of 300 flights per day during the same period. Traffic levels in North America remained strong. Asia, which remains the most significantly impacted region, continued to see slight gains in air traffic.

The war in Ukraine had a great influence on the global aviation industry. It has resulted not only in closed airspace over Ukraine but also in the cancellation of many flights to or from Russia and the restricted use of Russian airspace. Rising inflation from the ongoing situation has driven up the costs for ANSPs, including higher salaries.

As 2022 unfolded, travel restrictions were lifted, and global economies showed signs of recovery following the end of COVID-19 policies, along with the removal of most testing requirements for international travellers. These developments have driven a surge in global air traffic demand, leading to a recovery in air passenger volumes. These advancements boosted global air traffic demand. The strong recovery in air passenger demand has resulted in 2022 passenger numbers reaching an estimated 74 per cent of pre-pandemic levels⁶.

Impact of COVID-19 and varied reporting periods

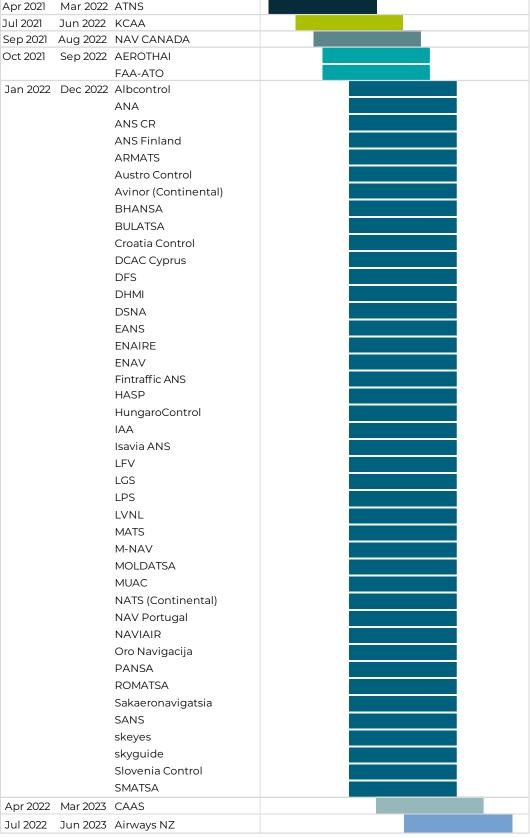


Figure 2 - Reporting Periods

Figure 2 illustrates, the reporting periods for the ANSPs submitting to CANSO differ, with some ANSPs submitting data within the 2021 calendar year, and some reporting periods ending in 2023; European ANSPs submit data spanning the full 2022 calendar year.

Some trends displayed by ANSPs reporting data for 2021 and the beginning of 2022 will therefore be mostly affected by the lifting of pandemic restrictions and the implementation of health and safety measures. Trends reflecting costs incurred in 2022 will be impacted by increased inflation⁷ due to the war in Ukraine. The most significant differences are expected to occur between ATNS, KCAA, NAV CANADA, AEROTHAI, and FAA-ATO, whose reporting periods started in 2021, and CAAS and Airways NZ, which reporting periods started later in 2022 and ended in 2023. Consideration should be made towards this, and thus, the KPI graphs have been ordered by the reporting period, with the earliest month being April 2021 for ATNS, and the latest reporting period by Airways NZ in June 2023.

Whilst the majority of the submitting ANSPs have reporting periods during 2022, anomalous KPIs may be indicative of the varying reporting period. For instance, in terms of Oceanic data the majority of Oceanic ANSPs have financial years that are not aligned with the calendar year 2022 but include a significant portion of data captured in the year 2021. Therefore, the data has more impact on the Oceanic ANSPs than the Continental ANSPs.

Operational Performance

The CANSO GBWG commenced collecting data on operational performance metrics in 2023 to explore the possibility of expanding the list of metrics currently monitored. At the 38th GBWG meeting in Ottawa in February 2024, several new metric proposals were reviewed. However, data completeness remains a significant challenge, as not all participating ANSPs have submitted data. To assess operational performance ANSPs were asked to submit data for 3 operational KPIs as a trial.

For trial operational KPIs, only seven ANSPs submitted data for all three KPIs.

Only seven ANSPs submitted data for all three operational trial KPIs. This indicates that the flights are, on average, deviating slightly from their planned routes, potentially due to factors such as weather conditions, or airspace restrictions.

DSNA monitors all three trial operational KPIs. The KEP value i.e. Horizontal flight efficiency of the planned route indicates that the planned routes are 5.68 per cent less efficient than the optimal (Great Circle) distance; the routes planned by the airline or flight planners are, on average, 5.68 per cent longer than the shortest possible path. The KPI 1 value of -2.40 per cent indicates that the actual en-route distance flown is shorter than the planned routes by 2.40 per cent.

ENAIRE monitors all three-trial operational KPIs with a KPI 1 the actual en-route distance flown versus the planned route distance is 0.741 per cent.

HungaroControl monitors all three trial operational KPIs with a KPI1 the actual en-route distance flown versus the planned route distance is 99.2 per cent. HungaroControl reported a higher value than the other ANSPs that submitted data. HungaroControl KEA value deteriorated mainly due to traffic flow changes resulting from the closure of Ukraine - invasion airspace.

NAV Portugal monitors all three trial operational KPIs. For KPI 1, the actual en-route distance flown versus the planned route distance is 1.52 per cent.

PANSA monitors all three trial operational KPIs. For KPI 1, the actual en-route distance flown versus the planned route distance is 4.79 per cent.

The Global Benchmarking Workgroup will continue to assess operational performance and encourage greater participation through submission of data.

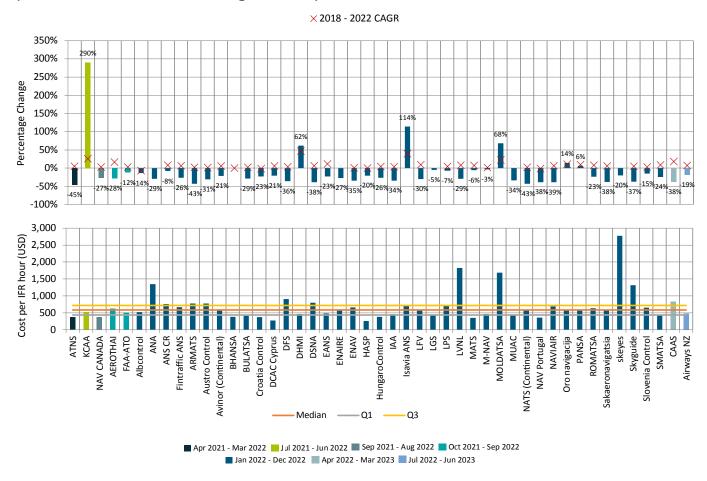


Figure 3 - Cost per IFR flight hour (USD)

The 2022 median cost per IFR flight hour was USD 584. The 2022 weighted average (taking into account total continental IFR flight hours per ANSP cost per IFR flight hour was USD 681. For comparison, the 2021 median for the same set of ANSPs was USD 721 per IFR hour, with a weighted average of USD 880 per IFR hour.

In terms of total costs in continental airspace, 95.65 per cent of ANSPs experienced an increase, with a rise of median by 25 per cent between 2021 and 2022.

KCAA experienced the most significant change of the year, with a 290 per cent increase in Cost per IFR hour as other costs rose sharply as a proportion of the total. The second highest change, an increase of over 100 per cent, was seen by Isavia ANS, driven by an almost 50 per cent drop in IFR hours in continental airspace.

It should be noted that differences between the operational characteristics of ANSPs' airspaces may significantly influence their 'Cost per IFR flight hour'. For example, skeyes and LVNL have delegated control of their upper airspace to MUAC. Skeyes and LVNL therefore have a higher 'Cost per IFR flight hour', than if they controlled both the upper and the lower airspace as traffic for the latter is generally more complex. MUAC, meanwhile, makes use of infrastructure provided by skeyes and LVNL, which reduces its 'Cost per IFR flight hour'. Furthermore, since the upper airspace does not include VFR flights, MUAC's ATCO in OPS productivity is fully reflected in this KPI, while the values for skeyes and LVNL does include VFR workload, which reduces the ATCO in OPS productivity.

The total costs per IFR hour (KPI) remain relatively high for ANSPs such as Skeyes, LVNL, Skyguide, and ANA, though there has been an improvement largely driven by an increase in IFR hours due to rising traffic levels. On the other hand, MOLDATSA recorded a significant increase in its cost per IFR flight hours, due to a 40 per cent decrease in IFR hours. This drop was caused by the reduction in air traffic resulting from the war in Ukraine, with safety concerns leading to airspace restrictions, rerouted flights, and heightened military activity. Despite the substantial reduction in IFR hours, MOLDATSA's total costs remained relatively stable.

Regarding the 2018-2022 CAGR for KPI 1, DHMI, Isavia ANS, and MOLDATSA saw higher growth rates compared to other ANSPs. For DHMI, the key factor was a more than twofold increase in total costs, while for Isavia ANS and MOLDATSA, the primary contributing factor was a decline in IFR hours.

Specific ANSP comments are outlined below.

DHMI (Turkiye)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For DHMI, costs increased significantly by 30.6 per cent or €139.4 million. This included substantial rises in the cost of capital (up 92.0 per cent or €87.7 million), non-staff operating costs (up 23.6 per cent or €35.2 million), and staff costs (up 15.6 per cent or €25.3 million). The notable increase in non-staff operating costs was primarily due to a significant rise in energy prices and other expenses denominated in foreign currencies.

M-NAV (Macedonia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For M-NAV, the costs rose by 30.1 per cent or €4.2 million, primarily due to an increase in staff costs (up 31.4 per cent or €3.5 million) and non-staff operating costs (up 36.5 per cent or €0.6 million). The significantly higher energy costs and other expenses incurred in 2022 also contributed to this increase.

PANSA (Poland)

The following justification is taken from the ACE Benchmarking report (2024 edition)

The rise in ATM/CNS provision costs for PANSA, up 26.2 per cent or €42.0 million, is largely due to higher staff costs. The cost of capital also significantly increased by 70.3 per cent or €5.9 million, primarily because of a higher WACC (up 2.4 percentage points) driven by a substantial rise in the annual interest rate on debt and its proportion of financing.

EANS (Estonia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For EANS, the 18.0 per cent decrease (or €4.8 million) is primarily driven by lower depreciation costs, which dropped by 41.7 per cent (or €2.7 million) due to adjustments in the implementation of new investments. Additionally, reductions in ATCO in OPS employment costs (down 17.2 per cent or €1.4 million) and the cost of capital (down 29.4 per cent or €0.6 million) also contributed to this decrease.

DFS (Germany)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For DFS, the 7.3 per cent decrease (or €86.5 million is primarily due to the absence of exceptional items in 2022, which fell by €64.8 million. Over the past 15 years, DFS reported exceptional costs as accounting losses on balance sheet items due to the conversion from the German Commercial Code (HGB) to IFRS in 2007. These losses were amortised over the period from 2007 to 2021.

DSNA (France)

The following justification is taken from the ACE Benchmarking report (2024 edition)

DSNA experienced a 3.3 per cent decrease (or €46.1 million) in costs, with all categories except the cost of capital declining in real terms. In 2022, DSNA underwent a re-organisation of its central services and restructuring of its investment portfolios. Depreciation costs decreased by 13.5 per cent (or €18.9 million) due to the postponement of project commissioning until 2023 and the redirection of investments towards service-oriented solutions.

ENAV (Italy)

The following justification is taken from the ACE Benchmarking report (2024 edition)

ENAV recorded a 2.7 per cent decrease (or €20.2 million), primarily attributable to reductions in depreciation costs (down 10.4 per cent or €12.0 million) and the cost of capital (down 12.2 per cent or €8.1 million). These reductions were mainly driven by delays in investment plans and the application of a lower WACC for calculating the cost of capital.

ENAIRE (Spain)

The following justification is taken from the ACE Benchmarking report (2024 edition)

ENAIRE reported a 13.5 per cent increase (or €105.2 million) in ATM/CNS provision costs in 2022, which includes an exceptional expense of €137.0 million. This expense is related to future liabilities for air traffic controllers (ATCOs) under a specific regime known as "Special Active Reserve" following the application of Law 26/2022. Further to this justification, ENAIRE notes that the law is aimed at resolving the differences in retirement age between the ENAIRE ATCOs Staff Labour Agreement and Spanish Social Security Pension Scheme however, this law does not indicate how to do so from an accounting perspective.

LPS (Slovakia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

LPS experienced a 32.2 per cent increase in costs (€14.5 million), mainly due to a 48.7 per cent rise in staff costs (€13.4 million) from higher employment costs. This increase contrasts with previous years' reductions due to COVID-19 measures and changes in retirement benefits.

MOLDATSA (Moldova)

The following justification is taken from the ACE Benchmarking report (2024 edition)

MOLDATSA recorded a decrease of 21.9 per cent (or €2.0M), primarily driven by lower ATCO in OPS employment costs, which decreased by 33.2 per cent (or €0.8M). This reduction is influenced by the fact that part of MOLDATSA ATCOs' compensation is tied to traffic volumes and associated complexity. The significant reduction in traffic flows resulted from airspace closures and reciprocal sanctions on air carriers issued by Western countries and Russia since February 2022, leading to a substantial decline in MOLDATSA's traffic (18.3 per cent decrease compared to 2021 and 51.5 per cent decrease compared to 2021 and 51.5 per cent decrease dby 64.8 per cent (or €0.6M) from 2021 to 2022, primarily due to a reduction in the asset base.

NATS (UK)

The following justification is taken from the ACE Benchmarking report (2024 edition)

NATS reported a 4.8 per cent increase (or €32.5M) in total ATM/CNS provision costs, primarily driven by a substantial rise in non-staff operating costs, which increased by 45.0 per cent (or €28.6M). In 2021, these costs were influenced by exceptional factors, resulting in a significantly lower figure compared to 2020, attributed to the implementation of cost containment measures and the release of a bad debt provision. In 2022, additional costs were also required to deliver large engineering projects, pay technical infrastructure costs and higher energy prices.

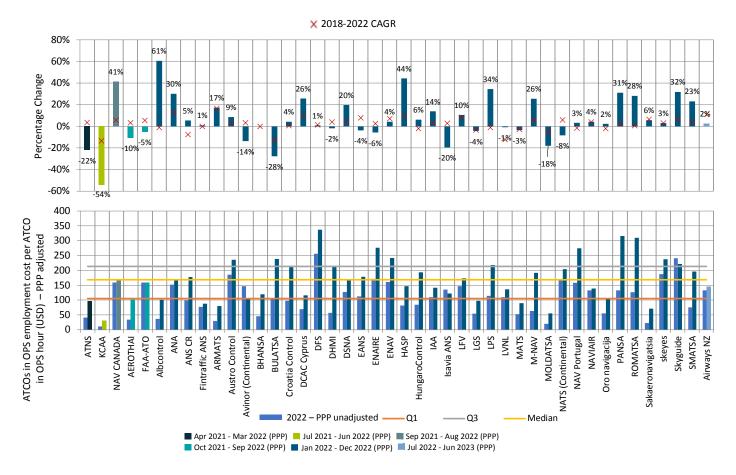


Figure 4 - ATCO in OPS Employment cost per ATCO is OPS hour (USD)

The 2022 median ATCO in OPS employment cost per ATCOs in OPS hour was USD 110. The same poll of ANSPs submitting data in 2021 showed a median of USD 97 per ATCO hour.

ANSPs with reporting periods starting in mid-2021 were likely affected by cost-cutting measures due to the pandemic, particularly through the implementation of part-time work as part of their staffing contracts. KCAA, which saw the largest decrease of 55 per cent in ATCO employment costs per ATCO hour in 2022, had experienced a significant 33 per cent increase in these costs per ATCO hour the previous year.

DHMI saw the largest increase in this metric, with an 80 per cent rise compared to 2021, largely driven by a significant rise in ATCO costs. This substantial increase was likely influenced by high inflation in Turkey, although inflation did not account for the entire change. In comparison, Albcontrol experienced the second-largest increase of 61 per cent in this metric, primarily due to nearly doubling its ATCO costs, despite a less significant rise in ATCO hours. Unlike DHMI, inflation had a less pronounced impact on Albcontrol's performance.

Slovenia Control and CAAS are not displayed on the chart because the required data for this KPI are missing. Specific ANSP comments are outlined below.

LPS SR (Slovakia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

The rise in staff costs should be considered in relation to the significant reductions in staff costs achieved in 2020 (down 38.5 per cent) and 2021 (down 18.0 per cent). These reductions were a result of temporary measures implemented in response to the COVID-19 crisis and adjustments made to long-term reserves for retirement benefits.

DHMI (Türkiye)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For DHMI, the rapid inflation surge in 2022 prompted two rounds of salary increases.

M-NAV (Macedonia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

The increase in staff cost comes after two consecutive years of decreasing average employment costs, which were attributed to withheld funds from employees' salaries between 2020 and 2022, as well as higher gross wages resulting from changes in the employment status of newly hired ATCOs.

PANSA (Poland)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For PANSA, the increase in staff costs (+33.4 per cent or +€33.8M), particularly in ATCO in OPS costs (+52.1 per cent or +€24.5M), primarily stems from the discontinuation of COVID-19 measures implemented during 2020 and 2021, along with subsequent adjustments to the remuneration scheme in 2022. Additionally, in 2022 the level of ATCO employment costs was affected by the utilisation of unspent budget in 2021, along with further changes to the remuneration scheme implemented during the year.

Indicator 2A: ATCO in OPS employment cost per ATCO in OPS hour (USD) – PPP adjusted

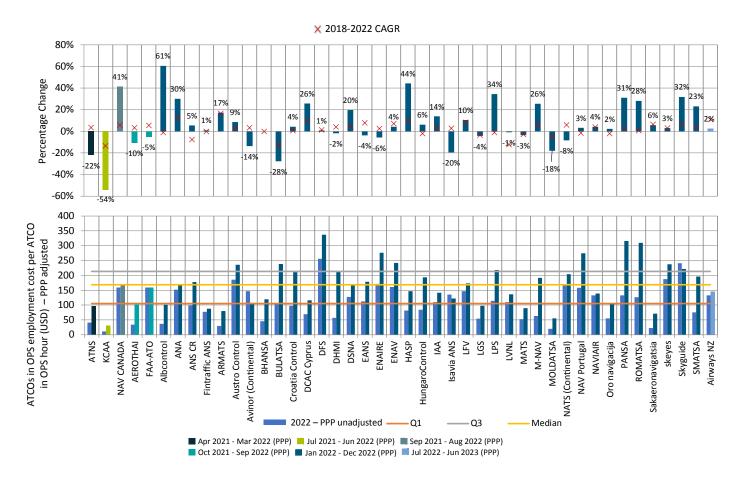


Figure 5 - ATCO in OPS Employment cost per ATCO in OPS hour (USD) - PPP Adjusted

The 2022 median ATCOs in OPS employment cost per ATCOs in OPS hour, after PPP adjustment was USD 169. The same ANSPs that submitted continental data for 2021 reached a median of USD 152 per ATCO hour.

Albcontrol experienced a significant increase of 61 per cent in PPP adjusted ATCO in OPS employment cost per ATCO in OPS hour in 2022. This followed a larger reduction in staffing numbers relative to other ANSPs and a 22 per cent decrease in PPP-adjusted value in 2021. Many ANSPs relaxed cost containment measures and eased cost reduction methods that were aimed at managing staffing costs due to the pandemic, resulting in increased ATCOs' employment costs in 2022 compared to the previous year.

Significant differences, exceeding 20 per cent, were noted between PPP-adjusted and unadjusted trends for DHMI and Avinor. DHMI experienced an 80 per cent increase in ATCO in OPS employment cost per ATCO in OPS hour; however, after adjusting for PPP, the actual year-over-year change, accounting for real prices of goods and services, was a 2 per cent decrease. For Avinor, PPP-adjusted figures revealed a 14 per cent decrease in ATCO employment costs per ATCO hour, whereas the unadjusted data showed a reported increase of 6 per cent. Other ANSPs showed differences of less than 20 per cent between PPP-adjusted and unadjusted changes for the 2021-2022 period.

MUAC, Slovenia Control and CAAS are not displayed on the chart because the required data for this KPI are missing.

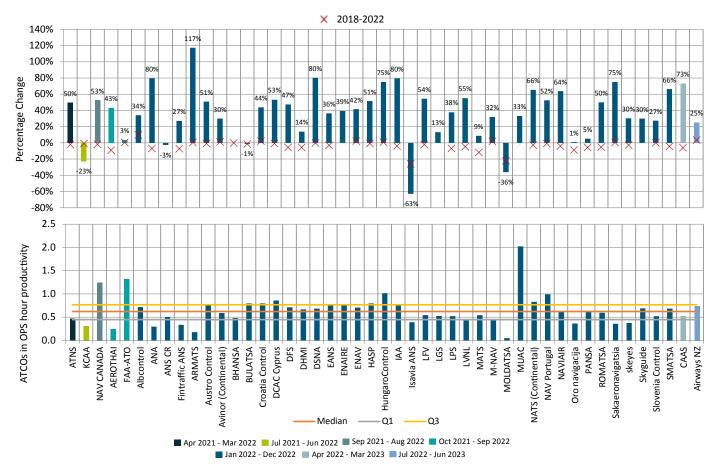


Figure 6 - ATCO in OPS hour productivity

The 2022 median ATCOs in OPS hour productivity was 0.62. The same poll of ANSPs submitting data in 2021 showed a median of 0.46.

ARMATS, as the ANSP with the largest growth in IFR hours, also achieved the highest increase in ATCO in OPS hour productivity, driven by this rise in IFR hours. In contrast, Isavia ANS and MOLDATSA were most negatively impacted by a decrease in IFR hours, leading to the most significant declines compared to other ANSPs. The decrease in ATCO hour productivity at Isavia ANS was further influenced by an increase in ATCO in OPS hours.

As highlighted in the 2021 report, MUAC maintained the highest productivity among all submitting ANSPs. It is important to note, however, that MUAC's scope of services typically excludes the more complex lower airspace, which contributes to its higher productivity levels.

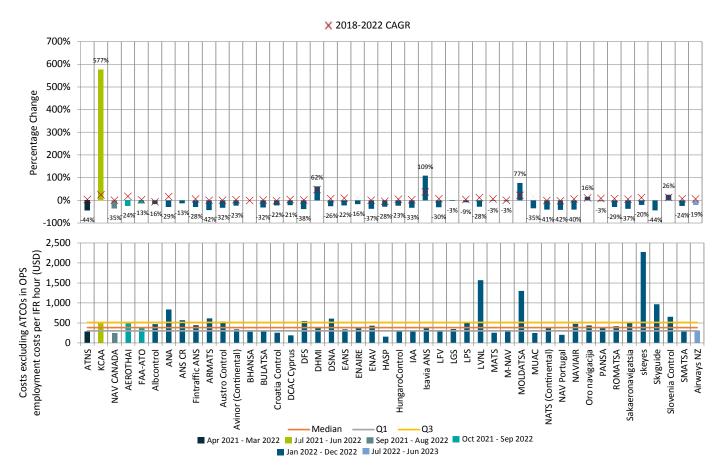


Figure 7 - Cost excluding ATCO in OPS employment costs per IFR hours

The 2022 median cost excluding ATCOs in operations employment cost per IFR flight hour was USD 383. The same poll of ANSPs submitting data in 2021 showed a median of USD 462 per IFR hour.

KCAA experienced a significant increase in costs per IFR hour excluding ATCOs in OPS employment, because of an increase in other expenses. Although IFR flight hours grew by 16 per cent, this factor had less impact on the KPI (costs per IFR hour excluding ATCOs in OPS employment), compared to the increase in other expenses. Meanwhile, most other ANSPs experienced a decline in this metric as their IFR flight hours increased.

All European ANSPs submitting to CANSO saw a decrease in costs per flight hour, as a result of increased traffic volumes during 2022. With skeyes' infrastructure made available to MUAC as part of their agreements, and therefore, combined with the fact that skeyes provides services in more complex lower airspace only, skeyes and LVNL (for similar reasons) typically have larger costs per flight hour.

It should be noted that, for the same reasons stated in the description of Indicator 1 'Cost per IFR flight hour', differences between the operational characteristics of ANSPs' airspaces may significantly influence their 'Costs excluding ATCOs in OPS employment costs per IFR hour'.

CAAS is not displayed on the chart because the required data for this KPI are missing.

Specific ANSP comments are outlined below.

EANS (Estonia)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For EANS, the decrease in support costs primarily stems from significant reductions in depreciation costs (down 41.7 per cent or -€2.7M) and the cost of capital (down 29.4 per cent or -€0.6M).

MOLDATSA (Moldova)

The following justification is taken from the ACE Benchmarking report (2024 edition)

MOLDATSA saw reductions across all support cost categories, particularly in the cost of capital (decreased by 64.8 per cent, or -€0.6M), non-staff operating costs (decreased by 24.3 per cent, or -€0.4M), and support staff costs (decreased by 5.1 per cent, or -€0.2M).

Skyguide (Switzerland)

The following justification is taken from the ACE Benchmarking report (2024 edition)

Skyguide's significant decrease primarily results from reductions in support staff costs (down 24.2 per cent, or -&46.6M). This substantial decrease is primarily attributed to the reassignment of ATCOs from other roles to operational duties. Depreciation costs also decreased by 12.3 per cent (or -&7.2M), and to a lesser extent, exceptional costs decreased by 7.9 per cent (or -&0.1M). However, these reductions were partly offset by increases in the cost of capital (up 55.1 per cent, or +&7.5M) and non-staff operating costs (up 12.2 per cent, or +&7.7M).

DFS (Germany)

The following justification is taken from the ACE Benchmarking report (2024 edition)

DFS experienced a reduction primarily attributed to the absence of exceptional costs in 2022 (down -€64.8M). Over the past 15 years, DFS has reported losses under exceptional costs, stemming from the conversion from German Commercial Code (HGB) to IFRS in 2007, which were spread over the period from 2007 to 2021.

Indicator 2D: Employment costs of ATCOs in OPS as a proportion of Total costs (Formula: ATCO in OPS employment costs/Total Costs)

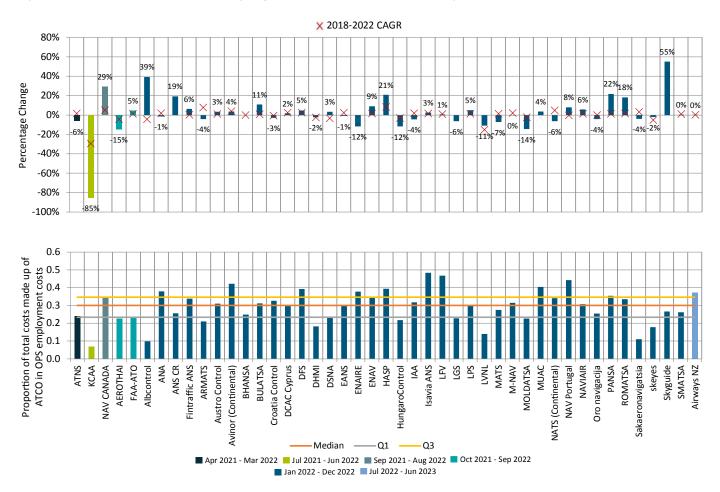


Figure 8 - Employment costs of ATCOs in OPS as a proportion of total costs

In 2022, the median of the total ANS costs spent on employing ATCO in OPS was 30 per cent. The same poll of ANSPs submitting data in 2021 showed a median of 29 per cent that year.

For KCAA, the 85 per cent decrease in employment costs of ATCOs in OPS as a proportion of total costs was influenced by a reduction in employment costs alongside an increase in other costs, both contributing to changes in total costs.

Skyguide experienced a 55 per cent rise in ATCO employment costs as a proportion of total costs, following a trend of decreasing costs in earlier years (e.g., 31 per cent decrease from 2019 to 2020 and 2 per cent decrease from 2020 to 2021). Albcontrol experienced an overall increase in costs, with employment costs nearly doubling and other costs also rising as a proportion of total expenses. This contributed to a 39 per cent increase in employment costs of ATCOs in OPS as a proportion of total costs, compared to the previous year.

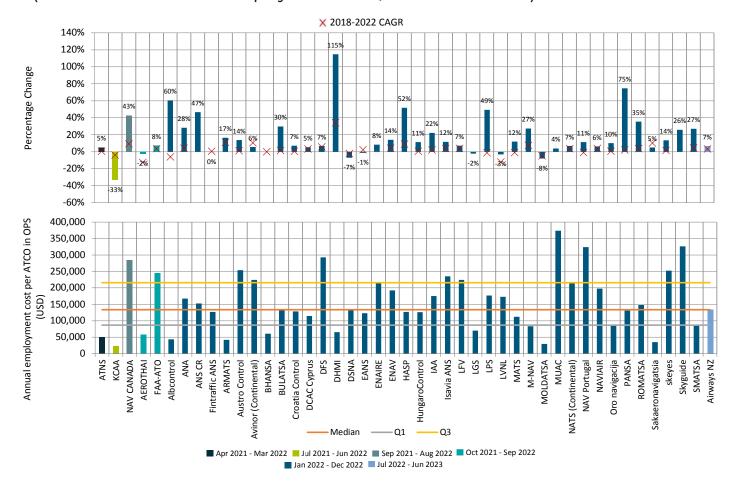


Figure 9 - Annual employment cost per ATCO in OPS

The 2022 median unit ATCO in OPS employment cost was USD 133,770. The same poll of ANSPs submitting data in 2021 showed a median of USD 120,402 per ATCO.

DHMI experienced a 115 per cent increase in annual employment cost per ATCO in OPS. This increase was driven by higher ATCO employment costs. DHMI also increased its number of ATCOs by 42, a 2 per cent increase from the previous year. However, this increase is relatively small compared to the 120 per cent rise in ATCO employment costs, largely due to inflation, making the growth in ATCO numbers negligible by comparison.

PANSA saw a 75 per cent increase in annual employment cost per ATCO in OPS. This increase was mainly due to a 72 per cent rise in ATCO employment costs, despite a 1.4 per cent decrease in the number of ATCOs. The decrease observed for KCAA in annual employment cost per ATCO in OPS was primarily influenced by the previously mentioned reduction in ATCO employment costs.

Slovenia Control and CAAS are not displayed on the chart because the required data for this KPI is not available. Specific ANSP comments are outlined below.

HASP (Greece)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For HASP, the increase in employment costs for ATCOs primarily stems from contributions to the occupational pension fund of ATCOs and an expansion of the contractual working hours for ATCOs in operations.

ENAV (Spain)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For ENAV, increased ATCOs in operations employment costs are attributed to the renewal of the financial aspects of the National Collective Labour Agreement and the increased need for staff presence and availability at sites to manage summer season traffic.

ROMATSA (Romania)

The following justification is taken from the ACE Benchmarking report (2024 edition)

For ROMATSA, the rise in ATCO employment cost is driven by an increased number of ATCOs in operations (+5.3 per cent, or +28 FTEs), coupled with higher pension expenses and one-time payments recorded for managing unexpectedly high traffic volumes and meeting capacity performance targets.

Skyguide (Switzerland)

The following justification is taken from the ACE Benchmarking report (2024 edition)

Skyguide experienced higher ATCO employment costs due to a 26 per cent increase in the number of ATCOs in operations, equivalent to 70 full-time equivalents (FTEs). This increase was in response to increased air traffic levels and the conclusion of short-time work arrangements implemented during the COVID-19 crisis.

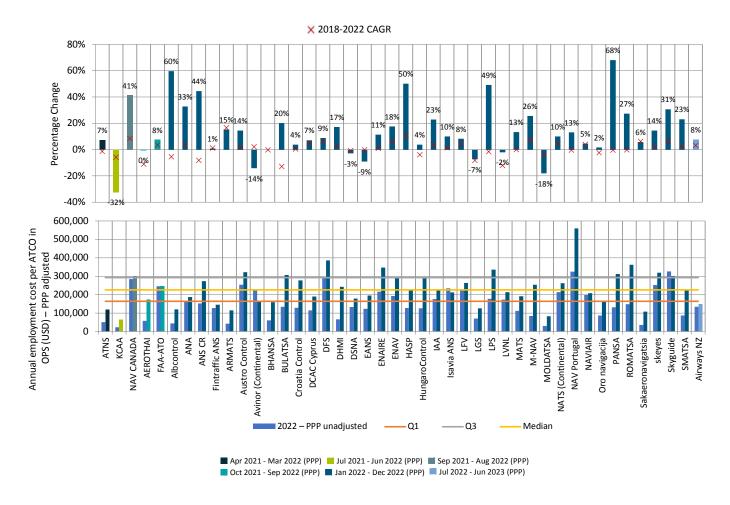


Figure 10 - Annual employment cost per ATCO in OPS (USD)

The 2022 median unit ATCO in OPS employment cost, after PPP adjustment, was USD 225,808. The same poll of ANSPs submitting data in 2021 showed a median of USD 195,395 per ATCO.

When comparing the PPP-adjusted and unadjusted changes from 2021 to 2022, the most significant difference is observed for DHMI, which is largely due to the high inflation in the country where it operates.

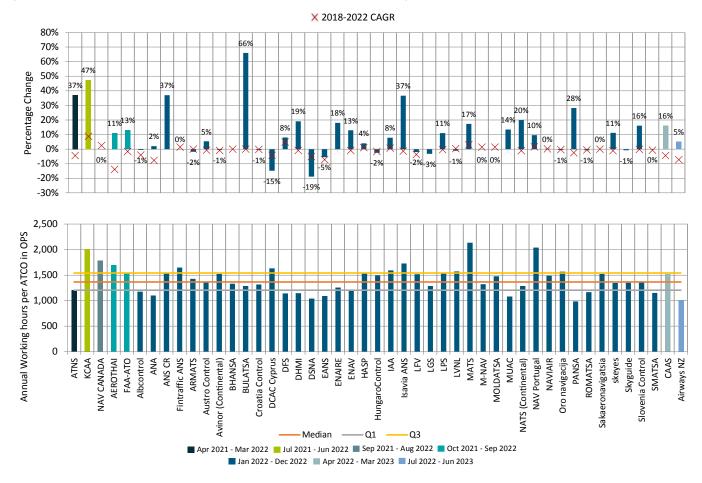


Figure 11 - Annual working hours per ATCO in OPS

The 2022 median annual working hours per ATCO in OPS was 1,366 hours. The differences recorded for this metric were influenced by the number of staff working full-time. The same poll of ANSPs submitting data in 2021 showed a median of 1,328 hours per ATCO.

Most ANSPs, especially those operating in European airspace, saw an increase in Annual Working Hours per ATCO in OPS. BULATSA experienced the largest increase in this indicator, rising by 66 per cent due to an increase in annual working hours. With this increase, their value is now close to the median, leading to a smaller difference compared to the workload of ATCOs at other ANSPs than in the previous year.

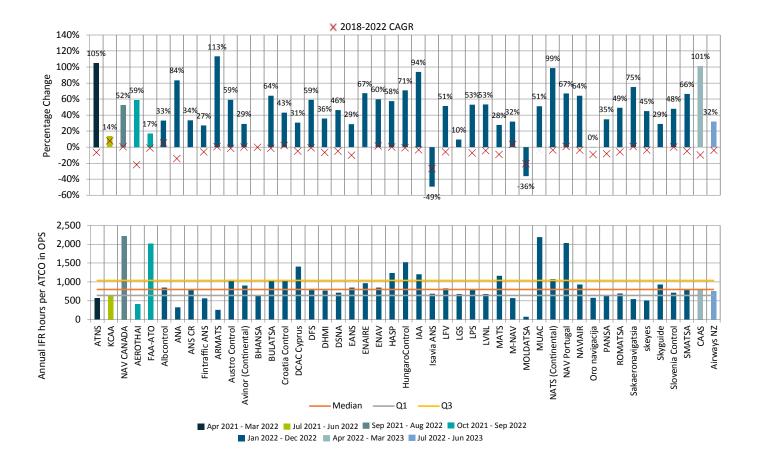


Figure 12 - Annual IFR hours per ATCO in OPS

The 2022 median annual IFR hours per ATCO in OPS was 800 hours. The same poll of ANSPs submitting data in 2021 showed a median of 565 hours per ATCO.

Nearly all ANSPs with reporting periods covering 2022 except for Isavia ANS and MOLDATSA, saw an increase in Annual IFR hours per ATCO, demonstrating a recovery from the pandemic and the subsequent increase in operations. Although the average increase in this KPI is 42 per cent, the 2022 median has not yet recovered to pre-pandemic levels.

ARMATS recorded the highest increase of 113 per cent in annual IFR Hours per ATCO in OPS, reflecting the increase in IFR hours. ATNS, IAA, NATS, and CAAS also saw substantial increases, comparable to ARMATS.

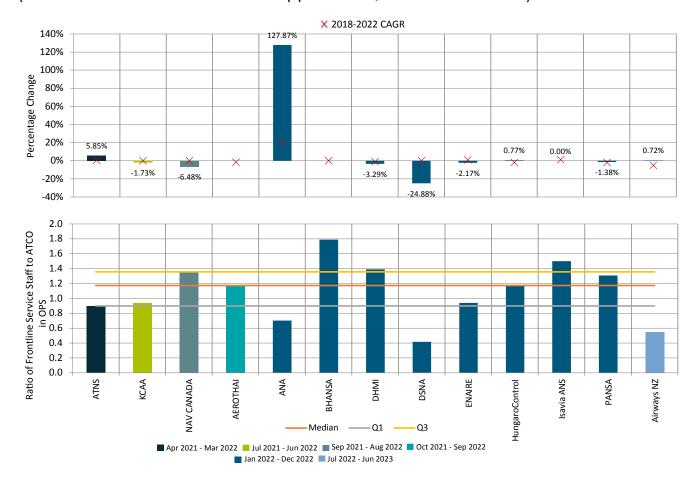


Figure 13 - Ratio of frontline service staff to ATCO in OPS

The 2022 median ratio of frontline service staff to ATCO in OPS was 1.17. The same poll of ANSPs submitting data in 2021 showed a median of 1.07.

The largest increase in the Ratio of Frontline Service Staff to ATCO in OPS came from ANA at 127.87 per cent, and the largest decrease was reported by DSNA at 24.88 per cent decrease in 2022. The previous reporting period saw more changes in the Ratio of Frontline Service Staff to ATCO in OPS compared to 2022. This was likely due to adjustments made during the pandemic in 2020-2021. However, in 2022 the situation has stabilised for most ANSPs.

Oceanic Cost Efficiency and Productivity: 2022

Indicator 1: Cost per IFR flight hour (USD)

(Formula: Total costs / IFR flight hours)

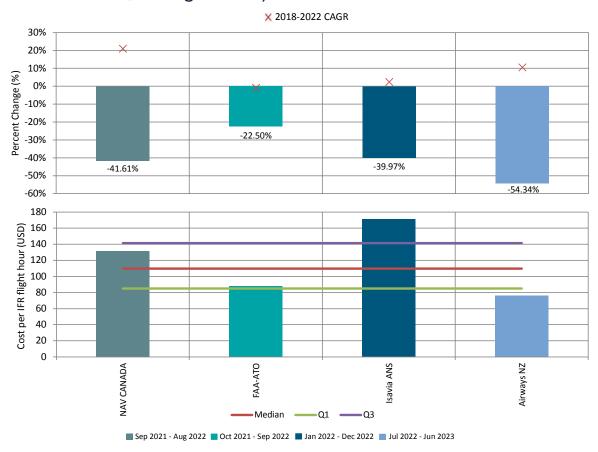


Figure 14 - Cost per IFR flight hour

The 2022 median cost per IFR flight hour was USD 110. The 2022 weighted average (taking into account total oceanic IFR flight hours per ANSP) cost per IFR flight hour was USD 117. The same poll of ANSPs submitting data in 2021 showed a median of USD 196 per IFR hour and a weighted average of USD 198 per IFR hour for that year.

Cost efficiency increased more than for continental airspace due to the greater increase in IFR hours in oceanic airspace. The most notable change was observed with Airways NZ, the ANSP that experienced the largest increase in IFR hours.

On the other hand, FAA-ATO experienced the smallest decrease in Total costs per IFR hour, with IFR hours increasing by just 19 per cent. In absolute terms, the volume of traffic in their control area saw the most significant growth compared to other ANSPs. However, when viewed as a percentage change over the years, the trend appears less pronounced.

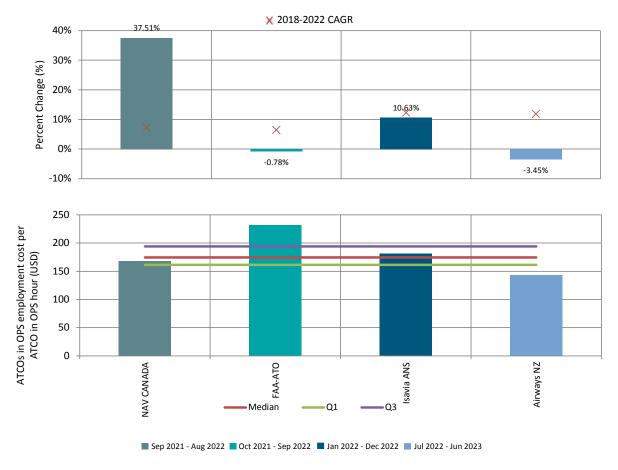


Figure 15 - ATCO in OPS employment cost per ATCO in OPS

The 2022 oceanic median employment cost per ATCO in OPS hour was USD 175. The same poll of ANSPs submitting data in 2021 showed a median of USD 145 per ATCO hour.

All ANSPs except FAA-ATO and Airways NZ saw an increase in ATCO in OPS employment cost per ATCO in OPS hour, driven by a combination of rising ATCO employment costs and a decrease in ATCO hours.

When comparing this KPI to performance in continental airspace, Isavia ANS exhibited a slight disparity. This difference is attributed to an increase in ATCO hours in continental airspace, while oceanic airspace saw a decrease. Otherwise, KPI trends among the other ANSPs were consistent across both airspaces.

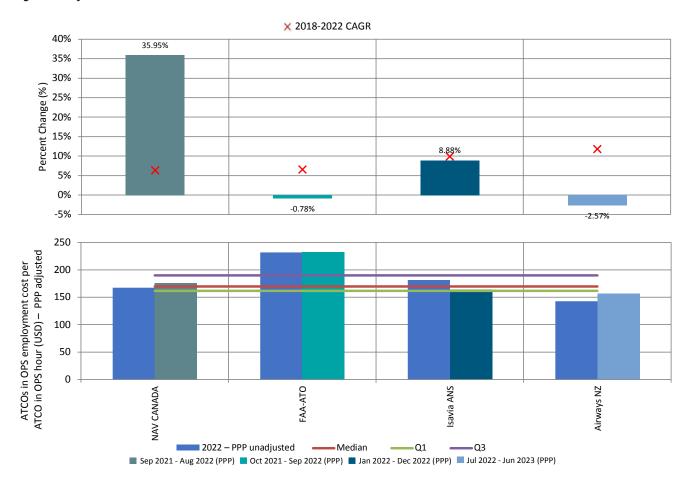


Figure 16 - ATCO in OPS employment cost per ATCO in OPS hour - PPP adjusted

In 2022, the median employment cost per ATCO (PPP-adjusted) in oceanic airspace was USD 170 per OPS hour, while the average for oceanic airspace was USD 182 per ATCO hour. For comparison, the same poll of ANSPs submitting data in 2021 showed a median of USD 150 per ATCO hour.

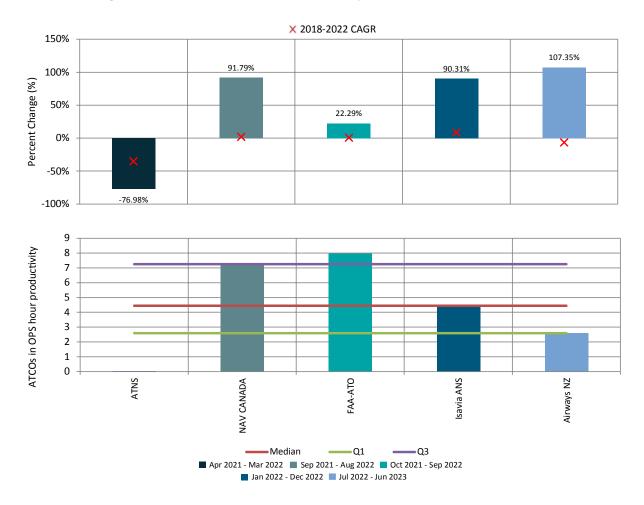


Figure 17 - ATCO in OPS hour productivity

The 2022 median ATCOs in OPS hour productivity was 4.45, which is significantly higher than the continental figure of 0.62. The same poll of ANSPs submitting data in 2021 showed a median of 2.34.

All ANSPs except ATNS experienced an increase in ATCO in OPS hour productivity due to the rise in IFR hours in oceanic airspace. ATNS IFR flight hours are low compared to other ANSPs (309 hours in 2022). The significant 77% decrease may be attributed to the already low absolute values, making the percentage decline appear disproportionately high.

On the other hand, Airways NZ experienced a rise of over 130 per cent in IFR hours in oceanic airspace which led to a significant increase in ATCO in OPS hour productivity.

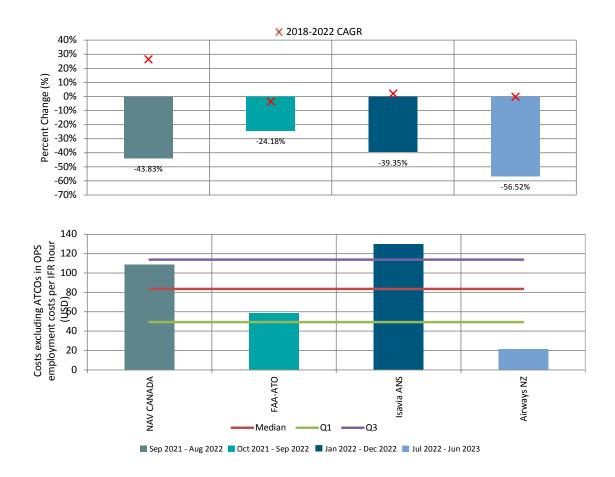


Figure 18 - Costs excluding ATCOs in OPS employment costs per IFR flight hours

The 2022 median cost excluding ATCOs in operations employment cost per IFR flight hour was USD 84. The same poll of ANSPs submitting data in 2021 showed a median of USD 135 per IFR hour.

The rise in IFR hours in oceanic airspace generally led to a decreasing trend in this metric across all reporting ANSPs. However, Isavia ANS reported a 12 per cent increase in other costs, which also impacted its KPI. Consequently, the KPI trend for Isavia ANS diverges from the pattern of increasing IFR hours seen in other ANSPs' KPIs.

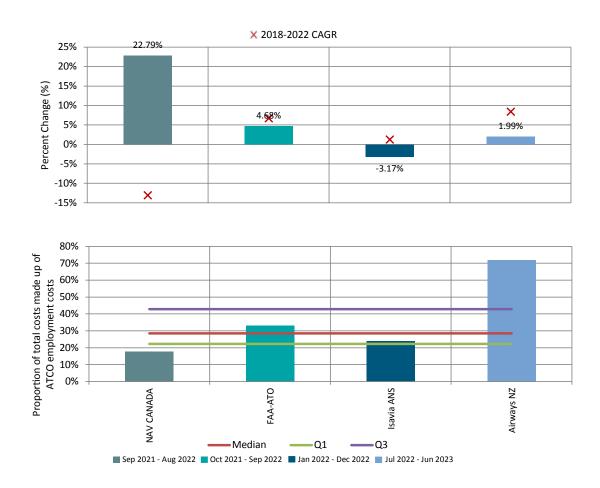


Figure 19 - Employment costs of ATCOs in OPS as a proportion of total costs

The 2022 median for the proportion of total costs made up of ATCO in OPS employment costs was 29 per cent. For comparison, the same poll of ANSPs submitting data in 2021 showed a median of 25 per cent. The 2022 median of 29 per cent marks a return to pre-pandemic levels.

The largest difference compared to the previous year was observed by NAV CANADA, with a 23 per cent increase. When comparing trends from previous reports, NAV CANADA experienced fluctuations in this KPI, primarily due to NAV CANADA reduced ATCO costs during low traffic periods of the pandemic and then increased with traffic. In contrast, the trends for other ANSPs remained relatively stable, as shown in Figure 19 above.

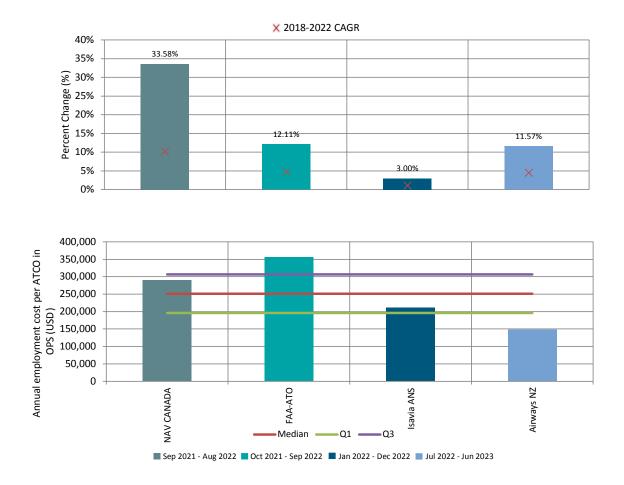


Figure 20 - Annual employment costs per ATCO in OPS

The 2022 median of Annual ATCO in OPS employment cost was USD 251,183. For comparison the 2021 median was USD 205,943 per ATCO.

Most ANSPs submitting data for this KPI remained stable compared to the previous reporting period. However, this was not the case for NAV CANADA, who experienced significant increases (34 per cent). This was mostly driven by a rise in ATCO employment costs. Similar to the previous KPI, NAV CANADA reduced ATCO costs during low traffic periods of the pandemic and then increased with traffic.

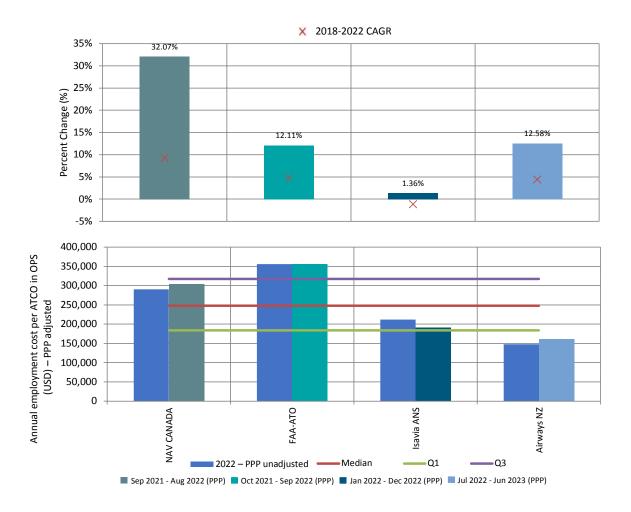


Figure 21 - Annual employment costs per ATCO in OPS - PPP adjusted

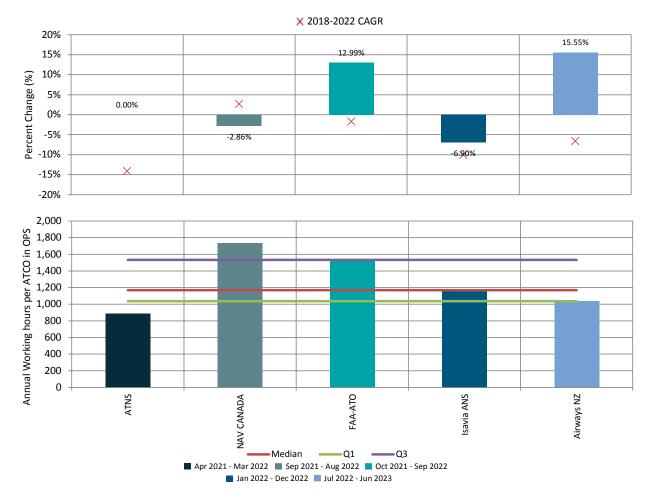


Figure 22 - Annual working hours per ATCO in OPS

The median annual working hours per ATCO in OPS in 2022 were 1,169, marking a 10 per cent decrease compared to the previous year. During the pandemic, the median remained stable at over 1,300 hours per ATCO, although this was up to 16 per cent lower than pre-pandemic levels, with even greater differences in the earlier years.

Isavia ANS experienced the largest decrease in annual working hours per ATCO in OPS, dropping by nearly 7 per cent. In contrast, Airways NZ saw the largest increase, with a rise of 16 per cent. Meanwhile, ATNS reported no change in this metric between 2021 and 2022.

(Formula: IFR flight hours / No. ATCOs in OPS)

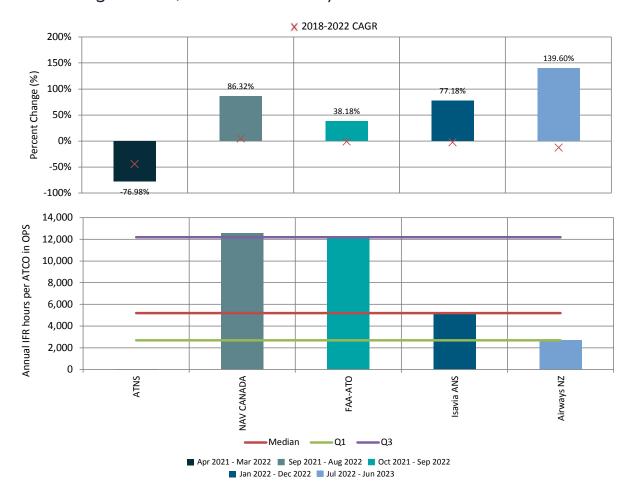


Figure 23 - Annual IFR hours per ATCO in OPS

The 2022 median annual IFR hours per ATCO in OPS was 5,200 hours. For comparison, the same poll of ANSPs submitting data in 2021 showed a median of 2,935 hours per ATCO.

The changes in this KPI mirror the fluctuations in IFR hours experienced by ANSPs operating in oceanic airspace, as the number of ATCOs in OPS saw only slight changes. Compared to other ANSPs, ATNS reported such a low value for this KPI (34 IFR hours per ATCO) that it is not displayed on the chart. In contrast, NAV CANADA had the highest workload in oceanic airspace, with 12,560 IFR hours per ATCO.

When examining changes from the previous year, Airways NZ saw the largest increase, with a 139 per cent rise. In terms of absolute numbers, NAV CANADA's ATCOs experienced the most significant workload increase, with over 5,800 additional IFR hours per ATCO, which is the highest within the sample.

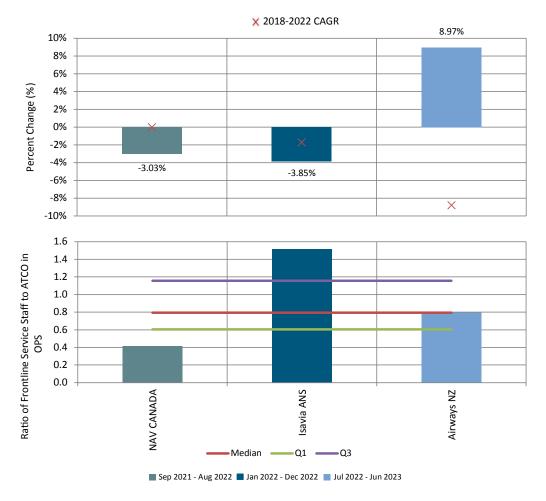


Figure 24 - Ratio of frontline service staff to ATCO in OPS

The 2022 median ratio of frontline service staff to ATCO in OPS was 0.79. For comparison, the median ratio for the same ANSPs that submitted oceanic data in 2021 was 0.70.

For the Ratio of Frontline Service Staff to ATCO in OPS, Airways NZ had the largest increase during their reporting period at 8.97 per cent. Isavia ANS' operations were dominated by oceanic flights, and therefore the ratio of frontline support staff is relatively high compared to other ANSPs, whose continental operations represent a larger proportion of their total service.

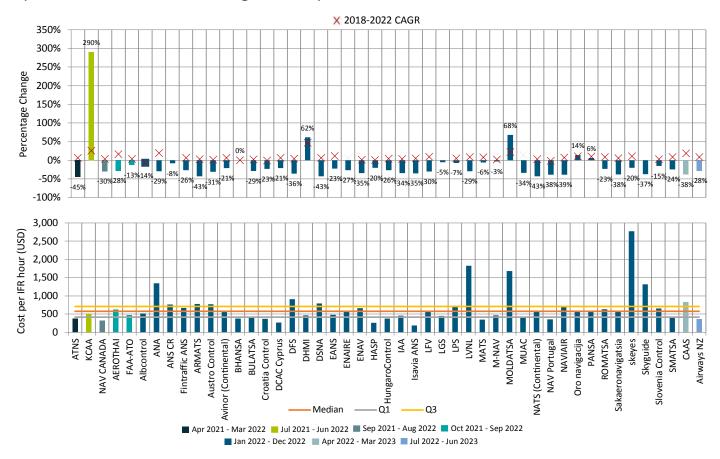


Figure 25 - Cost per IFR flight hour

The 2022 median cost per IFR flight hour was USD 579. The 2022 weighted average (taking into account total continental and oceanic IFR flight hours per ANSP) cost per IFR flight hour was USD 665. The 2021 median was USD 721 per IFR hour, and the weighted average was USD 877 per IFR hour.

An analysis of trends in joint KPI 1, Cost per IFR Flight Hour, reveals a significant change for Isavia ANS. While total costs increased in both airspaces, traffic volumes differed: oceanic airspace saw an 84 per cent increase, while continental airspace experienced a 49 per cent decrease. This led to a net difference of 35 per cent for the 2021-2022 period, causing KPI 1 to drop significantly below the median value.

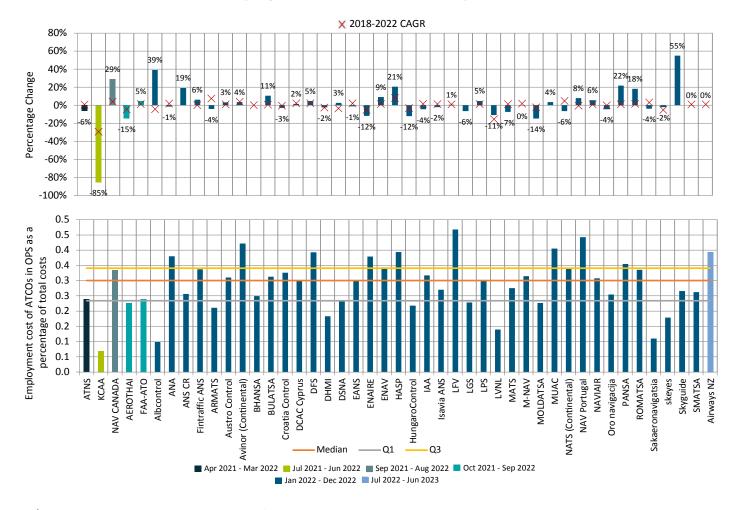


Figure 26 - Employment cost of ATCOs in OPS as a percentage of total costs

The 2022 median employment cost of ATCOs in OPS as a percentage of total costs was 30 per cent. The same poll of ANSPs submitting data in 2021 showed a median of 29 per cent.

Data are available for only four ANSPs operating in oceanic airspace—NAV CANADA, FAA-ATO, Isavia ANS, and Airways NZ. For these ANSPs, the trends in this KPI have remained relatively stable when combining data from both airspaces. The notable percentage change is a 5 per cent difference observed with Isavia ANS, which suggests that KPI 2D behaves similarly in both airspaces for ANSPs that cater to both continental and oceanic flights.

Slovenia Control and CAAS are not displayed on this chart because the required data for this KPI is not available.

Summary of Performance Trends

Key findings

- Significant performance improvements in oceanic airspace compared to continental airspace;
- Cost efficiency and ATCO productivity are improving and show signs of returning to pre-pandemic levels as traffic rises; ATCO productivity in oceanic airspace has reached a higher level than before the pandemic;
- ATCO employment costs per hour in continental airspace are rising again, while the increase in costs in oceanic airspace closely mirroring the pre-pandemic levels;
- The majority of ANSPs in continental airspace and all ANSPs in oceanic airspace reported a decrease in both total costs and costs excluding ATCO in OPS employment costs per IFR flight hour.

In 2022, the ATM system experienced a continued recovery, although challenges persisted. Air traffic volumes rebounded significantly as travel restrictions were lifted, with continental IFR hours increasing by nearly 19 per cent and oceanic IFR hours by over 40 per cent. This growth contributed to reductions in cost per IFR hour, particularly in oceanic airspace. However, rising inflation due to the war in Ukraine impacted operational costs, with fuel and labour expenses driving these increases.

The analysis reflected the varying reporting periods among ANSPs, ranging from 2021 to mid-2023, which influenced the observed trends. While inflation affected the performance of ANSPs in later reporting periods, the recovery from the pandemic had a more pronounced impact on the data, particularly in driving the positive trends seen in IFR hours and cost efficiencies.

Cost Efficiency

In terms of cost efficiency, only six ANSPs in continental airspace saw an increase in cost per IFR flight hour, while 40 reported a decrease. There are no historical data for one new submission. With a significant rise in IFR traffic, the total cost per IFR flight hours in continental airspace decreased by 22.65 per cent compared to 2021. Conversely, all four ANSPs in oceanic airspace experienced a reduction in cost per IFR hour, with the total cost per IFR flight hours decreasing by 40.97 per cent compared to 2021.

Productivity

Among the 47 ANSPs in continental airspace, 41 reported an increase, 5 reported a decrease in ATCO productivity and for one ANSP, there are no historical data. In oceanic airspace, 4 ANSPs experienced a rise, while only one saw a decrease in ATCO productivity. When comparing the same set of ANSPs, ATCO productivity in continental airspace increased by 31.77 per cent from 2021 to 2022, and in oceanic airspace by 63.7 per cent.

Future performance

Navigating the post-pandemic recovery remains a complex challenge for the ATM system. To ensure that gains in ATCO productivity and cost efficiency are sustainable, it is crucial to adopt strategies that enhance the resilience of ANSPs against future fluctuations in traffic demand.

As the industry moves forward, the data from 2019 will continue to be used as a reference point for pre-pandemic traffic levels. However, it is important to note that the pandemic's impact led to significant shifts in key trends, emphasising the need for ongoing adaptation and strategic planning to address the evolving dynamics of air traffic.

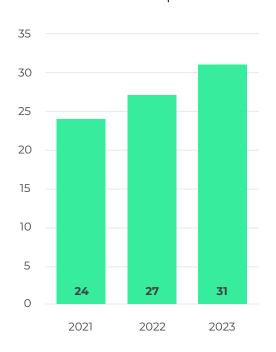
CANSO Safety Intelligence Workgroup

The CANSO SIWG champions safety measurement and continuous improvement of safety performance. Consisting of representatives from ANSPs across the globe, this group works to analyse, advise, and advance safety performance measurement, and reports to the CANSO Safety Forum¹⁰.

Safety Performance

Safety is critical for the trust and confidence of the flying public. As a result, CANSO measures key safety performance indicators to contribute to improvements in safety and efficiency of air traffic control.





When productivity and cost efficiency are measured, it becomes crucial to measure safety benchmarks, which rely on the interdependencies these three facets represent. Improvements in productivity and cost efficiency should never come at the cost of reduced safety.

Safety and safety performance are measured in several ways. This report focuses on event-based indicators of loss of separation and runway incursions.

Participation has gradually increased since the Pandemic hiatus, with 31 ANSPs submitting 2022 safety data.

The data is still very European-biased. CANSO continues to encourage ANSPs to join important safety sharing initiatives like this one for a hollistic understanding of the industry performance.

ATM Ground IFR-IFR Losses of Separation¹¹

A loss of separation is a key performance indicator for assuring compliance with applicable separation standards. This measure focuses on IFR-IFR losses (both aircraft flying under instrument flight rules). There are multiple measures for safety performance, CANSO has prioritised this measure over others as a benchmark based on the risk profiling around potential loss of life.

The monthly average rate for the participating ANSPs in 2022 was 83.76 IFR-IFR losses of separation per 1 million IFR flight hours and 3.59 per 100,000 IFR flights.

99.996% of IFR traffic was not involved in a loss of separation, which is a testament to the resiliency of the global ATM system.

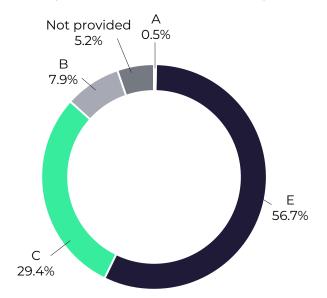
Five, out of 966 events, or 0.5% of reported losses, were considered as high severity in the Risk Analysis Took¹² (RAT) classification (which differs from the ICAO runway incursion severity classification). In relation to traffic, this represents 0.0002% of the operation.

The RAT severity classification describes the level of consequences of hazards on the safety of flight operations. It combines the level of loss of separation and the degree of ability to recover from a hazardous situation. The overall severity of one occurrence is composed of risk of collision/proximity (separation and rate of closure) and the degree of controllability over the incident.

From the diagram above, 56.8% of the IFR-IFR losses of separation had the lowest RAT severity (E).

In addition, 49% of losses occurred in Terminal/Control Zone environment and 30% in Enroute. The remaining 21% were not provided for analysis.

Runway Incursions (RIs)

A high proportion of safety events take place around the vicinity of an airport's runway(s). Again, there are multiple measurements for safety around an aerodrome. Here, CANSO has selected to measure runway incursions due to the increased likelihood that an ANSP may have contributed to the event.

In 2022, the monthly average rate of runway incursions for the ANSPs who submitted data was 4.58 RIs per 100,000 runway movements (one runway incursion for approx. every 22,000 take offs and landings).

The proportion of traffic that did not experience a Runway Incursion in 2022 was 99.995%. When focusing on those occurrences that had some level of ATM contribution, this proportion increases to 99.999%, at an average rate of 0.79 RIs per 100,000 runway movements.

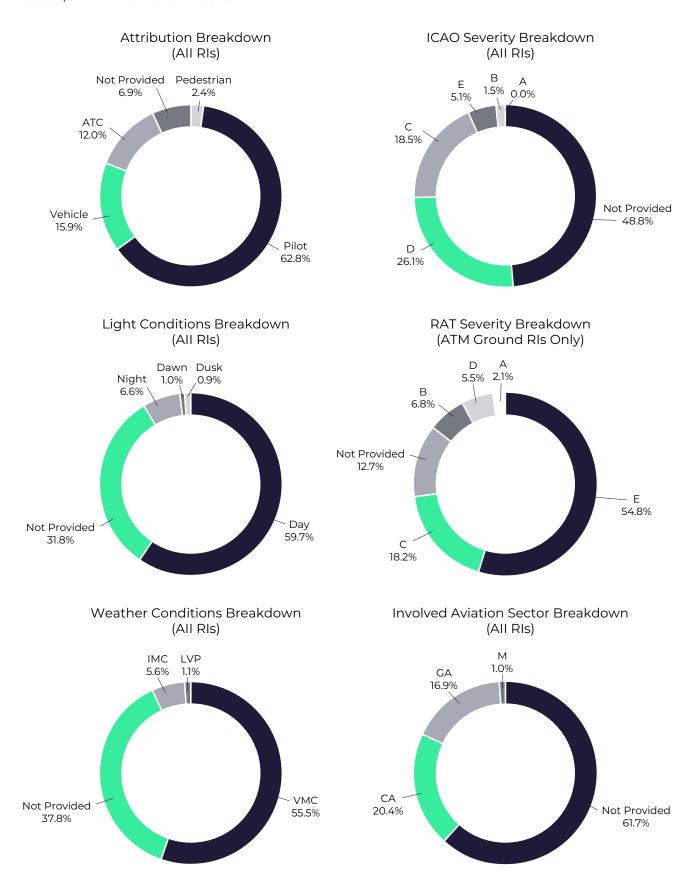
More than half of the reported RIs (51%) did not contain information on the ICAO severity¹³, but for the remaining 49% of events, none reported an occurrence assessed as an ICAO Severity A (the highest ICAO severity). However, 2 occurrences were categorized as RAT A (the highest RAT severity). This shows how the two severity classification schemes, or perhaps their interpretation and application, can very slightly.

Annex 1: Methodology

Measuring Performance

Cost efficiency and productivity are two key indicators of measuring the performance of air navigation service provision. They demonstrate how ANSPs are delivering value and serve as indicators of operational efficiency. These KPIs are all part of the CANSO ANS Performance Framework.

Cost Efficiency

Cost efficiency provides an indication of the balance between operational effectiveness (i.e. ATCO productivity) and the cost of providing the service.

The simplest indicator of cost efficiency is the **cost** of providing ANS services per IFR flight hour. A lower cost per flight hour, however, is not necessarily indicative of greater overall performance.

Economic differences outside of the control of ANSPs can drive differences in costs. This includes labour contracts, salary scales and working conditions (such as hours), as well as government regulations on pension management and mandatory financial controls. Furthermore, ANSPs do not control the volume of traffic, which is a function of economic activity and other air passenger demands. Where a minimum level of service is required, there is a limit to how activities can be scaled down in response to lower demand. This was particularly evident in 2022, the year considered in this report.

Cost indicators do not reflect external factors, other performance areas or the quality of service. Moreover, there are costs associated with providing a safer and more punctual, predictable, and efficient service, which can deliver savings to air operators flying in the airspace that offset higher ANSP costs.

Costs are broken down into ATCOs in OPS employment and other costs. Other costs include operating costs (excluding ATCO in OPS employment costs), depreciation/amortisation and costs of capital related to providing ATC/ATFM services. They do not include MET costs.

Productivity

The key indicator of ANS productivity is **IFR flight** hours per ATCO in OPS hour, often described as 'ATCO in OPS productivity'.

Although generally reflective of ANSPs' performance, factors beyond the control of the ANSP can cause low levels of productivity – for example a geopolitical event that alters traffic demand.

ATCO in OPS productivity is driven by traffic levels and an ANSP's ability to utilise its ATCOs in operations (OPS) resources. Although they cannot affect traffic demand, ANSPs may improve productivity by utilising flexible rostering and adapting airspace configuration to open and close sectors according to evolving traffic patterns.

Furthermore, advances in technology are now focusing more than ever on reducing the workload of ATCOs in OPS to enable them to safely manage higher levels of traffic in a given volume of airspace. Training associated with the introduction of technology, however, can lead to short-term reductions in productivity.

Airspace complexity also affects ATCO in OPS productivity. Lower airspace will typically have lower levels of ATCO in OPS productivity than upper airspace where aircraft are flying at more consistent altitudes and on non-crossing routes. Therefore, an ANSP operating a high proportion of sectors in lower airspace, or with numerous busy airports with complex approach sectors, is likely to have lower ATCO in OPS productivity than an ANSP with more overflights at higher altitude.

Data Processing

Data collection: ANSPs who are members of the CANSO GBWG provided data for this analysis. ANSPs either submit the minimum dataset required for participation in the report (the basic data), or additional data to inform the analysis of advanced KPIs (the advanced data).

ANSPs can also revise data submitted in previous years. The data submission workbook includes validation calculations that ANSPs are encouraged to consult in the data collection phase.

The entire dataset is available to all participating ANSPs to enable closer analysis and evaluation of performance trends. The advanced KPI dataset is only available to ANSPs submitting advanced data.

Data Processing (continued)

To extend the spectrum of provided ANSPs' performance data and ensure the validity of any trend analysis, EUROCONTROL has kindly provided 2022 performance data for European ANSPs, alongside data for the years 2018-2021 to facilitate historical trend analysis. European ANSP members of the CANSO GBWG who also submit data to EUROCONTROL have their CANSO data used in this analysis, unless otherwise agreed.

It should be noted that Indicator 2B 'ATCO productivity' is not directly comparable to the ATCO productivity KPI used in the ACE report. This is because the CANSO ANS Performance Framework uses IFR flight hours to calculate this KPI, rather than composite flight hours as used in the ACE report ATCO productivity KPI.

Finally, as part of the data sharing agreement with EUROCONTROL, CANSO data is only available to the core EUROCONTROL analysts and is not shared with the wider ACE report ANSP community.

Data Dashboard: As part of the CANSO 2018-2022 data collection cycle, a PowerBi dashboard was produced in November 2023, which allowed CANSO members a first look at trends in their data. This dashboard and accompanying underlying data document provided members the opportunity to thoroughly review and validate their data submission and notify Egis of any amendments if necessary.

The Data Dashboard additionally offers a more credible comparison of performance between participating ANSPs by dividing them into three comparator groups (CGs) based on the number of IFR hours managed, ensuring that the varying scales of their operations are taken into account.

Data processing: Data has been processed by Egis subject to a data processing agreement with CANSO and in accordance with European data privacy laws. It was subject to a one-step quality check for significant changes, potential errors or omissions and is subject to continued revision by participating ANSPs.

Separation of continental and oceanic data:

Information is provided both for continental and oceanic air navigation services, where applicable. Each of these environments has different challenges associated with providing ANS. For example, it is more straightforward to provide ground infrastructure for communications and surveillance services in continental airspace than it is over oceans.

Exchange rate conversion: ANSPs submit data in their chosen currency. For KPI comparison, data is presented in USD. 2022 KPI data is converted using exchange rates gathered from organisation World Bank.

For ANSPs that operate in a currency other than the USD, the assumption of lower cost may be caused in part by the strengthening USD. The change in the relative value of the dollar effectively lowers the price that ANSPs incur in USD.

Growth rates: Data is presented for 2022 and then for the one-year and four-year trends. The trend over four years is calculated as the compound annual growth rate (4 yr. CAGR). This shows the overall trend between 2018 and 2022 but masks the fluctuations that may have taken place over the intervening years. In addition, if 2018 was an outlier, this trend may not be representative of the trend over this timeframe. Individual ANSP results for 4 Year CAGR should therefore be interpreted alongside contextual information.

The trend analysis is presented above the 2022 KPI data and is based on the data submitted in the ANSP's chosen currency.

Inflation: The growth rates are not adjusted for inflation, and local inflation rates should therefore be considered when interpreting CAGR trends.

PPP correction: Salaries and the cost of living vary extensively around the world. One way to correct for this is by using purchasing power parity (PPP). Employment costs for ATCOs in OPS are corrected using World Bank data. There are, of course, limitations to this approach, as the cost of living can vary widely within a country and may be higher or lower in the region where ANS offices are located.

Median: The median is the middle number of the data set.

Q1 and Q3: The first quartile (Q1) is defined as the middle number between the smallest number and the median of the data set. The third quartile (Q3) is the middle value between the median and the highest value of the data set.

Annex 3: Key Performance Indicators

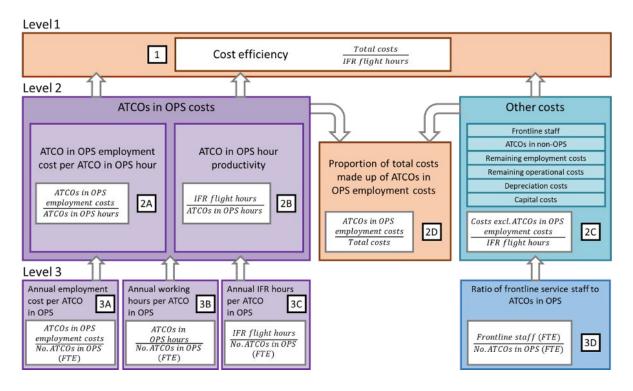


Figure 35 - CANSO ANS Performance Framework

The detailed metrics for determining the cost efficiency and productivity of continental and oceanic air navigation services are set out in Figure 35. These performance indicators are derived from the CANSO ANS Performance Framework.

Determining Performance Metrics

The CANSO ANS Performance Framework was established to create common performance indicators for global ANS data. Based on a tiered structure, the framework was developed in 2014 by the CANSO Global Benchmarking Workgroup (GBWG). It aims to demonstrate the drivers of cost efficiency.

Over the years, the GBWG has worked to identify alternative KPIs to investigate the drivers of the KPIs in the framework, in particular KPI 2C. In 2020, KPI 3D was added to the framework to better understand the proportion of 'frontline service support staff' to ATCO in OPS in an ANSP.

It is important to note the dependence of the higher tier metrics on the lower tier. This can be established as follows:

After the drop in traffic in 2020 caused by COVID-19, the recovery started in 2021, has accelerated during 2022. Because of this significant recovery the en route Capacity and Environment KPIs failed to meet the targets set in the Spanish Performance Plan. However, their values improve compared to 2019. ATFM Arrival Delay, achieves the goal set for RP3. It should be taken into account that during 2022, en route traffic had a recovery factor of +67 per cent compared to 2021 while the recovery factor for arrivals traffic was +60 per cent compared to this year.

On the other hand significant variations in traffic flows have been observed in 2022, but it is difficult to identify Russia's war against Ukraine as the main causal factor.
